

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 15 June 2019

TRACK: Heavy 8

(Rain affected track that horses will get into)

RAIL: Out 9 metres from 1200 metres to the Winning Post, out 6 metres remainder.

RACE 1: ACEIT COURIERS HANDICAP - 1100 metres

The start of this event was delayed approximately two minutes owing to an interstate delay (Gold Coast).

GOD'S PENNY (G. Lo) - when questioned in relation to the gelding's performance he explained that in his opinion the gelding may not have handled today's track conditions and it did not feel comfortable in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

KAYSERI (NZ) (P. Gatt) - inconvenienced on jumping away when tightened between MAGIC PHANTOM and SEAFOOD SOURCE and as a result lost its position. Held up for clear running for a short distance rounding the home turn.

OUR DEEP AGENDA (B. Vorster) - taken in on jumping away bumped MAGIC PHANTOM, which was taken in. Laid in under pressure in the straight.

SANTORINI SUMMER (J. Bowditch) - hung in under pressure in the straight. At the finish line shifted in and bumped MAGIC PHANTOM. A post-race veterinary examination revealed no visible abnormalities.



RACE 1: ACEIT COURIERS HANDICAP - 1100 metres (cont'd)

MAGIC PHANTOM (L. Riordan) - taken in on jumping away inconveniencing KAYSERI. Shortly after the start shifted in abruptly and away from OUR DEEP AGENDA, which rolled in, and was tightened onto KAYSERI, and as a consequence lost its position. Raced keenly in the early and middle stages of the event. In the vicinity of the 100 metres, when improving, was obliged to shift to the inside of SANTORINI SUMMER to obtain clear running. At the finish line rolled out and bumped SANTORINI SUMMER.

SHEZA LITTLE POSH (R. Hurdle) – jumped away awkwardly and contacted OUR DEEP AGENDA, which was taken in.

LASHDEE (K. Crowther) - raced keenly in the early and middle stages of the event.

SEAFOOD SOURCE (A. Darmanin) - held up for clear running rounding the home turn. Had difficulty obtaining clear ground from the entrance to the straight until in the vicinity of the 200 metres.

RACE 2: HEINEKEN 3 HANDICAP - 2500 metres

ZABALAN (IRE) (L. Riordan) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

LOSTARC (J. Bowditch) - when questioned in relation to the performance of LOSTARC rider reported the gelding appeared to race flat today. A post-race veterinary examination revealed no visible abnormalities.

FLOW METER (A. Darmanin) - had difficulty obtaining clear ground from rounding the home turn until approaching the 200 metres.

SHAKOPEE (GB) (D. Tourneur) - inclined to hang out throughout the event.

CASIRAGHI (J. Potter) - slow into stride and shortly after the start shifted in behind runners to obtain cover. Hung in from the vicinity of the 400 metres for the remainder of the event. Lost its near hind plate during the event.

RACE 3: HOLDFAST INSURANCE HANDICAP - 2035 metres

The start of this event was delayed approximately six minutes.

HUSSY'S GLOW (T. Hope) - raced wide without cover in the early stages of the event and got its head up on a number of occasions when being restrained in an attempt to gain cover. Rider explained that the mare is best ridden with cover and as she was unable to do so in today's event it was disappointing. A post-race veterinary examination revealed no visible abnormalities.

SUPER SWOOP (C. Jones) – lost its off fore plate en route to the barrier and required to be reshod on arrival at the barrier. Underwent a pre-race veterinary examination and was passed fit to start. Jumped away awkwardly, shifted out and contacted SLIPPERY JOURNEY.

LA LA LUCHIE (J. Holder) - slow into stride. Rider explained that the mare travelled well during the event; however, when asked for an effort only improved moderately and when asked to let down in the vicinity of the 200 metres failed to do so and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

SANIMA STAR (T. Pannell) - jumped away awkwardly. Hung out from in the vicinity of the 600 metres for the remained of the event.



RACE 3: HOLDFAST INSURANCE HANDICAP - 2035 metres (cont'd)

SLIPPERY JOURNEY (C. Lions) – contacted at the start, taken out and bumped DANOULI. When questioned in relation to the tactics adopted in today's event rider stated that her mount became fired up behind the barriers due to the delay and after beginning well found the lead comfortably. A post-race veterinary examination revealed no visible abnormalities.

DANOULI (A. Darmanin) - bumped on jumping away. Hung out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

FANTASTIC MAGIC (P. Gatt) - hung out under pressure in the straight.

RACE 4: COMMERCIAL FINANCE AUSTRALIA HANDICAP - 1050 metres

The start of this event was delayed approximately two minutes.

BURNING THE CLOCK (T. Pannell) - hung out under pressure in the straight.

SUNRISE DANCER (K. Crowther) - rider reported that the filly was disappointing in today's event. A post-race veterinary examination revealed no visible abnormalities.

PAPALET (P. Gatt) - fractious in the barriers. Underwent a pre-race veterinary examination and was ruled unfit to start. Acting on this advice Stewards withdrew PAPALET at 1.47 pm. Co-trainer, Mr R. Jolly, was advised that the gelding was required to perform to the Stewards' satisfaction in an Approval to Race Jump out prior to a future race start.

EXALTED MAXINE (J. Bowditch) - raced keenly in the early and middle stages of the event.

BAYOU (K. Lau) - jumped away very awkwardly and as a result its rider became unbalanced for a stride.

JAAMINT (J. Holder) - inclined to lay in under pressure in the straight.

LEGGERO (K. Cowan) - raced keenly in the early and middle stages of the event.

RACE 5: TABLE & CHAIR CO HANDICAP - 1600 metres

ICE GHOST (C. Jones) - hung in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

DI'S GREY (NZ) (T. Hope) – raced erratically in the early and middle stages and hung in throughout the event, and in the vicinity of the 1200 metres became awkwardly placed on the heels of ESPADEIRO for a number of strides. Inside the 700 metres continued to race erratically and when improving to the outside of ESPADEIRO rolled in, and as a consequence ESPADEIRO was obliged to be checked when tightened onto the heels of SERIOUS SPENDER.

NUDGE BAR (NZ) (A. Darmanin) - rider accidentally dropped his whip in the vicinity of the 300 metres.

ESPADEIRO (B. Vorster) - inside the 700 metres was obliged to be checked when tightened onto the heels of SERIOUS SPENDER when DI'S GREY (NZ) rolled in. Laid in under pressure in the straight.

RAPID BAY (D. Tourneur) - in the vicinity of the 400 metres bumped with SHE'S NEVER LATE, which rolled out. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

SERIOUS SPENDER (J. Holder) - slow into stride.



RACE 5: TABLE & CHAIR CO HANDICAP - 1600 metres (cont'd)

MINT TO BE (L. Riordan) - jumped away awkwardly.

SHE'S NEVER LATE (T. Pannell) - in the vicinity of the 400 metres rolled out and bumped with RAPID BAY. A post-race veterinary examination revealed no visible abnormalities.

COFFEE AMOUR (E. Boyd) - raced keenly in the middle stages of the event. Inside the 600 metres became awkwardly placed on the heels of CHASE THE THRILLS for a number of strides as that horse weakened.

CHASE THE THRILLS (J. Maund) - trainer, Mr J. Croucher, advised Stewards of a change of tactics prior to the event in that he would instruct his rider to be more forward in today's event. Weakened from in the vicinity of the 600 metres. Beaten 45 lengths. A post-race veterinary examination revealed no visible abnormalities. Mr Croucher was advised that a warning had been placed on the gelding for being uncompetitive.

RACE 6: RED, ROCK AND RIBS AT MORPHETTVILLE - BOOK NOW HANDICAP - 1600 metres

GIGGLON (T. Hope) – jumped away awkwardly, shifted in and contacted ROTHMOORE. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mrs S. Jaensch, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

MISS IDENTIFIED (J. Huxtable) - jumped away awkwardly.

AWAKE IN GRINZING (NZ) (A. Jordsjo) - rider reported that the gelding did not feel comfortable in its action over the concluding stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Ms K. Byrnes, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

GOING GAGA (S. Cahill) - hung in under pressure in the straight. Held up for clear running from the 500 metre until in the vicinity of the 300 metres.

RAINMOTH (K. Lau) - in the vicinity of the 1300 metres rolled in onto I'M BULLETPROOF, which was tightened onto AWAKE IN GRINZING (NZ). Rider advised to take greater care in future. In the vicinity of the 300 metres was accidentally struck on the head by the whip of A. Jordsjo. Rider reported that the mare may not have handled today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

ROTHMOORE (P. Gatt) - contacted on jumping away. In the vicinity of the 300 metres had difficulty obtaining clear ground for a short distance.

I'M BULLETPROOF (C. Lions) - jumped away awkwardly. In the vicinity of the 1300 metres was tightened between AWAKE IN GRINZING (NZ) and RAINMOTH, which shifted in. Raced keenly in the middle stages of the event.

DELLACQUA (K. Crowther) - difficult to load. Trainer, Mr D. Jolly, was advised that a warning had been placed on the mare. - hung in under pressure in the straight.

RACE 7: TAB HANDICAP - 1050 metres

READY SUNSHINE (J. Huxtable) - when questioned regarding the tactics adopted in today's event rider explained that his instructions were to settle towards the rear of the field; however, after beginning well and due to the early formation of the field and the early pace he found himself in the lead and felt it would have been detrimental to his mount to restrain to obtain cover at that point of the event.



RACE 7: TAB HANDICAP - 1050 metres (cont'd)

HE IS GOLDEN (S. Price) - raced keenly in the early and middle stages of the event.

MUM'S MY HERO (G. Lo) - jumped away awkwardly, shifted in and contacted NASIFA. Hung in under pressure in the straight.

THOMPSON'S REWARD (K. Crowther) - rider reported that the gelding was disappointing in today's event. A post-race veterinary examination revealed no visible abnormalities.

SWISS DESIGN (P. Gatt) - rider reported that the gelding did not feel comfortable in its action in today's event. A post-race veterinary examination revealed no visible abnormalities.

CALL ME ANYTHING (T. Hope) - jumped away awkwardly and shifted out. As a result T. Hope became unbalanced for a short distance.

BUCK'S ROW (L. Riordan) - failed to muster early speed.

I AM GRACIE (C. Jones) - when questioned regarding the tactics adopted in today's event rider explained that her instructions were to settle towards the rear of the field; however, after beginning well and due to the early formation of the field and the early pace she found herself in the lead and felt it would have been detrimental to her mount to restrain to obtain cover at that point of the event.

NASIFA (D. Tourneur) - contacted by MUM'S MY HERO on jumping away. Held up for clear running from approaching the 400 metres until in the vicinity of the 200 metres.

ANAMNESIS (K. Lau) – over-raced in the early and middle stages of the event. Held up for clear running from in the vicinity of the 500 metres until approaching the 100 metres. In the vicinity of the 200 metres, when attempting to improve to the outside of I AM GRACIE, was hampered as NASIFA improved quickly to its outside, and as a result ANAMNESIS was unable to improve its position.

RACE 8: AAMI HANDICAP - 1200 metres

BY THE POUND (S. Price) - jumped away awkwardly. Had difficulty obtaining clear running from the entrance to the straight until the finish when racing between SAVVY SHIELDS and ZARACE, which was weakening.

CHAROSSA (L. Riordan) - had difficulty obtaining clear ground in the vicinity of the 300 metres for a short distance. Was inclined to hang in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SKILLFUL STEPS (C. Jones) - shortly after the start shifted in behind runners to obtain cover.

OH MO (D. Tourneur) - slow to begin. Hung in under pressure in the straight. Approaching the 100 metres rider accidentally dropped his near side rein and did not use it for the remainder of the event.

ZARACE (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

CONCONI (C. Lions) - over-raced in the early and middle stages of the event and in the vicinity of the 900 metres became awkwardly placed on the heels of BY THE POUND and was obliged to be restrained.

BAJAN (K. Crowther) - raced keenly in the middle stages of the event and approaching the 800 metres got its head up when being restrained and was awkwardly placed between the heels of CONCONI and CHAROSSA. Held up for clear running from inside the 600 metres for the remainder of the event.



RACE 8: AAMI HANDICAP - 1200 metres (cont'd)

GALAXY GAZER (T. Pannell) - jumped away awkwardly.
