

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 29 June 2019

TRACK:Soft 5(Track with a reasonable amount of give in it)Downgraded to Soft 7 at 10.20 am(Rain affected track that will chop out)Downgraded to Heavy 8 at 12.44 pm (retrospective to Race 2)(Rain affected track that horses will get into)Downgraded to Heavy 9 at 3.55 pm (retrospective to Race 7)(Wet track getting into a squelchy area)

RAIL: True.

WEATHER: Intermittent rain / light hail

RACE 1: AAMI HANDICAP - 1250 metres

MAGIC PHANTOM (L. Riordan) – began awkwardly, shifted out inconveniencing MR CAUSEWAY, which was taken out onto the heels of HARD PRESS (NZ), which shifted in shortly after the start. Over-raced in the early stages of the event. Held up for clear running from near the 400 metres until shortly after the entrance to the straight. Inside the 200 metres was contacted and hampered when LASHDEE shifted in. Rider reported the gelding raced flat in today's event. A post-race veterinary examination revealed no visible abnormalities.

HARD PRESS (NZ) (R. Clark) - shifted in shortly after the start.

MR CAUSEWAY (T. Pannell) - inconvenienced at the start when taken out onto the heels of HARD PRESS (NZ), which shifted in, by MAGIC PHANTOM, which shifted out. Inclined to lay in, in the straight.

RACE 1: AAMI HANDICAP - 1250 metres (cont'd)

LASHDEE (J. Holder) – over-raced in the early stages of the event. Raced wide without cover from inside the 900 metres. Laid in, in the straight and inside the 200 metres shifted in and contacted MAGIC PHANTOM, resulting in that horse being hampered. A post-race veterinary examination revealed no visible abnormalities.

EMBROILED (K. Cowan) - slow to begin.

RACE 2: HUGHES LIMOUSINES HANDICAP - 1550 metres

Light hail fell prior to the running of this event.

UP 'N' ROLLING (NZ) (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

AAGAS (T. Pannell) - held up for a short distance approaching the 400 metres. Inclined to lay out in the straight.

CHAPEL CITY (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

DEBT COLLECTOR (J. Toeroek) – over-raced in the early stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: SCHWEPPES HANDICAP - 1400 metres

BEERZ WITH CLINT (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

ICE GHOST (D. Tourneur) – a post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer, Mr G. Richards, was advised that a Veterinary Certificate of Fitness was advised prior to a future trial or race.

LEFT HAND MAN (R. Hurdle) - contacted at the start. Raced wide without cover in the early stages of the event.

HELMAZ (J. Huxtable) - held up for clear running from near the 500 metres to the 400 metres. Shifted out at the entrance to the straight.

CALYPSO STORM (P. Gatt) - began awkwardly, shifted in and contacted LEFT HAND MAN. Taken wider at the entrance to the straight by HELMAZ, which shifted out to improve.

CROWN HARMONIUM (S. Fawke) – fractious prior to being loaded. Underwent a pre-race veterinary examination and was passed fit to start. Trainer, Mr J. Hickmott, was advised that a warning had been placed on the filly in relation to its barrier manners.

RACE 4: HEINEKEN 3 HANDICAP - 2400 metres

SASKO (C. MacFarlane) - slow to begin.



RACE 5: EVRIGHT.COM THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately two minutes owing to CRY OUT LOUD proving difficult and refusing to proceed to the barriers.

NEED THE YEN (T. Pannell) - laid out from in the vicinity of the 500 metres.

CRY OUT LOUD (A. Jordsjo) – refused to proceed to the barriers and after several attempts was declared a late scratching by order of Stewards at 2.22 pm. Trainer, Mr T. Jolly, was advised that the filly was now required to complete an Official Barrier Trial to the Stewards' satisfaction prior to a future race start.

DREAM FACTOR (S. Fawke) – a post-race veterinary examination revealed no visible abnormalities.

PAM'S JOURNEY (L. Doodt) – dislodged its rider en route to the barriers and galloped some distance before being recaptured. Underwent a pre-race veterinary examination and was passed fit to start. L. Doodt was examined by the First Care Medical personnel and passed fit to fulfil her remaining engagements. A post-race veterinary examination revealed no visible abnormalities.

QUEEN'S SONG (J. Holder) – following a submission by stable representative, Mr T. Stokes representing trainer, Mr P. Stokes, for the filly to be a late scratching owing to the track downgrade Stewards acceded to his request and declared the horse a late scratching at 10.22 am.

WANAASA (J. Eaton) – trainer, Mr R. Balfour, failed to product the Thoroughbred Identification Card. The horse was allowed to start as it was able to be identified from records held by the Stewards, which was subsequently cross-referenced with a photo of the TIC.

RACE 6: TAB HANDICAP - 1000 metres

CASHED (L. Riordan) - shifted in over the concluding stages. Rider dropped his whip at the winning post.

COUNTER PULSE (R. Clark) – inclined to lay out in the straight. Rider reported that the gelding resented the cross-over noseband in running.

BAROOD (P. Gatt) - slow to begin.

TOLSTOY (J. Huxtable) - inconvenienced over the concluding stages by CASHED, which shifted in.

CREATIVITY (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

NIPPERKIN (K. Bishop) – underwent a pre-race veterinary examination as it had not raced since September 2018 and was passed fit to start.

LIFE'S REWARD (G. Cartwright) - underwent a pre-race veterinary examination as it had not raced since May 2018 and was passed fit to start.

RACE 7: TERRY HOWE PRINTING HANDICAP - 1550 metres

ROSELLI STING (J. Toeroek) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

GOING GAGA (J. Eaton) - over-raced in the early and middle stages of the event.



RACE 7: TERRY HOWE PRINTING HANDICAP - 1550 metres (cont'd)

TAHNEE TIARA (L. Doodt) – following a submission by trainer, Mr P. Hardacre, for the mare to be a late scratching owing to the track downgrade Stewards acceded to his request and declared the horse a late scratching at 12.53 pm.

CANFORD (T. Pannell) - raced wide without cover in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

STAR PATRIOT (J. Huxtable) - approaching the 700 metres dipped in the underfoot conditions.

PICTURE ME ROLLING (D. Tourneur) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

SKILLFUL STEPS (C. Jones) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

ROTHMOORE (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: TEYS AUSTRALIA HANDICAP - 1400 metres

DIAMONDS ARE (K. Cowan) - stood flat-footed and was slow to begin losing many lengths at the start. A post-race veterinary examination revealed no visible abnormalities.

PALE ALE (E. Boyd) - raced keenly in the early stages of the event.

BORRIS IN OSSORY (R. Clark) – following a submission by trainer, Mr G. Young, for the gelding to be a late scratching owing to the track downgrade Stewards acceded to his request and declared the horse a late scratching at 12.49 pm.

GALAXY GAZER (G. Cartwright) – held up for clear running from the 500 metres until near the 400 metres. A post-race veterinary examination revealed no visible abnormalities.

SCOUT'S HONOUR (D. Tourneur) - raced wide without cover throughout the event.

SOMETHING SILVER (J. Holder) – following a submission by trainer, Mr C. McDonald, for the mare to be a late scratching owing to the track downgrade Stewards acceded to his request and declared the horse a late scratching at 1.19 pm.

GENERAL:

Prior to the running of Race 6 Apprentice C. MacFarlane approached Stewards requesting a release from her remaining engagements on personal grounds. Stewards acceded to her request and advised that before riding again she would require Stewards permission.
