# RACE 1: CLARE VALLEY RACE CLUB / SABOIS FILLIES AND MARES MAIDEN PLATE - 1100 metres

**OH GEORGIA** (D. McWhinney) - slow into stride. A post-race veterinary examination revealed no visible abnormalities.

**REJIGED** (K. Lau) - proved difficult to proceed to the start. Trainer Mr M. Moosha was advised a warning had been placed on the mare.

**VEGAS SUNRISE** (J. Chau) - rider explained the mare never travelled and did not finish as well as expected. A post-race veterinary examination revealed no visible abnormalities.

WITH PLEASURE (A. Jordsjo) - raced greenly in the straight.

**HEART LIKE MINE** (S. Fawke) - raced keenly in the early and middle stages of the event.

## RACE 2: AIRMASTER AUSTRALIA / SABOIS DISTANCE MAIDEN PLATE - 1800 metres

**STOPPETT** (S. Fawke) - bumped on jumping away. A post-race veterinary examination revealed no visible abnormalities.

## RACE 2: AIRMASTER AUSTRALIA / SABOIS DISTANCE MAIDEN PLATE - 1800 metres (Cont'd)

PETROVSKI (R. Hurdle) - jumped away awkwardly and shifted out bumping STOPPETT.

ANOTHER WHISPER (S. Logan) - jumped away awkwardly and as a result was slow to begin. Approaching the 600 metres improved onto the heels of RASHYATHERE, elected to switch to that gelding's outside in an attempt to improve. Rider explained after jumping away awkwardly, she elected to settle mid-field with cover where the mare was comfortable. Rider added approaching the 600 metres, the mare became awkwardly placed on the heels of RASHYATHERE, she elected to shift out to allow the mare to start to improve into the race. She further added ANOTHER WHISPER was one paced from the 600 metres and was disappointing to the finish.

MISS DONCH (J. Potter) - jumped away awkwardly shifted out tightening the running of SMARTFUL.

**SMARTFUL** (C. Lions) - lost its position on jumping away when tightened between ANOTHER WHISPER by MISS DONCH which shifted out.

#### RACE 3: JIM BARRY WINES BENCHMARK 64 HANDICAP - 1100 metres

KING'S SPIRIT (J. Potter) - laid in the straight. Inside the 100 metre was disappointed for a run between RUSTYDUSTYSUNSHINE, which shifted out and away from COMMANDING DIVA and ANAMNESIS, which rolled in marginally and was obliged to shift in to obtain clear ground. Rider explained it was always the intention to settle back, as is its normal racing pattern. The gelding travelled well throughout, however when placed under pressure in the straight was unable to improve to the outside of RUSTYDUSTYSUNSHINE, and inside the 100 metres, became disappointing for a run between RUSTYDUSTYSUNSHINE and ANAMNESIS and he was obliged to alter course to the inside to attempt to improve.

**COMMANDING DIVA** (D. Tourneur) - inside the 100 metres shifted out and away from TRIPLE DEEZ, which had improved to the mare's inside and inconvenienced RUSTYDUSTYSUNSHINE. Rider reminded of his obligations and to straighten his mounts sooner when they commence to shift ground.

**RUSTYDUSTYSUNSHINE** (J. Chau) - inside the 100 metres inconvenienced and obliged to shift out and away from COMMANDING DIVA tightening the running of KING'S SPIRIT.

**ANAMNESIS** (K. Lau) - laid out from the 700 metres until the 400 metres. Inside the 100 meters rolled in marginally.

#### RACE 4: TAMINGA HOTEL CLARE VALLEY CUP - 1800 metres

**SET TO CRUISE** (D. Tourneur) - rider explained the instructions were to be patient behind the speed and to make a run to the outside of runners. He stated the mare travelled well throughout and inside the 800 metres started to roll forward. He further added when SET TO CRUISE was placed under pressure inside the 600 metres, he was of the opinion that the mare was travelling comfortably however, inside the 200 metres, he felt the mare's run had come to an end and was disappointing to the finish.

## RACE 5: TAB / SABOIS MAIDEN PLATE - 1200 metres

CHASE THE THRILLS (D. Tourneur) - laid in, in the straight.

**PERUVIAN EXPRESS** (S. Fawke) - underwent a pre-race veterinary examination as it had not raced in 12 months and passed fit to race. Jumped away slowly.

**CHARADE** (J. Chau) - raced keenly in the middle stages of the event. Held up from the 300 metres for clear running between GOODARCHIE and THE MASTER and was untested to the line.

## RACE 5: TAB / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)

**KRUPTONITE** (S. Logan) - a late scracthing at 4.36 pm by order of Stewards as the filly had become fractious in the barrier and became cast. Stable was advised KRUPTONITE would be required to prove tractable in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 6: TAYLORS WINES BENCHMARK 56 HANDICAP - 1800 metres

**ELEVENBEE (NZ)** (P. Gatt) - in the vicinity of the 800 metres shifted out and inconvenienced TEMPERS FLARE. Rider reprimanded and advised to only shift ground when entitled to do so. A post-race veterinary examination revealed no visible abnormalities.

**BARRYMORE** (R. Hurdle) - became held up between the 400 metres and the entrance to the straight.

MINT TO BE (E. Annells) - jumped away awkwardly and shifted out tightening the running of NORTHSET. In the vicinity of the 1600 metres rolled out and bumped BALTIC PRINCE. Laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

ANTIPAS (J. Potter) - inconvenienced on jumping away by PARIS ON FIRE, which shifted out.

**AUGUSTA ROCK** (G. Lo) - laid in, in the straight. In the vicinity of the 150 metres was obliged to take hold to avoid the heels of PARIS ON FIRE, which shifted out.

**PARIS ON FIRE** (L. Neindorf) - on jumping away shifted out and inconvenienced ANTIPAS. Laid out in the straight. In the vicinity of the 150 metres shifted out and inconvenienced AUGUSTA ROCK. Rider reprimanded.

**NORTHSET** (J. Chau) - jumped away awkwardly. Shortly after the start was tightened between MINT TO BE, which shifted out and TATTIES and lost its position. Raced keenly in the early and middle stages of the event. Held up from inside the 400 metres until the entrance to the straight.

**BALTIC PRINCE** (C. Lions) - raced fiercely in the early stages of the event. In the vicinity of the 1600 metres shifted in and bumped MINT TO BE.

TATTIES (D. Tourneur) - held up for clear running from the 400 metres until the 150 metres.

**TEMPERS FLARE** (S. Logan) - in the vicinity of the 800 metres was inconvenienced by ELEVENBEE (NZ), which shifted out.

Correct weight was delayed to allow R. Hurdle (BARRYMORE) placed third, to view the vision in the straight.

#### RACE 7: MAGIC FM/5CS BENCHMARK 54 HANDICAP - 1200 metres

The start of this event was delayed approximately four minutes.

**FAY'S JOY** (L. Neindorf) - jumped away awkwardly and as a result was slow to begin. Disappointed for clear running in the vicinity of the 300 metres for a short distance.

**SARAH'S JULE** (J. Chau) - raced keenly in the early stages of the event. Laid out under pressure in the straight. Approaching the 50 metres shifted out into the running of SAGANO. Rider was severely reprimanded and advised to make a greater effort to straighten his mounts when they shift ground in future. A post-race veterinary examination revealed no visible abnormalities.

**SASSY MANEUVER** (S. Cahill) - a late scratching at 4.16 pm by order of Stewards due to the track upgrade.

## RACE 7: MAGIC FM/5CS BENCHMARK 54 HANDICAP - 1200 metres (Cont'd)

**SAGANO** (A. Jordsjo) - underwent a pre-race veterinary examination as it had not raced in 12 months and passed fit to race. Approaching the 50 metres was obliged to take hold to avoid the heels of SARAH'S JULE, which shifted out.

PARADISE COVE (USA) (D. Tourneur) - inside the 300 metres became disappointed when attempting a run to the inside of SWANKYTOFF, which rolled in marginally and was obliged to ease.
