

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT Report on Race Meeting held at Port Lincoln Racecourse by the Port Lincoln Racing Club on Sunday, 22 December 2019

TRACK: Good 4

RAIL: Out 3 metre 900 metres to 500 metres, 4 metres 500 metres to winning post, 2 metres remainder.

RACE 1: JOHN MARMION / SABOIS MAIDEN PLATE - 1210 metres

FULL TILT (K. Bishop) - jumped away awkwardly and was slow into stride. Raced greenly in the straight.

BLACK DIAMONDS (K. Lau) - fractious in the mounting enclosure and dislodged K. Lau on a number of occasions. K. Lau was examined by the first care personnel and was ruled unfit to fulfil this engagement. Acting on this advice the mare was declared a late scratching at 12.45pm. Trainer, M. Moosha, was advised the mare is now required to complete an Official Barrier Trial to the satisfaction of Stewards prior to accepting for a future race. A veterinary examination revealed no visible abnormalities.

IMBOSSIBLE (E. Boyd) - hung out rounding the home turn.

JETTA JAE (T. Voorham) – jumped away awkwardly, shifting out onto SHARVANOS. Momentarily hampered in the vicinity of 850m by SHARVANOS, who had shifted in.

LADANES (S. Logan) – raced keenly in the early stages. Rider was required to take hold in the vicinity of 850m when awkwardly placed on the heels of SHARVANOS, who had shifted in.

PLACID RED (C. Lions) - raced keenly in the early stages of the event.

SHARVANOS (J. Chau) – raced keenly in the early stages of the event. In the vicinity of the 850m shifted in onto JETTA JAE, who was momentarily hampered.



RACE 2: BK & BJ SOUTHHAM TV & LINE INSTALLATION/ SABOIS THREE-YEAR-OLD BENCHMARK 60 HANDICAP - 1210 metres

Prior to this event apprentice K. Lau was assessed by First Care Medical officers and deemed fit to fulfil his remaining engagements.

WOTUWANT (T. Pannell) - laid in under pressure in the straight.

BLUE GRANITE (G. Lo) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Hung out throughout the event.

THE FOUR CEES (K. Bishop) – underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Slow into stride.

MANOR KING (J. Potter) - raced keenly in the middle stages.

TIME GENTLEMAN (J. Chau) - laid out in the home straight.

DERR PHONZ (C. Lions) – raced wide and laid out throughout the event. A post race veterinary examination revealed the gelding to be lame in the near fore leg. Trainer, Mr T. Jolly, was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

GRAND BARBA (E. Boyd) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Raced keenly in the early and middle stages of the event.

RACE 3: AVIS PORT LINCOLN CLASS TWO HANDICAP - 1390 metres

SWING IT SISTER (B. Sweeney) – began awkwardly. In the vicinity of 1000m was obliged to race tightly between FEARLESS AL to the outside and TUNGKETTA to the inside. Raced in tight room over the final 30m of the event between FEARLESS AL, which was inclined to lay in, and PALI DE LYS.

FEARLESS AL (S. Logan) – taken wider when entering the home straight by BUNDLE O'DIAMONDS, which shifted out, prior to shifting to the inside of that runner. Shortly after was obliged to race in tight room until the vicinity of 150m between BUNDLE O'DIAMONDS, who commenced to lay in, and SWING IT SISTER. Inclined to lay in for the remainder of the straight.

PALI DE LYS (C. Lions) - raced keenly in the middle stages of the event. Approaching the 400m raced in tight room between BUNDLE O'DIAMONDS to the outside and HE'S ABEL to the inside.

TUNGKETTA (T. Pannell) - raced keenly in the early stages of the event. A post race veterinary examination revealed no visible abnormalities.

HE'S ABEL (L. Neindorf) – approaching the 400m when racing in tight room was momentarily inconvenienced by PALI DE LYS to the outside.

BUNDLE O' DIAMONDS (J. Chau) – hung out rounding the home turn. Laid in, in the early stages of the home straight.



RACE 4: SOUTHERN CROSS AUSTEREO MAIDEN / CLASS ONE PLATE THREE-YEAR-OLD & UP -1750 metres

AUGUSTER RUSH (M. Collett) - rider dislodged on arrival at the barriers. Rider passed fit by First Care Medical to fulfil her riding engagement.

DESERT MINTY (K. Crowther) – laid in in the straight.

NORTHSET (T. Pannell) – in the vicinity of 100m shifted out when insufficiently clear of ARTFULABEERS, who was forced to take a hold and lose its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he allowed his mount to shift out when insufficiently clear and was suspended for riding in races from midnight Saturday 28th December and to conclude at midnight Wednesday 1st January 2020: a period of three meetings.

BARB WIRE (R. Hurdle) - began awkwardly, shifting in. Hung in throughout the event.

LILAC WINE (K. Bishop) - laid out in the straight.

ARTFULABEERS (J. Toeroek) – inconvenienced in the vicinity of 100m by NORTHSET, which had shifted out.

OUR RHYTHM (J. Chau) - over raced in the middle stages of the event.

RACE 5: EYRE TRAVEL BENCHMARK 80 HANDICAP - 1750 metres

SAVANERO (T. Voorham) - reared on jumping away. In the vicinity of 150m shifted to the outside of EMOJI which was laying in.

REIGNING IN PARIS (J. Chau) – when racing out of the home straight in the vicinity of 1450m shifted in onto EMOJI which was momentarily hampered. Rider was severely reprimanded and advised to only shift ground when entitled to do so.

EMOJI (L. Neindorf) - Momentarily hampered in the vicinity of 1450m by REIGNING IN PARIS which shifted in.

BANRI DE HERO (S. Fawke) - slow to begin.

KEEP DIGGING (K. Bishop) - rider reported the gelding raced keenly in the early stages of the event.

RACE 6: DEL GIORNOS CAFÉ RESTAURANT BENCHMARK 72 HANDICAP - 1390 metres

GALAXY FALLS (T. Pannell) - inclined to lay in, in the straight.

STRYKER FORTUNE (K. Crowther) – raced wide without cover throughout the event. A post race veterinary examination revealed no visible abnormalities.



RACE 7: VETS ON EYRE BENCHMARK 60 HANDICAP - 1210 metres

APOLLO HOPE (R. Hurdle) - laid in, in the straight.

TYCOON FLUTTER (T. Voorham) – underwent a pre-race veterinary examination and passed fit to start. Slow to begin.

MAIDEN GRACE (C. Lions) – raced keenly in the early and middle stages. Hung out in the vicinity of the 800m whilst racing out of the back straight. A post race veterinary examination revealed no visible abnormalities.

RACE 8: MCMERRY CHRISTMAS BENCHMARK 64 HANDICAP - 1000 metres

HEAVENS FLIGHT (B. Sweeney) – underwent a pre-race veterinary examination as the gelding had not started in over twelve months and passed fit to start. Inconvenienced shortly after the start by KIROSHIMA, which was taken out by SOCIAL MEDIA. A post race veterinary examination revealed no visible abnormalities.

MY LESSON (T. Voorham) - over raced in the early stages of the event.

LA PETITE ROUSSE (K. Bishop) - began awkwardly.

SOCIAL MEDIA (G. Lo) - jumped away awkwardly shifting out onto KIROSHIMA.

KIROSHIMA (S. Fawke) - hampered on jumping away when tightened between SOCIAL MEDIA, which shifted out, and HEAVENS FLIGHT.

ARTISTIC ESCAPE (C. Lions) - inclined to lay in under pressure.
