### RACE 1: MOPHETTVILLE EQUINE CLINIC / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately two minutes owing to KOODA TROOPER (NZ) dislodging its rider en route to the barriers.

**KOODA TROOPER (NZ)** (L. Neindorf) - dislodged rider en route to the barriers. As the gelding galloped riderless for a considerable distance Stewards declared KOODA TROOPER (NZ) a late scratching at 12.45pm. Trainer Ms J. Stoetzer was advised a warning had been placed on the gelding in relation to its pre-race behavior. L. Neindorf was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements.

HAYZELLE (E. Boyd) - slow to begin. Rider reported the filly raced greenly throughout the event.

**LADY VENUS (NZ)** (S. Fawke) - slow to begin. In the vicinity of the 800 metres when racing keenly, was eased from the heels of DOUBLE DAZZLER. A post-race veterinary examination revealed no visible abnormalities.

**STRIP CLUB** (C. Lions) - laid in, in the straight.

ZEBLAN (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

## RACE 2: MITAVITE - LEADERS IN EQUINE NUTRITION BENCHMARK 80 HANDICAP - 1750 metres

**LADY CONQUISTADOR** (S. Logan) - inconvenienced and taken wider in the vicinity of the 1450 metres when ABBI FEDE, who was over racing, shifted out. Laid out under pressure in the straight.

**ABBI FEDE** (S. Fawke) - over-raced in the early stages and shifted out in the vicinity of the 1450 metres taking LADY CONQUISTADOR wider. Laid out under pressure in the straight.

# RACE 2: MITAVITE - LEADERS IN EQUINE NUTRITION BENCHMARK 80 HANDICAP - 1750 metres (Cont'd)

**DANCE OF HEROES (GB)** (E. Boyd) - laid out from in the vicinity of the 400 metres until the entrance to the straight. Rider reported the gelding became unbalanced rounding the home turn.

## RACE 3: SCALLYWAGS TOYS & NURSERY SABOIS MAIDEN PLATE - 1210 metres

**BARB WIRE** (R. Hurdle) - rider reported the gelding was disappointing in the run to the finish. Rider was reminded of his obligations to ride his mounts out to the finish. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr D. Carrison was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**TAJAVEDO** (T. Pannell) - raced keenly in the early stages of the event. Laid in under pressure in the straight.

GRAND BARBA (E. Boyd) - raced keenly in the early and middle stages of the event.

**PRINCE ZACHERY** (K. Bishop) - slow to begin.

**ANASTASIA SKILL** (G. Lo) - hampered on jumping away by LOVE ME HARDER, which shifted out.

**LOVE ME HARDER** (B. Sweeney) - jumped away awkwardly and shifted out hampering ANASTASIA SKILL.

SHARVANOS (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

## RACE 4: KEMP REAL ESTATE BENCHMARK 62 HANDICAP - 1390 metres

**MIRTHDALE** (T. Pannell) – raced keenly in the early stages of the event. Rider had to momentarily take hold in the vicinity of the 1100 metres when CALL ME HERBIE shifted in.

**STONECAST** (K. Bishop) - slow to begin.

SEE ME ROLLIN' (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

**CALL ME HERBIE** (A. Jordsjo) – in the vicinity of the 1100 meters shifted in onto MIRTHDALE which was inconvenienced. Rider was reminded of her obligations when shifting ground.

**FEARLESS AL** (J. Chau) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

## RACE 5: WSA CHARTERED ACCOUNTANTS BENCHMARK 54 HANDICAP - 1000 metres

KIROSHIMA (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

**BLUE GRANITE** (R. Hurdle) - jumped awkwardly and shifted in onto DOWNS AFTER DARK, hampering that runner.

**DOWNS AFTER DARK** (A. Jordsjo) - hampered when jumping away by BLUE GRANITE, which shifted in. Held up for clear running from the vicinity of the 400 metres until the entrance of the straight.

**METEOR'S MAN** (E. Boyd) - raced wide without cover throughout the event. Laid out under pressure in the straight.

## RACE 5: WSA CHARTERED ACCOUNTANTS BENCHMARK 54 HANDICAP - 1000 metres (Cont'd)

MAIDEN GRACE (C. Lions) - hung out in the straight.

**WINE DANCE** (T. Voorham) - tightened and lost its position shortly after jumping away between CELEBRAKTI to the inside and DOWNS AFTER DARK to the outside, which was taken in by BLUE GRANITE.

## RACE 6: SCWEPPES LEMONADE BENCHMARK 54 HANDICAP - 1750 metres

The start of this event was delayed approximately two minutes owing to QUEENS PALACE dislodging its rider at the barriers.

**SAVANERO (NZ)** (M. Collett) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. First aid administered. Trainer, Ms J. Branford, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**CRAZY CULPRIT** (B. Sweeney) - laid in under pressure in the straight. Rider reminded of his obligations when his mounts commence to shift ground.

**DESERT MINTY** (A. Jordsjo) - in the vicinity of the 1000 metres was inconvenienced when THE FOUR CEES shifted out.

**SAINT VALENTINE** (E. Boyd) - jumped away awkwardly and shifted out.

**THE FOUR CEES** (J. Potter) - in the vicinity of the 1000 metres shifted out abruptly for no apparent reason.

**HE'S ABEL** (L. Neindorf) – rider was obliged to steady his mount over the concluding stages when racing in restricted room on the rail inside CRAZY CULPRIT, which was laying in.

**QUEEN'S PALACE** (S. Logan) - dislodged rider behind the barriers. Underwent a pre-race veterinary examination and passed fit to start. Rider S. Logan was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

**ARTFULABEERS** (T. Voorham) - laid in, in the straight.

#### RACE 7: AVIS PORT LINCOLN BENCHMARK 62 HANDICAP - 1210 metres

KINGSON (A. Jordsjo) - laid in, in the straight.

**IRISH MAMBO** (R. Hurdle) - hung out rounding the home turn.

**MONTRE** (S. Logan) - shifted in on jumping away. In the vicinity of the 1000 metres had to be steadied when MR TRUMAN shifted in.

**MR TRUMAN** (J. Chau) - shifted in onto MONTRE in the vicinity of the 1000 metres. Rider was severely reprimanded. Taken wider rounding the home turn by CHOUX BACQUAT to its inside, which was taken wider by IRISH MAMBO. Inclined to lay in, in the straight.

**HOW JAMMY'S THAT** (T. Voorham) - tightened on jumping away between CHOUX BACQUAT, which shifted out and MONTRE, which shifted in.

**CHOUX BACQUAT (NZ)** (K. Bishop) - jumped away awkwardly and shifted out. Raced keenly in the early stages of the event. Taken wider rounding the home turn by IRISH MAMBO, which hung out.

## RACE 8: HYGAIN - FEEDING CHAMPIONS CLASS TWO HANDICAP - 1210 metres

**DOCTOR DOOLITTLE** (R. Hurdle) - raced wide without cover throughout the event. Hung out rounding the home turn. Laid in under pressure in the straight.

**CHINESIS** (J. Chau) - hung out rounding the home turn. Inclined to shift about in the early part of the straight. Rider dropped his whip in the vicinity of the 200 metres. Rider reprimanded under AR131(b) for failing to ride his mount out to the finish.

AVORA SUN (S. Fawke) - jumped awkwardly shifting in onto CHINESIS.

**SPENCER GULF** (T. Pannell) - hung in, in the straight.

**GEANDGE** (L. Neindorf) - inside the 200 metres shifted to the outside of runners to obtain clear running.

**SERIOUS MOONLIGHT** (E. Boyd) - hampered on jumping away by CHINESIS to the outside, which was taken in by AVORA SUN.

**BUNDLE O' DIAMONDS** (K. Bishop) - raced keenly in the early stages of the event. Laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**STAR MOVER** (S. Williams) – Declared a late scratching by order of stewards at 8.37am. due to veterinary reasons.
