Due to the weather conditions, Stewards enacted Level 2 of the TRSA Hot Weather Policy and in addition, altered the race times to commence the meeting earlier, as follows:

RACE 1: AUSBIA ELECTRICAL CLASS ONE HANDICAP - 1200 metres

HEROES QUEST (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

Following the running of this race rider L. Neindorf was examined by the First Care Medical Personnel and ruled unfit to fulfil his remaining engagements.

RACE 2: TERRACE FUNCTION CENTRE / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1200 metres

The start of this event was delayed approximately three minutes.

MR RANGER (G. Lo) - raced wide without cover throughout the event.

RADIO ROOM (J. Potter) - jumped away awkwardly.

COPPERFIELDS (P. Gatt) - laid in over the concluding 600 metres of the event. A post-race veterinary examination revealed no visible abnormalities.



RACE 2: TERRACE FUNCTION CENTRE / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1200 metres (Cont'd)

IKNOW WHERE YOULIV (J. Toeroek) - laid out under pressure over the concluding 400 metres.

NEW ROMAN (J. Holder) - contacted on jumping away. Inclined to lay in under pressure over the concluding 200 metres.

TOSCA ROCKS (K. Bishop) - became fractious in its barrier after being loaded. Underwent a prerace veterinary examination and passed fit to race. Jumped away awkwardly and shifted out contacting NEW ROMAN. Raced keenly in the early and middle stages of the event. Trainer, Mr G. Searle was advised a warning had been placed on the gelding in relation to its barrier manners.

RACE 3: COOPERS RATING 0-62 HANDICAP - 2106 metres

WHITE HEATH (G. Lo) - laid in under pressure in the straight.

LOOKING AROUND (NZ) (T. Pannell) - slow to begin.

SHAKOPEE (GB) (J. Holder) - rider reported that he had become concerned with the gelding's action over the concluding stages. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

DR DAPPER (K. Bishop) - raced keenly in the early and middle stages of the event.

RACE 4: SANDERS FODDER / SABOIS FILLIES & MARES MAIDEN PLATE - 1200 metres

BUT BEAUTIFUL (D. Tourneur) - became awkward in its action and shifted out abruptly in the vicinity of the 200 metres.

NIKE BELLE (T. Voorham) - jumped away awkwardly.

NUKIN (J. Potter) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

TINNY BAR BLUE (K. Bishop) - laid out under pressure in the straight.

ZEPHYR GROVE (J. Toeroek) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: HOLDFAST INSURANCE BENCHMARK 54 HANDICAP - 1506 metres

HAHNDORF (T. Pannell) - laid in, in the middle stage of the event.

GROOVE WITH ME (D. Tourneur) - laid in, in the middle stage of the event.

OUR FREEBIE (T. Voorham) - raced keenly in the early and middle stages of the event.

THRONES (G. Lo) - Stewards questioned Trainer Mr S. Adams in relation to his saddling and presentation of this horse to race. After considering his explanation, he was reprimanded and advised that more severe action would be taken if he was to present a horse for a race saddled in a manner that he had on this occasion.



RACE 6: CORNERSTONE STUD RATING 0-58 HANDICAP - 1706 metres

CITY BEATS (E. Annells) - raced keenly in the early and middle stages of the event.

GUEST LIST (J. Holder) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

SUCCEEDANDCONQUER (S. Logan) - Trainer advised that he would instruct the rider to attempt to settle further back in this event if possible.

RACE 7: WILLIAMSTOWN HOTEL RATING 0-56 HANDICAP - 1100 metres

SPECTATE (T. Voorham) - jumped away awkwardly and shifted out onto AVALON DOWNS.

AVALON DOWNS (J. Potter) - hampered on jumping away when tightened between SPECTATE and MISS ELEGANCE. A post-race veterinary examination revealed no visible abnormalities.

MISS ELEGANCE (J. Toeroek) - jumped away awkwardly and shifted in onto AVALON DOWNS. Laid in under pressure in the straight.

TOFFEE BELL (K. Bishop) - raced wide without cover throughout the event.

MAIDEN GRACE (K. Lau) - laid out rounding the home turn. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

PARTY SET (S. Fawke) - laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100.

GENERAL:

Trainer Mr S. Adams was questioned in relation to him failing to record any medication or treatment that had been administered to his horse, when Stewards visited for a routine stable inspection on race morning. He pleaded guilty to a charge under AR104(1) and was fined \$200.
