RACE 1: FOURIER TECHNOLOGIES / SABOIS TWO-YEAR-OLD HANDICAP - 1210 metres

RIGHT TURN (K. Crowther) - slow to begin. Raced greenly in the early and middle stages of the event.

BRAZEN HEAD (K. Bishop) - slow to begin.

CONGE (J. Chau) - inclined to hang in from the 400 metres until the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

HAYZELLE (J. Toeroek) - raced keenly in the early and middle stages of the event.

RACE 2: EYRE PENINSULA 765, 5CC RADIO / SABOIS MAIDEN HANDICAP - 1000 metres

BEERS ON BILL (K. Crowther) - slow to begin. Raced greenly throughout the event and was inclined to lay in. Tailed the field throughout the event. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr B. Cozamanis was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race.

COPPERFIELDS (J. Potter) - Trainer Mr R. Dawson was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

LADY HUNTSMEN (K. Bishop) - Trainer Mr T. Haddy was reprimanded under AR65(i) for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards. performed below expectations. A post-race veterinary examination revealed no visible abnormalities.



RACE 3: MEMBER FOR FLINDERS, PETER TRELOAR / SABOIS MAIDEN PLATE - 1390 metres

OUR JOURNEYMAN (S. Logan) - held up for clear running from the 400 metres until the 100 metres.

ANASTASIA SKILL (G. Lo) - slow to begin.

OUR RHYTHM (J. Chau) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 4: EMPSEY'S SADDLERY & FEED SUPPLIES BENCHMARK 62 HANDICAP - 1390 metres

ONWARD (B. Sweeney) - in the vicinity of the 100 metres had to take hold and lose its position when LEONARDA shifted in and away from FEARLESS, which was shifting in.

ABBI FEDE (J. Potter) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

DOCTOR DOOLITTLE (J. Toeroek) - brushed on jumping away when LEONARDA jumped away awkwardly and shifted out.

FEARLESS AL (J. Chau) - in the vicinity of the 100 metres shifted in when insufficiently clear of LEONARDA, which was taken in onto ONWARD, which had to be steadied and lost its position. Rider was found to be guilty of a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 23 February and to conclude at midnight on Sunday, 1 March 2020: a period of three meetings.

LEONARDA (L. Neindorf) - jumped away awkwardly and shifted out brushing DOCTOR DOOLITTLE. In the vicinity of the 100 metres was taken in by ONWARD, which shifted in when insufficiently clear and as a result ONWARD, which was to the inside had to take hold and lose its position.

RACE 5: RAISE A GLASS TO WES FLYING HANDICAP - 1000 metres

GO THE JOURNEY (M. Collett) - inconvenienced at the start when TINTAGEL ROCKER jumped away awkwardly and shifted out and KINGSON jumped away awkwardly and shifted in.

ARTFUL RAMBLER (L. Neindorf) - a post-race veterinary examination revealed the mare to have lacerations to the posterior proximal cannon on the near hind leg. Trainer, MR R. King, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. First aid administered.

RUBY'S REWARD (K. Bishop) - rider explained that approaching the finish line her mount felt awkward in its action and elected to not ride out to the finish. A post-race veterinary examination revealed no visible abnormalities. Trainer Ms J. Branford was advised if anything that becomes apparent in the next few days in regards to an issue that may have affected the gelding's performance, to advise Stewards at her earliest convenience.

KNOTTED (C. Lions) - inconvenienced at the start when TINTAGEL ROCKER jumped away awkwardly and shifted out and KINGSON jumped away awkwardly and shifted in.

TINTAGEL ROCKER (J. Chau) - jumped away awkwardly and shifted out inconveniencing GO THE JOURNEY and KNOTTED.

KINGSON (K. Crowther) - jumped away awkwardly and shifted in inconveniencing GO THE JOURNEY and KNOTTED.



RACE 6: THOMAS FOODS INTERNATIONAL 2020 PORT LINCOLN CUP PRELUDE - 1750 metres

The start of this event was delayed approximately 10 minutes.

DEXTER YOU DEVIL (S. Cahill) - in the vicinity of the 400 metres shifted out when insufficiently clear of WITCH KID, which had to be steadied and lost its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 23 February and to conclude at midnight on Sunday 1 March 2020: a period of three meetings.

BRAMFIELD (T. Pannell) - jumped away awkwardly and shifted out. Raced keenly in the early and middle stages of the event.

IT'S HUMPHREY (M. Collett) - on arrival at the barriers reared dislodging its rider. Underwent a pre-race veterinary examination and ruled unfit to race. A late scratching by order of Stewards at 4.10 pm on veterinary advice. M. Collett was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements.

LADY CONQUISTADOR (S. Logan) - jumped away awkwardly. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

DANCE OF HEROES (GB) (G. Lo) - on arrival at the barriers had to be reshod. Underwent a prerace veterinary examination and ruled unfit to race. A late scratching by order Stewards at 4.16 pm on veterinary advice.

EMOJI (S. Fawke) - rider accidentally dropped his whip at the entrance to the straight.

I'M BULLETPROOF (J. Potter) - raced keenly in the early and middle stages of the event.

WITCH KID (C. Lions) - knuckled on jumping away and as a result was slow into stride. In the vicinity of the 400 metres had to be steadied and lost its position when DEXTER YOU DEVIL shifted out when insufficiently clear.

RACE 7: MEN IN BLACK SALUTE OUR VOLUNTEERS BENCHMARK 58 HANDICAP - 1000 metres

The start of this event was delayed approximately three minutes.

ANGEL'S WISH (J. Chau) - held up for clear running from the vicinity of the 100 metres until the winning post.

SHANE (J. Potter) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ARTFUL MONTY - underwent a pre-race veterinary examination on arrival at the barriers and ruled unfit to race. A late scratching by order of Stewards at 4.50 pm on veterinary advice.

AVORA SUN (E. Boyd) - raced keenly in the early and middle stages of the event.

LOVES EDGE (T. Voorham) - jumped away awkwardly and was slow into stride. A post-race veterinary examination revealed no visible abnormalities.
