RACE 1: HIT107 HANDICAP - 2006 metres

JAGUARY (NZ) (D. Dunn) - rider could offer no explanation to the poor performance of the gelding. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr T. Doudle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

FAROOQ (R. Hurdle) - raced keenly in the early and middle stages of the event. Inclined to lay out under pressure in the straight.

WAR TIGER (USA) (D. Lane) - raced keenly in the early and middle stages of the event. Rider explained it was not his intention to lead in the event, however after being keen in the early stages, he allowed the gelding to roll forward to obtain the lead to have WAR TIGER (USA) settle.

RACE 2: MAGIC MILLIONS ADELAIDE 2YO CLASSIC - 1200 metres

GLENFIDDICH (B. Prebble) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

AMISH BOY (J. McNeil) - jumped away awkwardly.

SEA WITNESS (D. Holland) - shifted in on jumping away onto BRIBERY. Raced keenly in the early and middle stages of the event.

BRIBERY (D. Lane) - inconvenienced on jumping away when tightened between KIRINIA, which shifted out and SEA WITNESS, which shifted in. In the vicinity of the 250 metres was disappointed when attempting a run between AMISH BOY and SEA WITNESS, which shifted out and away from GLENFIDDICH, and was obliged to alter course to obtain clear ground.

RACE 2: MAGIC MILLIONS ADELAIDE 2YO CLASSIC - 1200 metres (Cont'd)

ZEBLAN (J. Kah) - rider explained the filly travelled well in the early and middle stages however, when placed under pressure, had failed to respond to her riding. She added, in her opinion, ZEBLAN felt shin sore. A post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer, Mr W. Clarken, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

KIRINIA (J. Toeroek) - shifted out on jumping away onto BRIBERY. Rider explained the filly travelled well in the early and middle stages of the event, however when placed under pressure had failed to respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

ROCABELLA (T. Pannell) - momentarily held up in the vicinity of the 300 metres when attempting a run between GLENFIDDICH, which laid in at the same time as KIRINIA commenced to give ground. Inclined to lay in under pressure in the straight.

RACE 3: AAMI HANDICAP - 1200 metres

SANSOM (NZ) (T. Stockdale) - raced wide without cover throughout the event.

HINT OF MINT (J. Kah) - laid in under pressure in the straight.

LA RICHESSE (T. Pannell) - Stewards permitted T. Pannell to ride the filly 0.5 kg over its declared weight of 54 kg. Rider explained the filly travelled well in the early and middle stages of the event, however had failed to let down when asked for an effort. A post-race veterinary examination revealed no visible abnormalities.

CLEARY ADONIS (G. Cartwright) - raced keenly in the early and middle stages of the event.

GOLDEN SNITCH (L. Neindorf) - Stewards granted permission for L. Neindorf to only claim 1.5kg in this event. Rider explained the filly was reluctant to race early and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

PARTY HACK (J. Potter) - inclined to lay out over the concluding 500 metres.

RACE 4: WINNING EDGE PRESENTATIONS HANDICAP - 1200 metres

WANTED BY ALL (D. Caboche) - jumped away awkwardly.

ONE MORE JACK (J. Potter) - taken out on jumping away onto EXALTED RUTH. Raced keenly in the early and middle stages of the event. Rider was reprimanded under AR232(b) for disobeying a Stewards direction in relation to making celebratory after passing the winning post.

EXALTED RUTH (J. Holder) - contacted on jumping away. Rider reported the mare did not stretch out when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

KENYAN WONDER (D. Dunn) - raced keenly in the early and middle stages of the event.

WOULDA THOUGHT SO (D. Tourneur) - jumped away awkwardly and shifted out onto ONE MORE JACK. Raced keenly in the early and middle stages of the event. Held up from the vicinity of the 400 metres until inside the 200 metres.

RACE 5: FURPHY HANDICAP - 1600 metres

DIAMONDS ARE (J. Holder) - rider could offer no explanation in relation to the disappointing performance of the gelding. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: FURPHY HANDICAP - 1600 metres (Cont'd)

FRANCE'S BOY (K. Crowther) - raced keenly in the early stages of the event. Rider explained it was not her intention to lead the event, however the gelding had jumped away extremely well, raced fiercely early and took itself to the front.

LOPE DE WOLF (G. Cartwright) - slow to begin.

RACE 6: SCHWEPPES C S HAYES MEMORIAL CUP - 1600 metres

CHAROSSA (J. Holder) - laid in under pressure in the straight.

OVER EXPOSURE (J. Kah) - at the entrance to the straight, the gelding improved, despite the efforts of its rider, into a tight run between the heels of WETAKEMANHATTAN and REGALO DI GAETANO, which shifted out slightly, resulting in J. Kah having to take hold and alter course. In the vicinity of the 200 metres shifted in and brushed KARDASHING.

REGALO DI GAETANO (L. Neindrof) - at the entrance to the straight shifted out onto OVER EXPOSURE, which had improved into a tight run, resulting in J. Kah having to take hold. Rider severely reprimanded. Lost its near hind plate during the event. Rider reported the gelding raced flat. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Co-Trainer, Mr R. Jolly, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

WETAKEMANHATTAN (D. Bates) - rider could offer no explanation in relation to the gelding's disappointing performance. A post-race veterinary examination revealed no visible abnormalities.

KARDASHING (J. Mc Neil) - rider reported the mare was never comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

GOLDIFOX (D. Dunn) - lost its off fore plate during the event.

RACE 7: TAB ADELAIDE CUP - 3200 metres

All runners underwent a veterinary examination on arrival on course.

HOME BY MIDNIGHT (NZ) (W. Egan) - contacted on jumping away. Rider reported the gelding was disappointing in today's event. A post-race veterinary examination revealed no visible abnormalities.

YOGI (NZ) (J. Allen) - underwent a pre-race veterinary examination which revealed the gelding was lame in the off foreleg and was unfit to race. Stewards declared YOGI (NZ) a late scratching at 2.34 pm on veterinary advice.

DABIYR (IRE) (J. McNeil) - rider reported the gelding did not run out the 3200 metres. A postrace veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr C. Waller, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

NAVAL WARFARE (IRE) (D. Dunn) - in the vicinity of the 2600 metres, attempted to savage YULONG RISING (IRE). Rider explained he would have preferred to be another pair forward in the run and in his opinion; the gelding was not suited by the tempo of the race. A post-race veterinary examination revealed no visible abnormalities.

ROCK ON (NZ) (A. Darmanin) - slow to begin. In the vicinity of the 1400 metres, rider improved around the field to take up a more forward position.

RACE 7: TAB ADELAIDE CUP - 3200 metres (Cont'd)

YULONG RISING (IRE) (D. Holland) - jumped away awkwardly and shifted in onto KNIGHT STAR (IRE). Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

GOOD IDEA (B. Thompson) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

ALIENATED (G. Cartwright) - a post-race veterinary examination revealed tying up in both shoulders. First aid administered. Trainer Mr C. Murray was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

KNIGHT STAR (IRE) (J. Holder) - hampered on jumping away when tightened onto HOME BY MIDNIGHT (NZ) by YULONG RISING (IRE).

RACE 8: TERRY HOWE PRINTING MATRICE STAKES - 1200 metres

HARD EMPIRE (J. Toeroek) - hampered on jumping away when contacted by FLEET REVIEW (USA).

FLEET REVIEW (USA) (D. Lane) - jumped away awkwardly and shifted out contacting HARD EMPIRE.

FREE OF DEBT (J. McNeil) - jumped away awkwardly. Raced wide without cover throughout the event. In the vicinity of the 500 metres was taken out onto QUEEN ANNABEL by FLEET REVIEW (USA). Rider reported the colt felt uncomfortable in its action in the straight. A post-race veterinary examination revealed FREE OF DEBT to be lame in the near hind leg. Trainer, Mr C. Bieg, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

AMBERDI (P. Gatt) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

QUEEN ANNABEL (J. Kah) - raced wide without cover throughout the event. Inconvenienced in the vicinity of the 500 metres when FREE OF DEBT was taken out slightly into its running line. Laid out under pressure in the straight. Rider reported the mare raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

BEAUTIFUL FLYER (J. Potter) - laid in under pressure in the straight.

CAZABILLIE (T. Pannell) - Stewards permitted T. Pannell to ride the mare 0.5 kg over its declared weight of 54kg. Jumped away awkwardly. Rider reported the mare felt uncomfortable in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: G.H. MUMM HANDICAP - 1050 metres

SHAMINO (K. Crowther) - jumped away awkwardly. Disappointed in the vicinity of the 300 metres when attempting to improve into a tight run between SCHILLDORA and MAGNA BELLA and was obliged to alter course to the inside of SCHILLDORA. Approaching the 100 metres was again disappointed when attempting a tight run between the heels of SCHILLDORA and LI'L KONTRA, which shifted out under riding, resulting in SHAMINO having to alter course to that filly's inside to obtain clear ground.

LI'L KONTRA (L. Neindorf) - laid out under pressure over the concluding 400 metres. In the vicinity of the 100 metres shifted out under riding onto SHAMINO, which was obliged to alter course. Rider reprimanded and advised in future he would be required to make a greater effort to keep his mounts straight, rather than allow them to shift out under pressure.

TIARA STAR (T. Pannell) - raced keenly in the early and middle stages of the event.
