

# THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 11 April 2020

# RACE 1: M&J CHICKENS HANDICAP - 1250 Metres

The start of this event was delayed approximately three minutes.

GRANDSLAM (T. Pannell) - shifted out at the start and contacted ENAAYA. Laid out in the straight.

KORUTO (K. Crowther) - raced keenly in the early stages of the event. Inclined to lay out under pressure over the concluding stages. Lost its near hind plate during the event.

DISS 'N' DAT (T. Voorham) - shortly after the start shifted in and away from ICHIBANSAN and became awkward on the heels of ENAAYA for a number of strides.

**DISTILLATE** (L. Neindorf) - lost its off fore plate during the event.

**ENAAYA** (J. Toeroek) - shifted in at the start and contacted GRANDSLAM. Raced keenly in the early stages of the event. Shifted in over the concluding stages and had its hindquarters contacted by ICHIBANSAN as that horse was tightened to its inside.

ICHIBANSAN (J. Holder) - raced greenly and was inclined to lay in, in the early part of the straight. Approaching the 100 metres, when attempting to improve into a run between ENAAYA, which rolled in slightly and KORUTO, which was inclined to lay out and shifted out, was obliged to be checked when tightened between these two runners and contacted the hindquarters of ENAAYA and as a consequence was unable to be ridden out to the finish over the concluding stages.

**STAR OF UMA** (B. Vorster) - proved very difficult to load. Awkward to begin. Raced wide without cover from near the 1000 metres and raced greenly throughout the event. Laid in, in the straight.



# RACE 1: M&J CHICKENS HANDICAP - 1250 Metres (Cont'd)

SHEBRINGZIT (R. Hurdle) - commenced to buck for some distance shortly after the start resulting in R. Hurdle being unable to maintain his position and losing contact with the field. As a consequence, this horse took no competitive part in the event. Trainer Mr M. Huxtable was advised the filly would be required to perform to the Stewards satisfaction in an Approval to Race Jump Out prior to accepting for a future race. Trainer also advised a warning had been placed on the filly in relation to its barrier manners. A post-race veterinary examination revealed the filly had a wheal behind its right shoulder.

Correct weight was delayed to allow Stewards to view the vision over the concluding stages.

#### RACE 2: TAB COUNTRY CUP - 1950 Metres

**BRAMFIELD** (L. Neindorf) - raced keenly for a short distance approaching the 1000 metres and thereafter from near the 900 metres raced wide without cover until approaching the 500 metres where it was disappointed for clear running for a short distance when racing to the inside of TOMMY GUN and thereafter laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**STANLEY** (S. Fawke) - over-raced in the early and middle stages of the event. Rider reported the gelding was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

SHINSEKI (J. Toeroek) - rider reported his mount laid in over the concluding stages.

**SUPERVELOCE (NZ)** (C. Lions) - rider reported her mount laid out near the entrance to the straight. Laid out under pressure over the concluding stages.

**COBBERS MATE** (D. Tourneur) - laid in, in the straight. Rider reported the gelding commenced to hang in from near the 600 metres when placed under pressure.

**TOMMY GUN** (D. Caboche) - raced wide without cover from near the 900 metres.

### **RACE 3: SCHWEPPES HANDICAP - 1400 Metres**

HYPERCANE (C. Jones) - awkward to begin, shifted out and contacted BLUDOG.

WESTPORT (B. Vorster) - slow to begin. Over-raced in the early stages of the event. Thereafter raced wide without cover for some distance. Shifted out under pressure from near the 100 metres and near the 50 metres tightened BLUDOG, which had improved to its outside, onto INTRIGUE, resulting in BLUDOG contacting the hindquarters of INTRIGUE and losing its position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 18 April and to conclude at midnight on Saturday, 25 April 2020: a period of three meetings. A post-race veterinary examination revealed no visible abnormalities.

**BLUDOG** (P. Gatt) - approaching the 100 metres when continuing to improve into a run between INTRIGUE and WESTPORT was tightened onto INTRIGUE by WESTPORT near the 50 metres as WESTPORT shifted out under pressure. As a consequence contacted the hindquarters of INTRIGUE, was obliged to be steadied and lost its position.

**INTRIGUE** (J. Holder) - awkward to begin, shifted in and contacted WICKED SCANDAL, had its hindquarters turned near the 50 metres when contacted. A post-race veterinary examination revealed no visible abnormalities.

**WICKED SCANDAL** (K. Crowther) - contacted at the start. Held up for a short distance near the entrance to the straight.



#### RACE 4: FLEURIEU MILK COMPANY HANDICAP - 1250 Metres

**BY THE POUND** - a late scratching at 1.53 pm by order of Stewards as the gelding failed to load. Trainer Ms K. Mooney was advised BY THE POUND would have to load to the Stewards satisfaction, and without delay at an Approval to Race Jump Out prior to accepting for a future race.

**ARCHWAY TO HEAVEN** - a late scratching at 1.50 pm by order of Stewards acting on veterinary advice that the gelding was found to be lame in its near foreleg, after arrival at the barriers. Trainer Mr S. Whittle was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future Approval to Race Jump-Out, trial or race.

**GOUGERS** (C. Jones) - a late scratching at 1. 25 pm by order of Stewards acting on veterinary advice that the gelding was found to be suffering colic after arrival on course. First aid was administered.

PALE ALE (E. Boyd) - very awkward to begin.

**HE WILL BOOM** (E. Finnegan) - tightened at the start between TWO ODD SOX, which shifted in and JACOBITE PRINCE, which shifted out. Unable to obtain clear running for a short distance near the entrance to the straight.

LACE AND WHISKEY (T. Pannell) - Stable representative Mr L. Weekly, acting on behalf of Trainer Mr W. Clarken advised Stewards prior to the event of a change in tactics being, that he would advise his rider to attempt to take up a forward position if the filly jumped on terms. Began well but shortly thereafter commenced to buck. As a consequence, rider became unbalanced and was dislodged inside the 1200 metres. T. Pannell was examined by the First Care Medical Personnel and transported to hospital for further assessment and observation. Trainer Mr W. Clarken was advised the filly would be required to perform to the Stewards satisfaction in an Approval to Race Jump Out prior to accepting for a future race.

### RACE 5: AAMI HANDICAP - 1550 Metres

The start of this event was delayed approximately two minutes owing to T. Pannell having to be attended to by the First Care Medical Personnel after Race 4.

**HUSSYBAY** (L. Neindorf) - awkward to begin. A post-race veterinary examination revealed no visible abnormalities.

EASY BEAST (NZ) (B. Vorster) - inclined to lay out in the straight.

NASEEB (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

LIEDER (S. Cahill) - laid in, in the straight.

**NIPPERKIN** (J. Holder) - shortly after the start raced in restricted room for a number of strides when racing to the outside of BORRIS IN OSSORY. Shortly after the entrance to the straight was obliged to shift in to obtain clear running.

**ROSELLI STING** (J. Toeroek) - inside the 200 metres was obliged to shift to the outside of NASEEB to obtain clear running.

# **RACE 6: FURPHY STAKES - 1000 Metres**

The start of this event was delayed approximately one minute.

BOLD STAR (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

**TAVISAN (NZ)** (J. Holder) - shifted out shortly after the start onto ARROW LANE inconveniencing that horse. Laid out in the straight.



# RACE 6: FURPHY STAKES - 1000 Metres (Cont'd)

**BEAUTY** (B. Vorster) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**ARROW LANE** (S. Fawke) - inconvenienced at the start by TAVISAN (NZ), which shifted out on jumping away.

**RIZSKI** (P. Gatt) - inside the 400 metres when improving its position, got onto the heels of EQUAL LOVE clipped that horses heels and stumbled.

### RACE 7: WINNING EDGE PRESENTATIONS HANDICAP - 1400 Metres

**LITTLE AKIE** (K. Crowther) - underwent a pre-race veterinary examination as the gelding is a 12 year old and was passed fit to race.

CASINO FOURTEEN (B. Vorster) - raced wide without cover throughout the event.

KINGSGROVE (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

YIN AND YANG (D. Tourneur) - raced keenly in the early stages of the event.

# **RACE 8: TERRY HOWE PRINTING HANDICAP - 1000 Metres**

STAR OF MONSOON (J. Holder) - rolled in slightly over the concluding stages.

**TINTAGEL ROCKER** - a late scratching at 4.30 pm by order of Stewards acting on veterinary advice that the gelding was lame in the near foreleg. Trainer Mr J. Dunn was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future Approval to Race Jump Out, trial or race.

MISS LABELLE (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

WHITE KAPS (D. Caboche) - awkward to begin. Raced wide without cover and over-raced in the early stages of the event. Laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

**NOTHING NEEDED** (B. Vorster) - awkwardly placed inside the heels of STAR OF MONSOON over the concluding stages as that horse rolled in slightly and as a consequence had to be steadied and was unable to be ridden out fully to the finish.

**EXALTED LAURETTA** (R. Hurdle) - underwent a pre-race veterinary examination and was passed fit to race.

GOODGEE (T. Voorham) - resaddled on arrival at the barriers.

#### RACE 9: CHALK HILL HANDICAP - 1400 Metres

**SWEET MISCHIEF** (L. Neindorf) - rider explained when improving his position near the 600 metres, his horse did not respond in the manner he expected and he was taken wider into the straight by runners to his inside. He added thereafter, the mare was inclined to lay in, in the straight and was disappointing to the finish.

**SET TO CRUISE** (R. Hurdle) - awkward to begin, shifted out and tightened GOOD GIRL BELLA shortly after the start.



#### RACE 9: CHALK HILL HANDICAP - 1400 Metres

LADY BETHANY (NZ) (E. Boyd) - Trainer Mr M. Hickmott advised Stewards prior to the event of a change in tactics, being that he would instruct his rider to settle back with cover if possible. Shifted in at the start and contacted POYSED TO REIN. Inside the 1100 metres when awkwardly placed inside the heels of POYSED TO REIN, which rolled in, got its head up and raced ungenerously for several strides. Thereafter near the 300 metres had to be momentarily steadied when racing inside POYSED TO REIN as that horse shifted in to improve its position. A post-race veterinary examination revealed no visible abnormalities.

**FLEETING FEELING** (B. Panicucci) - lost its near hind plate during the event. Co-Trainer Mr C. McEvoy advised Stewards prior to the event of a change of tactics, being that he would instruct his rider to be positive early and attempt to obtain a forward position in running. A post-race veterinary examination revealed no visible abnormalities.

MABEL JOSEPHINE (S. Logan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**POYSED TO REIN** (P. Gatt) - shifted out and contacted LADY BETHANY (NZ) at the start. Near the 1100 metres rolled in slightly and inconvenienced LADY BETHANY (NZ). Thereafter near the 300 metres shifted in to improve its position and momentarily inconvenienced LADY BETHANY (NZ), which was obliged to be steadied. Rider reprimanded and advised to take greater care when shifting ground.

**SACRED WALK (NZ)** (J. Holder) - rider reported the mare was under pressure from near the 600 metres and failed to respond to his riding in the manner expected. A post-race veterinary examination revealed no visible abnormalities.

GOOD GIRL BELLA (D. Tourneur) - lost its near hind plate during the event.
