#### RACE : 1 BRYAN (POPEYE) & LORRAINE HARBRIDGE MEMORIAL BENCHMARK 62 HANDICAP - 1867 Metres

**SPIEGEL GROVE** (S. Fawke) - slow to begin. Rider reported the gelding travelled well until inside the 600 metres and then failed to respond to his riding for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities. Trainer D. Magro undertook to monitor the geldings recovery and advise any abnormalities.

TOMMY GUN (E. Boyd) - hung out rounding the home turn.

TAKE IT UP A GIA (J. Potter) - hung out rounding the home turn. Inclined to lay in, in the straight.

# RACE 2: JB RADIATORS & WINDSCREEN SERVICE / SABOIS 2UP MAIDEN PLATE - 1100 Metres

**COMMANDING DRAGON** (M. Collett) - brushed the inside running rail in the vicinity of the 200 metres and became unbalanced for several strides.

**COLD GOLD** (K. Zechner) - inclined to lay in, in the straight.

**GOOD TIME MADAM** (E. Boyd) - in the vicinity of the 400 metres was disappointed for a run between COMMANDING DRAGON and GREAT WHITE HOPE, which shifted in momentarily.

**GREAT WHITE HOPE** (A. Lindsay) - in the vicinity of 400 metres shifted in momentarily inconveniencing GOOD TIME MADAM. Inclined to lay out in the straight.

**HIGHLANDER FLYER** (J. Potter) - rider reported the gelding raced greenly in the event. A postrace veterinary examination revealed the gelding to have bi-lateral shin soreness. Trainer, Mr A. Jarvis, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**IMA LUCKY STAR** (C. Lions) - knuckled shortly after the start.

AMBER HAZE (S. So) - laid in, in the straight.

## RACE 3: MILHINCH HOURGLASS JEWELLERS / SABOIS MAIDEN PLATE - 1396 Metres

**CLANGER** (S. So) - rider reported the gelding raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MY MATE SONNY (S. Fawke) - raced keenly in the early and middle stages of the event.

**OURKEED** (A. Lindsay) - jumped away awkwardly and shifted out. In the vicinity of the 200 metres shifted to the outside of ANOTHER WHISPER to obtain clear running.

COOGEE DANCER (J. Opperman) - laid in, in the straight.

KATE'S VALLEY (E. Boyd) - inclined to lay in, in the straight.

SMARTFUL (C. Lions) - raced keenly in the early and middle stages of the event.

## RACE 4: TERRY GARDINERS MEATS & SMALLGOODS BENCHMARK 62 HANDICAP - 1100 Metres

**KING'S SPIRIT** (C. Lions) - rider reported the gelding hung out throughout the event.

CALL ME ANYTHING (S. Fawke) - inclined to lay in, in the straight.

**DOUG'S JOURNEY** (K. Bishop) - laid in, in the straight.

**MY LESSON** (A. Lindsay) - laid in throughout the event. Rider stated her mount had one month between runs and after having to work the gelding in the early stages from the outside barrier, left its condition vulnerable over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

LOFTY TYCOON (M. Collett) - laid in, in the straight.

SHINING MANE (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

ALWAYS BE TRUE (S. So) - slow into stride as the start was affected.

MISS FORBIDDEN (J. Opperman) - inclined to lay in, in the straight.

## RACE 5: PORT PIRIE BUS SERVICE BENCHMARK 62 HANDICAP - 1396 Metres

**WHITE JADE** (J. Opperman) - tightened shortly after the start between REAL EASY and NO PAROLE, losing its position. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using the whip more than five occasions prior to the 100 metres and was reprimanded.

OLIVE GROVE (S. Fawke) - laid out under pressure over the concluding stages.

STRINGER BELL (C. Lions) - laid out in the straight.

**GOOD NIC** (J. Potter) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr M. Seyers was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

REAL EASY (M. Collett) - jumped away awkwardly and shifted out. Laid in, in the straight.

AUGUSTA ROCK (K. Bishop) - difficulty obtaining clear running over the concluding stages.

#### RACE 6: CENTRAL AUGUSTA FOOTBALL & COMMUNITY SPORTING CLUB BENCHMARK 54 HANDICAP - 1200 Metres

**LUCERNEFIELD** (C. Lions) - hung out in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**KNAVESMIRE** (J. Potter) - taken wider on the track in the vicinity of the 800 metres by LUCERNEFIELD, which hung out.

**BIT SPENSIVE** (S. Fawke) - underwent a pre-race veterinary examination as it had not raced for approximately 12 months and passed fit to race. In the vicinity of the 1100 metres shifted in brushing HABANERO.

**HABANERO** (K. Bishop) - in the vicinity of the 1100 metres was brushed by BIT SPENSIVE and as a result raced keenly.

## RACE 7: SOUTHERN CROSS AUSTEREO SPENCER GULF BENCHMARK 54 HANDICAP 1600 Metres

**NORTHSET** (K. Bishop) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**UNCLE KENNETH (NZ)** (A. Lindsay) - jumped away awkwardly and shifted in. Laid in, in the straight.

IT'S CHIEF (D. McWhinney) - began awkwardly and as a result was slow to begin.
