

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 27 June 2020

RACE 1: FURPHY HANDICAP - 1550 Metres

The start of this event was delayed approximately two minutes.

FRANCE'S BOY (A. Jordsjo) - raced keenly in the early stages of the event.

ROSELLI STING (S. Cahill) - raced keenly in the early stages of the event. Inclined to lay in, in the straight.

CROCKETT (B. Vorster) - became fractious after being loaded into its barrier stall, got its off hind leg up into its barrier stall. Underwent a pre-race veterinary examination and was passed fit to race. Over-raced in the early stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. Co-Trainer Mr C. McEvoy was advised a warning had been placed on the gelding in relation to its barrier manners.

ELUSIVE NATURE (J. Holder) - raced keenly in the early stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. Laid out from inside the 600 metres. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Trainer Mr W. Clarken was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 2: TAB HANDICAP - 1000 Metres

DIVINE JOURNEY (P. Gatt) - awkward to begin, shifted in and contacted WHO RUNS THE WORLD, which was taken in as a consequence onto MRS MOURINHO, resulting in WHO RUNS THE WORLD making contact with and taking MRS MOURINHO inwards. A post-race veterinary examination revealed no visible abnormalities.



RACE 2: TAB HANDICAP - 1000 Metres (Cont'd)

SHOWUSYOURMOTOR (J. Potter) - laid out from in the vicinity of the 600 metres.

THREE TEARS (J. Toeroek) - raced wide without cover throughout the event. Raced greenly when rounding the home turn.

WHO RUNS THE WORLD (B. Vorster) - contacted and taken in at the start and as a consequence was inconvenienced when taken in onto MRS MOURINHO. A post-race veterinary examination revealed no visible abnormalities.

OPHELIA BLUES (D. Caboche) - was very fractious in its barrier stall and when the gates were released, dropped its head and as a consequence was slow to begin, losing approximately two lengths. Trainer Mr B. Campbell was advised a warning had been placed on the filly in respect of its barrier manners. Rider reported it was his intention to settle on pace in this event, however owing to the manner in which the horse began, he was unable to take up this position. A post-race veterinary examination revealed no visible abnormalities.

MRS MOURINHO (K. Crowther) - contacted and inconvenienced at the start by WHO RUNS THE WORLD, which was taken in. Laid out from near the 200 metres. A post-race veterinary examination revealed an abrasion to the outside of its off hind hock.

Correct weight was delayed to allow Stewards and the Starter to view the vision of the start in relation to OPHELIA BLUES and to consider a submission from this filly's rider, D. Caboche, in respect of declaring the filly a non-runner on the basis that it was denied a fair start owing to the barrier attendant having hold of the horse's head as the gates were released. After considering the submission, the evidence of the starter, on viewing the official footage and acting on their own observations, Stewards determined that while the barrier attendant did have hold of this horse's head when the gates were released, this action was unavoidable as the filly had been under starter's orders before becoming fractious and dropping its head as the gates were released. In the circumstances Stewards determined that the filly's predicament was as a result of its own barrier manners and consequently declared it a runner.

RACE 3: SCHWEPPES HANDICAP - 1400 Metres

ROYALTY (B. Vorster) - raced keenly in the early and middle stages of the event. Shifted out slightly approaching the 1300 metres onto STARDEN LASS.

STARDEN LASS (T. Pannell) - approaching the 1300 metres was hampered when racing between TUBBY TWO TRACKS and ROYALTY, which both shifted ground slightly. Inclined to lay out in the straight. A post-race veterinary examination revealed no visible abnormalities.

TUBBY TWO TRACKS (P. Gatt) - contacted at the start. Approaching the 1300 metres shifted in slightly onto STARDEN LASS.

ANGASTON (K. Zechner) - very awkward to begin, shifted out and contacted TUBBY TWO TRACKS.

HONORABLE SPIRIT (J. Toeroek) - rider reported the gelding raced keenly and was inclined to lay out in the straight.

SHARPLY ATTIRED (K. Bishop) - very awkward to begin, shifted in and contacted TUBBY TWO TRACKS. Inclined to lay out in the straight. A post-race veterinary examination revealed no visible abnormalities.



RACE 4: FLEURIEU MILK COMPANY HANDICAP - 1550 Metres

ROTHMOORE (J. Holder) - awkward to begin, shifted in and contacted THRONES. Held up for clear running from near the 400 metres when racing behind DESIDERO and to the inside of CLASSY JOE and was unable to obtain clear running until near the 200 metres where it was obliged to shift to the outside of CLASSY JOE.

CALL ME SHAMUS (P. Gatt) - awkward to begin. Inclined to lay out over the concluding stages.

DESIDERO (S. Logan) - contacted at the start. Laid out under pressure over the concluding stages. **CLASSY JOE** (J. Maund) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

CRYPTO CURRENCY (K. Crowther) - laid out from approaching the entrance to the straight.

BIG CALL (E. Boyd) - awkward to begin. Raced keenly in the early stages of the event. Raced wide without cover throughout the event. Rider reported the mare was inclined to hang out during the event, did not race in a tractable manner and was disappointing in its performance and for that reason; she did not ride the mare out in her normal manner in the straight. A post-race veterinary examination revealed no visible abnormalities.

THRONES (D. Caboche) - contacted at the start. Laid out for a short distance rounding the home turn.

RACE 5: GRANT BURGE HANDICAP -1300 Metres

COFFEE AMOUR (A. Jordsjo) - slow to begin. Inclined to lay out in in the straight.

ARAY OF SUNSHINE (E. Boyd) - shortly after the entrance to the straight had difficulty obtaining clear running until approaching the 200 metres, where it was obliged to shift in to improve its position and in doing so took CONCONI inwards, hampering that horse for a number of strides. Thereafter, laid out under pressure over the concluding stages.

AUSTRALIAN DESIGN (K. Zechner) - awkward to begin, shifted out, contacted MABEL JOSEPHINE and thereafter over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

MABEL JOSEPHINE (J. Potter) - contacted at the start.

CONCONI (K. Crowther) - Near the 200 metres was taken in and hampered for a number of strides by ARAY OF SUNSHINE which shifted in to improve.

RACE 6: CAUDO VINEYARD HANDICAP - 2250 Metres

BERTWHISTLE (K. Crowther) - near the 1400 metres was momentarily inconvenienced when awkward on the heels of BREAK AND ENTER, which rolled out slightly. Rider explained it was her intention to settle closer to the speed and as the race unfolded mid-race, she was comfortable settling behind BREAK AND ENTER, however, shortly thereafter the pace slackened and this in her opinion did not suit the mare. She stated thereafter the mare only finished the event off evenly.

BREAK AND ENTER (P. Gatt) - Trainer Mr M. Williams advised Stewards prior to the event of a change in tactics, that being, that he would instruct his rider to be positive in the early stages and attempt to obtain a more forward position in running. Near the 1400 metres rolled out slightly and momentarily inconvenienced BERTWHISTLE. A post-race veterinary examination revealed no visible abnormalities.

ZOUY'S COMET (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.



RACE 6: CAUDO VINEYARD HANDICAP - 2250 Metres (Cont'd)

MANZALA (E. Finnegan) - Trainer Ms A. Downing advised Stewards prior to the event of a change in tactics, that being, that she would instruct her rider to attempt to be more forward in this event. Contacted at the start.

BUSKER'S BALLAD (D. Tourneur) - award to begin.

SWANKYTOFF (A. Jordsjo) - awkward to begin, shifted out and contacted MANZALA. A post-race veterinary examination revealed no visible abnormalities.

EXALTED AMBITION (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: WINNING EDGE PRESENTATIONS HANDICAP - 1000 Metres

CELTIC BLAST (R. Hurdle) - raced keenly in the early and middle stages of the event. Near the 200 metres shifted out under pressure for a short distance.

TATOOSH (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

IRISH MINT (C. Jones) - held up for clear running form near the entrance to the straight until approaching the 200 metres, elected to shift to the outside of CELTIC BLAST to improve and was initially dictated to by that horse which shifted out under pressure and as a consequence shifted out onto BRIMARVI VEHERO, which shifted out and away from this horse and a short distance thereafter BRIMARVI VEHERO shifted out onto OAMARU OWL near the 150 metres, tightening that horse onto the heels of STAR OF MONSOON resulting in OAMARU OWL having to be checked losing its position.

OAMARU OWL (J. Potter) - raced keenly in the early and middle stages of the event. Near the 700 metres commenced to lay in, rolled in at the same time as FLOSTAR rolled out and became awkward outside the heels of FLOSTAR for a number of strides. Thereafter was inclined to continue to lay in. Near the 150 metres, was tightened by BRIMARVI VEHERO onto the heels of STAR OF MONSOON, had to be checked and lost its positon.

BRIMARVI VEHERO (D. Tourneur) - shifted out and away from IRISH MINT inside the 200 metres and as a consequence continued to shift out onto OAMARU OWL, which was tightened onto the heels of STAR OF MONOON, resulting in OAMARU OWL having to be checked losing its position.

FLOSTAR (J. Toeroek) - laid out in the straight. Over the concluding stages continued to shift ground wider on the track hampering STAR OF MONSOON on two separate occasions taking that horse wider.

MR HAMILTON (D. Caboche) - which had not raced since July 2019 underwent a pre-race veterinary examination and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

STAR OF MONSOON (S. Logan) - taken wider over the concluding stages by FLOSTAR and was hampered on two separate occasions.

Correct weight was delayed to allow Trainer Mr G. Young, and S. Logan the rider of MONSOON, to view the vision in the straight.

RACE 8 AAMI HANDICAP - 1300 Metres

The start of this event was delayed approximately three minutes.

ANALYTICA (NZ) (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.



RACE 8 AAMI HANDICAP - 1300 Metres (Cont'd)

BEEOKAY (S. Logan) - inclined to lay in, in the straight.

JUST KAPPY (J. Potter) - lost its near hind plate prior to leaving the mounting yard. Had to be attended to by the Farrier, was replated and proceeded to the barriers. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race. Laid out in the straight.

BAR GEM (E Boyd) - had its tongue-tie adjusted on arrival at the barriers. A post-race veterinary examination revealed gelding had bled from both nostrils. Trainer, Mr R. Wilkinson, was advised that as this was the gelding first bi-lateral bleed BAR GEM would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

ALSVIOR (P. Gatt) - which raced on 24 June 2020 at Murray Bridge underwent a pre-race veterinary examination and was passed fit to race. It was noted that after winning on 24 June 2020 at Murray Bridge the gelding had been re-handicapped to carry 55.5 kg in this event. Held up for clear running from near the entrance to the straight until inside the 300 metres.

LITTLEBITFUNNY (K. Crowther) - had difficulty obtaining clear running from shortly after the entrance to the straight until inside the 300 metres where it was obliged to shift to the outside of SPIRITED MATCH to improve its position.

RACE 9: TAB HANDICAP - 1000 Metres

CALL ME CURTIS (C. Jones) - raced wide without cover throughout the event. Near the 200 metres was contacted by SYMPHONETTE, had its hindquarters turned and was inclined to lay in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

SYMPHONETTE (D. Caboche) - contacted near the 200 metres, shifted out slightly and contacted CALL ME CURTIS. A post-race veterinary examination revealed no visible abnormalities.

WHITE KAPS (A. Jordsjo) - near the 200 metres was tightened by AKKACAN as that horse improved into a run to the outside of WANAASA and shifted out and away from WANAASA as that horse commenced to shift ground outwards. As a consequence had to be steadied for several strides and lost its position when tightened by AKKACAN onto SYMPHONETTE.

ATOMIC WIZARD (J. Holder) - held up for clear running from near the entrance to the straight until approaching the 150 metres.

AKKACAN (K. Zechner) - hampered shortly after the start. Near the 200 metres shifted outwards after improving to the outside of WANAASA, as that horse shifted ground, and as a consequence tightened WHITE CAPS onto SYMPHONETTE.

WANAASA (T. Voorham) - got its head up shortly after the start and shifted out onto AKKACAN, hampering that horse. Near the 200 metres shifted out for a number of strides taking AKKACAN, which had improved to its outside, on an outward course, and onto WHITE KAPS. Rider was reprimanded and advised to take greater care in future.

OGGALUTION (B. Vorster) - near the 700 metres was obliged to race in restricted room for a number of strides and was hampered when racing to the inside of RUSHWA, which shifted in and away from AKKACAN, which improved to its outside.

RUSHWA (S. Fawke) - awkward and slow to begin. Near the 700 metres shifted in and away from AKKACAN onto OGGALUTION, which was tightened onto the running rail and hampered for a number of strides.
