## RACE 1: DESTINATION HOMES AUSTRALIA / SABOIS FOUR-YEAR-OLD & OVER MAIDEN <u>PLATE</u> - 1100 Metres

**COLORADO KID** (J. Opperman) – raced keenly in the early and middle stages and was inclined to lay out. In the vicinity of the 450 metres had to be steadied when it laid out onto the heels of WOODCROFT.

DEEJAY BOBO (NZ) (J. Potter) - jumped away awkwardly and shifted out onto WOODCROFT.

**SPUDSTA** (K. Crowther) - in the vicinity of the 100 metres had to be steadied when ARCTIC FLORA shifted in.

WOODCROFT (D. Tourneur) - hampered on jumping away.

**ARCTIC FLORA** (J. Holder) – inclined to lay in under pressure in the straight and in the vicinity of the 100 metres shifted in onto SPUDSTA. Rider severely reprimanded and advised to stop riding and straighten sooner than he had on this occasion in future when his mounts commence to shif ground.

**ELECTRUM** (K. Bishop) – laid out under pressure in the straight.

**LYRICKIN'S DREAM** (P. Gatt) – rider reported the mare felt awkward in its action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.



# RACE 2: ROAD TO THE BIGTIME' PODCAST / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1100 Metres

COMPANY (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

**DIVINE SUCCESS** (J. Opperman) – hampered on jumping away when tightened onto LOOKING FORWARD by XINGYUN. Raced in restricted room for a number of strides in the vicinity of 200 metres when awkwardly placed to the inside of ILLUSION DATE.

LOMAX (J. Potter) – momentarily steadied approaching the 100 metres when NARRATIVE laid out.

**LOOKING FORWARD** (J. Eaton) – contacted on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**OSCILLATION** (D. Tourneur) – inconvenienced when taken wider in the vicinity of the 800m by MOSSTADO MISS.

**PEARL DRAGON** (J. Holder) – inclined to shift about under pressure in the straight. Lost its off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

**XINGYUN** (K. Zechner) – shifted out on jumping away onto DIVINE SUCCESS. Raced greenly in the straight and was inclined to shift about under pressure.

**MOSSTADO MISS** (K. Bishop) – raced wide without cover throughout the event. Laid out rounding the turn in the vicinity of the 800 metres.

NARRATIVE STAR (B. Vorster) - Laid out under pressure in the straight.

#### RACE 3: MARX REAL ESTATE / SABOIS DISTANCE MAIDEN PLATE - 2112 Metres

**GUNFIREINTHECITY** (K. Crowther) - laid out rounding the home turn and under pressure in the straight.

MAGUS MAN (C. Jones) - laid in under pressure in the straight.

MANILOW (J. Toeroek) - laid in under pressure in the straight.

**OURKEED** (S. Fawke) – fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and passed fit to race.

**NGAIRE** (J. Potter) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

SHOPSTER (J. Maund) - raced keenly in the early and middle stages of the event.

#### RACE 4: COOPERS BENCHMARK 62 HANDICAP - 2112 Metres

**EXALTED AMBITION** (T. Pannell) - A post-race veterinary examination revealed the gelding was lame in the off hind leg. Trainer Mr G. Young was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**CONNERMARA ROSE** (D. Tootell) - slow to begin. Shifted out and away from BUCKEYE NATION at the entrance to the straight and contacted REINVIGORATE. Rider was reminded of his obligations in riding his mounts out to the end of the race in accordance with AR131(b).

**REINVIGORATE** (NZ) (B. Vorster) – inconvenienced at the entrance to the straight when contacted by CONNERMARA ROSE.

**KARAOKE EXPRESS** (T. Voorham) – made the crossing in the vicinity of the 1800 metres awkwardly.

## RACE 5: SPECSAVERS GAWLER BENCHMARK 54 HANDICAP - 1100 Metres

LORD ROSENTHAL (M. Collett) - shifted out shortly after the start onto PONTYPAUL.

**HEART LIKE MINE** (B. Vorster) - A post-race veterinary examination revealed no visible abnormalities.

**PONTYPAUL** (D. Tootell) – shortly after the start lost its position when tightened between LORD ROSENTHAL and SARAH'S JULE. In the vicinity of the 800 metres was inconvenienced when taken wider by TOFFEE BELL. A post-race veterinary examination revealed no visible abnormalities.

**SARAH'S JULE** (D. Tourneur) – On jumping away shifted in and away from CHEVITE onto PONTYPAUL.

**TOFFEE BELL** (K. Bishop) – inclined to rear on jumping away and was slow into stride. Raced fiercely in the early and middle stages of the event and in the vicinity of the 800 metres laid out onto PONTYPAUL, which was taken wider.

#### RACE 6: ADELAIDE PLAINS BLOODSTOCK BENCHMARK 54 HANDICAP - 1506 Metres

**KING RED** (T. Pannell) - had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

ALLAYEZ (J. Opperman) - laid out under pressure in the straight.

**TAPPIN' THOMAS** (J. Holder) - A post-race veterinary examination revealed no visible abnormalities.

**SHARPLY ATTIRED** (K. Bishop) – raced keenly in the middle stages of the event whilst being restrained. A post-race veterinary examination revealed no visible abnormalities.

**TATTIES** (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

#### RACE 7: CORNERSTONE STUD / SABOIS FILLIES & MARES BENCHMARK 58 HANDICAP - 1200 Metres

**MABEL JOSEPHINE** (M. Collett) - underwent a pre-race veterinary examination and was passed fit to race. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

HOLY TORMENT (K. Crowther) - laid in under pressure in the straight.

HILUMIERE (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

JUST KAUTO (T. Voorham) - raced keenly in the early and middle stages of the event.
