RACE 1: ADRIAN THOMAS INDUSTRIAL / SABOIS MAIDEN HANDICAP - 1400 Metres

The start of this event was delayed approximately 15 minutes as the arrival of the First Care was delayed due to a breakdown.

BACK IN ACTION (G. O'Loughlin) - rolled about in the straight. Rider explained the horse raced greenly throughout the event and never travelled. A post-race veterinary examination revealed the horse to be shin sore in the near side leg.

WONGABELLE (S. Logan) - jumped away awkwardly, shifted in and contacted PELADERA.

PELADERA (P. Gatt) - contacted at the start. Laid in, in the straight. Rider was obliged to straighten his mount on a number of occasions over the final 100 metres placing him at a disadvantage.

DR CHOCCY (J. Opperman) - jumped away awkwardly. Raced keenly in the middle stages of the event.

RACE 2: FINNS FINE FOODS / SABOIS MAIDEN PLATE - 1100 Metres

JAYWICK (J. Maund) - on jumping away lost its position when tightened onto FENCELINE by HALO'S QUEST.

HALO'S QUEST (D. Caboche) - bumped on jumping away by ISA SECRET and as a result taken JAYWICK wider on the track.

WEEKEND BANG (G. O'Loughlin) - Rider pleaded guilty to a charge under AR132(7)(a)(i) in that he used his whip in in consecutive strides prior to the 100 metres and was reprimanded. Rider also pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$500. In determining penalty, Stewards had regard for the totality of the use of the whip by rider and noted that he only used his whip on one occasions over the last 100 metres. Rider reprimanded under AR131(b) for failing to ride his mount out to the line.



RACE 2: FINNS FINE FOODS / SABOIS MAIDEN PLATE - 1100 Metres (Cont'd)

ISA SECRET (S. Logan) - jumped away awkwardly and shifted out bumping HALO'S QUEST. Laid out throughout the event. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

DETNAW (A. Jordsjo) - jumped away awkwardly.

RACE 3: COOPERS BREWERY BENCHMARK 68 HANDICAP - 1300 Metres

GIGGLON (L. Halliday) - jumped away awkwardly. Approaching the 150 metres was obliged to be steadied and altered course to avoid the heels of GOOD THERAPY.

GOOD THERAPY (S. Fawke) - laid out rounding the home turn. Laid in, in the straight. Approaching the 150 metres shifted in and inconvenienced GIGGLON. Rider reprimanded under AR131(a) and advised to make a greater effort to straighten his mounts when they commence to shift ground.

DYAGILEV (J. Maund) - raced keenly in the early and middle stages of the event. In the vicinity of the 1000 metres got its head up while being restrained.

CANNY MOVE (G. O'Loughlin) - jumped away awkwardly.

RACE 4: MP AIR-CON & EXCAVATION BENCHMARK 62 HANDICAP - 1100 Metres

LOVE MAGIC (J. Eaton) - had difficulty obtaining clear running from the entrance to the straight and became disappointed when attempting a run inside the 200 metres between THANASI and MONTRE and was not fully tested to the finish.

TERINDAH (P. Gatt) - jumped away awkwardly. Raced wide without cover throughout the event. Laid in, in the straight. Rider reported his mount never travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

THANASI (J. Opperman) - jumped away awkwardly. In the vicinity of the 600 metres rolled out and inconvenienced MONTRE. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

MONTRE (D. Caboche) - Stewards permitted D. Caboche to ride the filly 0.5 kg over its declared weight of 54kg. Jumped away awkwardly.

BENOVSKY (L. Halliday) - jumped away awkwardly and shifted in.

Correct weight was delayed to allow K. Crowther (DR DEE DEE) placed third, to view the official photo finish.

RACE 5: OMNIZAR BENCHMARK 62 HANDICAP - 1700 Metres

LUCADONIS (M. Collett) - raced greenly from the 400 metres until the finish. Inside the 100 metres inconvenienced by SUPERHOOP, which rolled out.

ACT OF AGGRESSION (P. Gatt) - in the vicinity of the 300 metres allowed his mount to shift in tightening the running of TAKSIM GIRL. Rider was reminded of his obligations and obliged to straighten his mounts sooner when they commence to shift ground.

SUPERHOOPS (S. Fawke) - jumped away awkwardly. Inside the 100 metres rolled out and inconvenienced LUCADONIS.



RACE 5: OMNIZAR BENCHMARK 62 HANDICAP - 1700 Metres (Cont'd)

TAKSIM GIRL (Z. White) - in the vicinity of the 300 metres inconvenienced by ACT OF AGGRESSION, which rolled in.

LADY DEE DEE (K. Zechner) - jumped away slowly.

RACE 6: TAB CLASS TWO HANDICAP - 1100 Metres

BARRY'S BROTHER (L. Halliday) - underwent a pre-race veterinary examination as it had not raced for over 10 months and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

CORAGGIO (C. Jones) - jumped away slowly.

RUBY QUE (M. Collett) - underwent a pre-race veterinary examination as it had not raced for over 10 months and passed fit to race. In the vicinity of the 400 metres obliged to be steadied after improving onto the heels of PERSIAN HONEY. A post-race veterinary examination revealed no visible abnormalities.

HASTA LA DREAMS (K. Zechner) - raced ungenerously in the early and middle stages of the event. In the vicinity of the 600 metres was obliged to be steadied on a number of occasions away from the heels of FERGIE, which rolled out. Held up for clear running until the 150 metres when obliged to shift out to the outside of OPHELIA BLUES to obtain clear ground.

DENOMINATOR (NZ) (S. Fawke) - Stewards permitted S. Fawke to ride the filly 0.5 kg over its declared weight of 54kg. Underwent a pre-race veterinary examination on arrival at the barriers and passed fit to race. Jumped away awkwardly. Laid out in the straight.

RACE 7: MED ELECTRICAL BENCHMARK 54 HANDICAP - 1400 Metres

BUBBLERAP (J. Opperman) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

FAREWELL GRETA (G. O'Loughlin) - raced keenly in the early and middle stages of the event.

TIZA (S. Fawke) - stood flat footed as the start was effected and as a result was slow to begin by four lengths.

O'MIZZNA (J. Eaton) - jumped away awkwardly and shifted out.
