RACE 1: S.A. SHIPARD & D.E. BEATTIE MEMORIAL MAIDEN PLATE - 1200 Metres

WICKED KID (E. Annells) - laid in, in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by E. Annells and noted that she used it on one occasions over the final 100 metres of the event.

BLINKIN READY NOW (A. Chung) - laid out under pressure in the straight.

PORTRAIT OF MACIE (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

CHATAFOX (E. Wong) - trainer, Mr T. Haddy, was reprimanded under AR65(1) for failing to produce the Thoroughbred Identification Card for the filly. CHATAFOX was permitted to start as it was able to be identified from records held by the Stewards.

RACE 2: GYPSUM RESOURCES AUSTRALIA/PENONG STATION BENCHMARK 52 - 1000 Metres

GOLDEN PHYSICIAN (F. Atkinson) - underwent a pre-race veterinary examination and was passed fit to start.

ZAAZOE (E. Annells) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by E. Annells and noted that she did not use it over the final 100 metres of the event.

RACE 3: CEDUNA FORESHORE HOTEL/WEST COAST FUELS BENCHMARK 56 HANDICAP - 1200 Metres

MAGNUS MAGIC (M. Vassallo) - was inconvenienced in the vicinity of the 250 metres when TILBURY rolled in marginally and was obliged to shift out to obtain clear ground.

TUNGKETTA (E. Annells) - a post-race veterinary examination revealed no visible abnormalities.

TILBURY (A. Chung) - inclined to lay in, in the straight. In the vicinity of the 250 metres rolled in marginally onto MAGNUS MAGIC, which was inconvenienced and obliged to shift out to obtain clear ground.



RACE 4: FAR WEST FARMERS PENONG CUP - 1600 Metres

BOTTLE AND BIRD (E. Wong) - inclined to lay out in the straight.

ART MUSIC (M. Vassallo) - laid in rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

SLIPPERY JOURNEY (A. Chung) - knuckled on jumping away. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by A. Chung and noted that he did not use it over the final 100 metres of the event.

RACE 5: CHEETHAM SALT/PENONG HOTEL BENCHMARK 52 TROPHY RACE - 1400 Metres

ONWARD (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

TREMBLING (F. Atkinson) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

HOST ESPRIT (M. Vassallo) - a post-race veterinary examination revealed no visible abnormalities.

FLYING LOCO (E. Annells) – rider reported that her saddle slipped back shortly after jumping away placing her at a disadvantage for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

SCALLOP (E. Wong) – slow to begin. Laid out under pressure in the straight. Rider returned to the jockey room prior to weighing in, however, quickly returned to scale and weighed in as required. Stewards were comfortably satisfied that the horse carried the correct weight in the event. Rider was reprimanded under AR210(1).
