# Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Monday, 8 March 2021

## RACE 1: TAB CINDERELLA STAKES - 1050 Metres

BOLSONARO (A. Jordsjo) – held up for a short distance prior to the entrance to the straight when racing behind ROXY BLUE. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by A. Jordsjo and noted that she used it on four occasions over the final 100 metres of the event. Rider reported that her mount was slow to begin.

SIRIANNI (J. Holder) - raced greenly in the straight. Approaching the 200 metres rolled in and brushed with GLOVED (NZ).

GLOVED (NZ) (B. Vorster) – raced keenly in the early stages of the event. Raced greenly in the straight and approaching the 200 metres rolled out and brushed with SIRIANNI. A post-race veterinary examination revealed no visible abnormalities.

STARSONGARI (J. Toeroek) – approaching the entrance to the straight was momentarily inconvenienced between SERADESS, which maintained its line, and ZOMBIE WITNESS, which shifted out slightly to improve.



ZOMBIE WITNESS (M. Aitken) - trainer, Mr T. Doudle, failed to produce the Thoroughbred Identification Card for the gelding. ZOMBIE WITNESS was permitted to start as it was able to be identified from records held by Stewards. Approaching the entrance to the straight was inclined to lay out and shifted out slightly momentarily tightening and inconveniencing STARSONGARI. A post-race veterinary examination revealed no visible abnormalities.



## RACE 2: WHITE MARQUEE HANDICAP - 1600 Metres

FIVE KINGDOM (T. Stockdale) – tightened shortly after the start by LEGEND OF ZORRO, which rolled out. Near the 800 metres got its head up and raced ungenerously for a short distance. A post-race veterinary examination revealed no visible abnormalities.

UNLACED (NZ) (J. Eaton) – awkward to begin, shifted out and contacted LEGEND OF ZORRO. Inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

JACKTHEGIANTSLAYER (C. Jones) – awkward and slow to begin. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by C. Jones and noted that she used it on four occasions over the final 100 metres of the event.

LEGEND OF ZORRO (W. Price) - trainer, Mr A. Noblet, failed to produce the Thoroughbred Identification Card for the gelding. LEGEND OF ZORRO was permitted to start as it was able to be identified from records held by Stewards. Awkward to begin, shifted in and contacted UNLACED (NZ). Shortly thereafter, rolled out and tightened FIVE KINGDOM onto ROSELLI STING. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by W. Price and noted that he used it on two occasions over the final 100 metres of the event.

LA RICHESSE (T. Pannell) - laid out under pressure over the concluding stages of the event.

ICECRUSHER (R. Hurdle) - raced keenly in the early stages of the event.

## RACE 3: FURPHY HANDICAP - 1200 Metres

ECUMENICAL (J. Eaton) - rider explained that her instructions were to be positive in the early stages of the event and to attempt to take a position behind the leaders. She added that the filly was slow to muster early speed and as a consequence she was unable to take up a forward position as intended and was obliged, under the circumstances, to race further back and wide without cover for the entire event. She stated that notwithstanding the horse being disadvantaged by being trapped wide without cover and out of position, the filly finished the race off in a manner which suggested that it may be better suited to racing over more ground in future. A post-race veterinary examination revealed no visible abnormalities.

HIGHLY DISCREET (W. Price) - near the 300 metres became awkward on the heels of PIMM'S PARTY and was obliged to shift to that horse's outside to improve.

PIMM'S PARTY (J. Holder) - awkward to begin, shifted out and contacted THE BIG EASY, which was taken out slightly.

SMOKIN' VAL (K. Crowther) - laid in for a short distance approaching the 100 metres.

THE BIG EASY (D. Yendall) - contacted and taken out slightly at the start.

## RACE 4: TERRY HOWE PRINTING MATRICE STAKES - 1200 Metres

GARNER (J. Holder) - contacted at the start.

TERBIUM (K. Crowther) – awkward to begin and shifted out onto SECOND SLIP (NZ), which was tightened onto GARNER. Rider reported that the gelding felt uneven and awkward in its action from in the vicinity of the 600 metres and for that reason she did not ride it in her normal manner over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.



SECOND SLIP (NZ) (T. Pannell) - inconvenienced shortly after the start when tightened onto GARNER by TERBIUM, which shifted out.

## RACE 4: TERRY HOWE PRINTING MATRICE STAKES - 1200 Metres (cont'd)

SWING AND BOOM (D. Yendall) – slow to begin. Rider reported that he became concerned with the mare's action shortly after the start and when asked for an effort to improve the mare's action became more exaggerated, and for that reason he did not ride it in his normal manner from inside the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

NIGHT RAID (J. Kah) – Stewards permitted J. Kah to ride the filly 0.5 kg above its declared weight of 53.0 kg.

#### RACE 5: CANADIAN CLUB HANDICAP - 1050 Metres

AIGUILETTE (K. McEvoy) - approaching the 200 metres shifted out to improve and brushed with CALL IT A DAY taking that horse a little wider.

SIZZLEFLY (K. Crowther) – from inside the 800 metres until in the vicinity of the 700 metres was brushed on several occasions by JUST CHIPPING AWAY, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

IDATWO (S. Price) – which had not raced since March 2019 underwent a pre-race veterinary examination and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

TOFF LOVE (B. Vorster) - began awkwardly, shifted out and contacted CALYPSO REIGN.

CALYPSO REIGN (P. Gatt) - began awkwardly and was hampered shortly thereafter by TOFF LOVE, which shifted out.

CALL IT A DAY (T. Pannell) – dislodged its rider in the mounting yard. Rider was examined by the First Care Medical personnel and was passed fit to fulfil his engagements. Approaching the 200 metres was inconvenienced by AIGUILETTE, which shifted out to improve and as a consequence was taken a little wider. A post-race veterinary examination revealed no visible abnormalities.

LITTLE RICH BOY (S. Metcalfe) - shifted out under pressure over the concluding stages of the event.

JUST CHIPPING AWAY (D. Holland) - from near the 800 metres until in the vicinity of the 700 metres rolled in on several occasions and brushed with SIZZLEFLY.

MILEVA (A. Jordsjo) - shifted out under pressure over the concluding stages of the event.

HARD ROCK GIRL (J. Holder) - inclined to lay out rounding the home turn.

#### RACE 6: C S HAYES MEMORIAL CUP - 1600 Metres

LE DON DE VIE (GB) (T. Pannell) – co-trainers, Messrs A. & S. Freedman, failed to produce the Thoroughbred Identification Card for the gelding. LE DON DE VIE (GB) was permitted to start as it was able to be identified from records held by Stewards. Held up for clear ground from near the entrance to the straight until inside the 100 metres.

NIGHT'S WATCH (NZ) (M. Zahra) – slow to begin. Near the entrance to the straight shifted out to improve and momentarily tightened VON COSTA GLASS. A post-race veterinary examination revealed no visible abnormalities.

OVER EXPOSURE (J. Kah) - near the 1200 metres, when the placed slackened, became awkward on the heels of BALF'S CHOICE and had to alter course to the outside of that horse. Rider reported that the gelding felt awkward in its action during the event. A post-race veterinary examination revealed the gelding to have jarred up in both forelegs. Co-trainer, Mr T. McEvoy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. Mr T. McEvoy, advised that the gelding will now be spelled.



RITRATTO (J. Holder) – shortly prior to the winning post shifted out abruptly of its own accord and contacted with LORD VLADIVOSTOK (NZ).

## RACE 6: C S HAYES MEMORIAL CUP - 1600 Metres (cont'd)

VON COSTA GLASS (K. Crowther) – shortly after the entrance to the straight was obliged to race in restricted room for several strides when momentarily tightened by NIGHT'S WATCH (NZ), which shifted out to improve.

RENEGADE (B. Vorster) - near the 1200 metres was hampered and was obliged to be steadied when tightened by EXALTED TRAVELLER, which shifted.

LORD VLADIVOSTOK (NZ) (J. Eaton) – approaching the 100 shifted out when inclined to lay out and contacted IRONCLAD (GB) and as a consequence had its own hindquarters turned. Thereafter, shortly prior to the winning post was contacted by RITRATTO, which shifted out abruptly of its own accord.

IRONCLAD (GB) (K. McEvoy) - approaching the 100 metres was contacted by LORD VLADIVOSTOK (NZ), which shifted out when inclined to lay out.

EXALTED TRAVELLER (D. Tourneur) – near the 1200 metres shifted in and tightened RENEGADE, which had to be steadied. Rider was reprimanded under AR131(a) and advised to take greater care when shifting ground in future.

#### RACE 7: TAB ADELAIDE CUP - 3200 Metres

SIN TO WIN (NZ) (D. Stackhouse) – underwent a pre-race veterinary examination and was found to be lame in the near foreleg and unfit to start. Acting on this advice Stewards withdrew SIN TO WIN (NZ) at 1.51 pm. Co-trainers, Mr T. Dabernig & Mr B. Hayes, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

TRALEE ROSE (NZ) (J. Holder) – shifted in, inside the 600 metres, and crossed the running of DARVIN (IRE), which had to be steadied. Rider reprimanded under AR131(a) and advised to take greater care when shifting ground in future. A post-race veterinary examination revealed the mare to have a poor respiratory and cardiac recovery.

BARADE (FR) (J. Eaton) - laid out under pressure from in the vicinity of the 200 metres.

LONG ARM (IRE) (K. McEvoy) - inclined to lay in under pressure over the concluding stages of the event.

STARS OF CARRUM (J. Benbow) – awkward to begin and shifted out onto RIPCORD (NZ), which was hampered when tightened onto TABLE OF WISDOM.

EPERDUMENT (K. Crowther) – rider reminded of her obligations in riding her mounts out to the finish of the event.

CLASSIC WEIWEI (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

DARVIN (IRE) (D. Yendall) - inside the 600 metres was obliged to be steadied when crossed by TRALEE ROSE (NZ). A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr M. Williams, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

RIPCORD (NZ) (D. Bates) – tightened and hampered at the start by STARS OF CARRUM, which shifted out and as a consequence was taken out onto TABLE OF WISDOM. A post-race veterinary examination revealed the gelding to be exhibiting signs of heat stress and the thumps. First aid administered.

TABLE OF WISDOM (A. Jordsjo) - which raced on Saturday, 06 March 2021, underwent a prerace veterinary examination and was passed fit to start. Contacted at the start.



#### RACE 8: MORPHETTVILLE GUINEAS - 1600 Metres

STRUCK BY (P. Gatt) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions and was fined \$300. In determining penalty Stewards had regard for the totality of the use of the whip by P. Gatt and noted that he used it on six occasions over the final 100 metres of the event; however Stewards also his recent record for breaches of this rule.

ULTIMATE VICTORY (D. Tourneur) – over-raced for a short distance from near the 1200 metres. Rider reported that the gelding felt awkward in its off foreleg for a short distance inside the 500 metres. A post-race veterinary examination revealed no visible abnormalities.

VICTORIA QUAY (J. Kah) – rider explained that the filly may derive benefit from today's run and, in her opinion, may be suited to racing over more ground. A post-race veterinary examination revealed no visible abnormalities.

ANOTHER AWARD (J. Holder) - inclined to lay in, in the straight.

ANGELIC SCENT (D. Stackhouse) - laid out in the straight.

## RACE 9: WINNING EDGE PRESENTATIONS HANDICAP - 1200 Metres

HYPERCANE (J. Toeroek) - held up for clear running rounding the home turn and in the early part of the straight. Near the 200 metres shifted out and hampered ATEN, which was taken out onto BOLT I AM. A post-race veterinary examination revealed no visible abnormalities.

VIDUKA (W. Price) – approaching the 1000 metres when crossed by CALL ME CURTIS, which improved to its outside, was obliged to be steadied to avoid that horse's heels.

BOLT I AM (P. Gatt) – inconvenienced over the concluding stages by MIDNIGHT STORM, which shifted out and away from VIDUKA, which shifted out.

CALL ME CURTIS (D. Tourneur) – approaching the 1000 metres shifted in when insufficiently clear of VIDUKA taking that horse's running resulting in VIDUKA having to be steadied. Rider was severely reprimanded for careless riding under AR131(a).

HYPERSONIC (K. McEvoy) - a post-race veterinary examination revealed no visible abnormalities.

ATEN (R. Hurdle) - raced keenly in the early stages of the event. Near the 200 metres was hampered and taken out onto BOLT I AM by HYPERCANE, which shifted out.

MIDNIGHT STORM (J. Holder) – shifted out and away from VIDUKA over the concluding stages of the event as that horse shifted out and as a consequence inconvenienced BOLT I AM.

MIROKU (J. Benbow) – held up for clear running from rounding the home turn and in the early part of the straight before obtaining clear ground inside the 300 metres. Thereafter was again held upfor clear running for a short distance approaching the 100 metres.

WOULDA THOUGHT SO (A. Jordsjo) - raced wide without cover throughout the event.
