INTERIM REPORT

RACE 1: G.H. MUMM TWO-YEAR-OLD MAIDEN PLATE - 1100 Metres

MY KHALIFA (R. Hurdle) - jumped away awkwardly, shifted in and contacted ZYCLONIC, which was inconvenienced when taken in. Raced greenly in the straight.

STRIKE EAGLE (B. Vorster) - raced keenly in the early stages of the event. Raced greenly over the concluding stages.

VEZERE RIVER (K. Crowther) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

ZYCLONIC (J. Potter) - inconvenienced and taken in on jumping away.

APACHE FOX (J. Maund) - rider reported that the filly felt short in its action in front. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: ACCOLADE WINES HANDICAP - 1200 Metres

JAPERY (C. Rawiller) – raced keenly in the early stages of the event. In the vicinity of the 1000 metres was tightened by LADY SIMONE, which shifted in, had to be restrained for several strides, shifted in and tightened WINNING WEATHER and thereafter was obliged to shift to the outside of LADY SIMONE's heels.

VICTORY CLUB (J. Opperman) - slow to begin.

WINNING WEATHER (J. Holder) - near the 1000 metres was obliged to race in restricted room to the inside of JAPERY as that horse was tightened, and as a consequence was taken in slightly and hampered NO STRINGS for a number of strides.

SHORT STORIES (T. Pannell) - slow to begin and shortly thereafter was hampered by NO STRINGS, which shifted out on jumping away. Inside the 1000 metres became awkward on the heels of JAPERY for several strides.

TANJA'S DREAM (R. Hurdle) – awkward to begin. A post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer, Mr T. Doudle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

FALL ON A STAR (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

TREAD SOFTLY (J. Eaton) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

NO STRINGS (S. Metcalfe) - shifted out on jumping away and hampered SHORT STORIES. Raced keenly in the early stages of the event. Near the 1000 metres was hampered for several strides when WINNING WEATHER was taken in by JAPERY.

LADY SIMONE (S. Logan) – approaching the 1000 metres shifted in and tightened JAPERY, which was hampered for several strides, taken in onto WININNG WEATHER, which was tightened. As a consequence of being tightened JAPERY was obliged to be restrained and had to alter course to the outside of LADY SIMONE to avoid that horse's heels. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 3 July 2021 to conclude midnight Saturday, 10 July 2021, a period of three meetings.

RACE 3: THE JUNCTION MAIDEN PLATE - 1200 Metres

THE PARTISAN (J. Maund) - lost its off fore plate during the event.

UTAH JOE (K. Crowther) - inclined to lay in, in the straight.

WE WILL REMEMBER (T. Pannell) - raced very keenly in the early stages of the event. Held up for clear running from in the vicinity of the 500 metres until shortly after the entrance to the straight. Commended to race very greenly from inside the 200 metres and shifted out over the concluding stages of the event. A post-race veterinary examination revealed a lower than expected heart rate.

LOTTIE'S THE BOSS (J. Eaton) - rider accidentally dropped her whip inside the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

MISS LANGTRY (S. Logan) - raced keenly in the early stages of the event.

MISS SIZZLER (C. Jones) - very awkward to begin. A post-race veterinary examination revealed no visible abnormalities.

TURFITT (J. Holder) - raced keenly in the early stages of the event.

CLUB QUEEN (C. Lions) - raced wide without cover throughout the event.



RACE 4: FURPHY HANDICAP - 1050 Metres

EPIC GREY (C. Rawiller) - contacted at the start by MUM'S MY HERO and taken in onto AADELAD. Near the 700 metres shifted out and momentarily inconvenienced LARIMER STREET, which had to be steadied. Rider was reprimanded and advised to take greater care when shifting ground in future. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by C. Rawiller and noted that he used it on one occasion over the final 100 metres of the event. A post-race veterinary examination revealed no visible abnormalities.

STAR HILLS (S. Logan) - awkward to begin. Laid out in the straight.

MUM'S MY HERO (A. Jordsjo) - shifted in at the start and contacted EPIC GREY, which was taken in onto and contacted AADELAD, which began awkwardly and shifted out.

CELTIC BLAST (R. Hurdle) - awkward to begin. Raced keenly in the early stages of the event.

LARIMER STREET (P. Gatt) - near the 700 metres was momentarily inconvenienced and had to be steadied when EPIC GREY shifted out and took its running. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

AADELAD (B. Vorster) - began awkwardly and shifted out and was contacted by EPIC GREY which was taken in by MUM'S MY HERO. As a consequence AADELAD was severely hampered and lost ground.

EXTRA MILE (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 0.5 kg over its declared weight of 54.0 Kg. Inclined to lay in, in the straight.

BEEOKAY (E. Boyd) - rider reported that the gelding felt awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: DOMINANT HANDICAP - 1526 Metres

MY BOY BIRMINGHAM (J. Opperman) - shifted in on jumping away and contacted WHISKEY 'N' WOMEN, which shifted out. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Co-trainers, Messrs T & C McEvoy, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

LADY BETHANY (NZ) (C. Rawiller) - approaching the 400 metres was momentarily hampered when DON'T DISMISS shifted out into its running line. A post-race veterinary examination revealed no visible abnormalities.

CAMPOBASSO (NZ) (K. Zechner) - rider reported that the gelding laid in, in the straight.

DON'T DISMISS (R. Hurdle) - approaching the 400 metres shifted out and away from WHISKEY 'N' WOMEN into the running line of LADY BETHANY (NZ).

PENTIRE'S SPIRIT (NZ) (J. Toeroek) - rider reported that the gelding did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

WHISKEY 'N' WOMEN (D. Tourneur) - shifted out on jumping away and contacted MY BOY BIRMINGHAM, which shifted in. Approaching the 400 metres, after being held up for a number of strides when trailing CANIDAE, shifted out to improve, resulting in DON'T DISMISS shifting out and away from this horse into the running line of LADY BETHANY (NZ), resulting in LADY BETHANY (NZ) being momentarily hampered. After attempting a run to the outside of CANIDAE, WHISKEY 'N' WOMEN was disappointed for clear running and was obliged to alter course to the inside of CANIDAE to improve its position.

JAAMINT (K. Crowther) - lost its off hind plate during the event.

RACE 6: CANCER COUNCIL SA HANDICAP - 2032 Metres

NOT USUAL GLORIOUS (P. Gatt) - laid in, in the straight.

LORENTE (B. Vorster) - rider explained that the gelding was under pressure from near the 1000 metres and from near the 600 metres failed to respond to his riding and for that reason he did not ride this gelding out in his normal manner for the remainder of the race. He could offer no explanation for the gelding's poor performance. A post-race veterinary examination revealed no visible abnormalities.

DOES IT (NZ) (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

STAR STATUS (J. Holder) - Stewards permitted J. Holder to ride the gelding 0.5 kg over its declared weight of 54.0 kg. Awkward to begin.

FLOW METER (J. Maund) - underwent a pre-race veterinary examination and passed fit to start.

RACE 7: SAJC ARCHIVERS HANDICAP - 1600 Metres

SERIOUS SPENDER (C. Rawiller) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by C. Rawiller and noted that he did not use it over the final 100 metres of the event.

TIBETAN (NZ) (M. Aitken) – following the declaration of acceptances Trainer, Mr M. Hickmott, made an application to remove visors from the gelding's race gear. Stewards acceded to his request and acting under AR206(2) fined Mr Hickmott \$200 for a late gear declaration. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by M. Aitken and noted that he did not use it over the final 100 metres of the event.

CRYPTO CURRENCY (T. Pannell) - inclined to lay out in the straight.

MISOOL (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

LITTLEBITFUNNY (D. Tourneur) - awkward and slow to begin. Raced wide without cover throughout the event.

RACE 8: TAB HANDICAP - 1200 Metres

LIDO BEACH (C. Rawiller) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by C. Rawiller and noted that he used it on one occasion over the final 100 metres of the event.

FRANKIE PINOT (B. Vorster) - held up for clear running from approaching the 400 metres until near the 300 metres.

CONCRETE (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

AMBIDAZZLE (K. Crowther) - rider reported that the mare did not handle today's track conditions and that it changed stride on a number of occasions in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RINGFORT (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

RACE 9: IRISH RACE DAY AT MORPHETTVILLE - SATURDAY AUGUST 14 HANDICAP - 1050 Metres

HE'S EXCLUSIVE (NZ) (T. Pannell) - inside the 200 metres shifted out abruptly onto POLLYANNA, which was tightened onto SKARA BRAE. As a consequence POLLYANNA was obliged to be checked. A post-race veterinary examination revealed no visible abnormalities.

RACE 9: IRISHRACE DAY AT MORPHETTVILLE - SATURDAY AUGUST 14 HANDICAP - 1050 Metres (cont'd)

LITTLE AL (K. Zechner) - on jumping away made contact with SKARA BRAE and shifted out tightening ANAMNESIS.

SKARA BRAE (R. Hurdle) - contacted with LITTLE AL on jumping away. Inside the 200 metres was contacted by POLLYANNA and taken wider on the track. A post-race veterinary examination revealed no visible abnormalities.

NEVER YOU MIND (C. Jones) - awkward to begin. Rider explained that her instructions were to take up a forward position in today's event; however, after beginning awkwardly the gelding did not muster sufficient early speed to allow her to take up a forward position in running. She added that the gelding finished the race off only fairly.

SEA WITNESS (J. Holder) - rider explained that his instructions were to lead in today's event if possible. He added that the he was able to comply with those instructions; however, after straightening the gelding, in his opinion, had commenced to labour and weakened and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

POLLYANNA (K. Crowther) - inside the 200 metres was tightened onto SKARA BRAE by HE'S EXCLUSIVE (NZ), which shifted out abruptly, and was obliged to be checked.

ANAMNESIS (D. Tourneur) - difficult to load. Trainer, Mr K. Sweeney, was advised that a warning had been placed on the gelding. Tightened shortly after the start by LITTLE AL, which shifted out after making contact with SKARA BRAE on jumping away. As a consequence ANAMNESIS was taken out onto the heels of THE BIG GOODBYE and was unable to improve its position for several strides.
