RACE 1: THOMAS FARMS TWO-YEAR-OLD PLATE - 1050 Metres

KUSU (J. Toeroek) - near the 900 metres, became awkwardly placed between the heels of MONSEAGLE and SPENCER'S SPIRIT which rolled in when racing greenly.

MONSEAGLE (J. Holder) - raced greenly under pressure in the straight.

SPENCER'S SPIRIT (D. Tootell) – jumped away awkwardly. Near the 900 metres when racing greenly rolled in and continued to lay in for some distance. Hung out rounding the home turn. Rider explained in relation to the gelding's performance that it travelled well during the event; however raced on its wrong lead leg. Otherwise he was satisfied with the gelding's performance. A post-race veterinary examination revealed no visible abnormalities.

ZUFASTA (R. Hurdle) - laid in under pressure in the straight.

CELTIC VADER (K. Zechner) - dislodged it rider on route to the start. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. K. Zechner was examined by the first care medical personnel and passed fit to ride.

RACE 2: TWILIGHT RACES AT MORPHETTVILLE - FRIDAY DECEMBER 17 THREE-YEAR-OLD MAIDEN PLATE - 1100 Metres

LAKEHURST (R. Hurdle) – near the 700 metres when making the turn, hung out, taking JESTER PUPPET wider and continued to hang out for the remainder of the event. Approaching the 100 metres was obliged to be steadied as JESTER PUPPET shifted in when racing greenly. A post-race veterinary examination revealed the gelding to be lame in the near foreleg and had a lower than expected heart rate. Co-trainer, Mr G. Richards, was advised a Veterinary Certificate of Fitness is required prior to a future trial or race.

RACE 2: TWILIGHT RACES AT MORPHETTVILLE - FRIDAY DECEMBER 17 THREE-YEAR-OLD MAIDEN PLATE - 1100 Metres (cont'd)

APOLLO GIRL (C. Lions) - slightly slow to begin.

JESTER PUPPET (B. Vorster) – approaching the 100 metres when racing greenly, shifted in onto LAKEHURST which, when hanging out, was obliged to be steadied. Rider was reprimanded under AR131(a) and advised to take greater care in future. A post-race veterinary examination revealed the mare to be lame in the off the hind leg. Trainer, Mr B. Cozamanias, was advised a Veterinary Certificate of Fitness is required prior to a future trial or race.

SPEED LOVER (A. Kelly) – a post-race veterinary examination revealed post-race colic, heat stress related.

SQUEAKY GATE (T. Pannell) - raced keenly during the event.

STARLITE REBEL (B. Price) - near the 700 metres raced in restricted room to the inside of SQUEAKY GATE and as a consequence raced ungenerously for a number of strides.

RACE 3: TERRY HOWE PRINTING HANDICAP - 1200 Metres

KAYSERI (NZ) (B. Price) - raced wide without cover throughout the event. Rider explained in relation to the gelding's performance that it travelled well despite racing wide and when placed under pressure failed to let down as he had expected and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

LADY DUNMORE (G. Lo) - raced keenly during the event.

LOVE MAGIC (T. Voorham) - Laid in under pressure in the straight.

TULLYS GOLD (W. Price) - laid in under pressure in the straight.

LUCY DIAMONDS (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

HUNTLEY LADY (K. Crowther) – slow to begin. Over-raced during the event. Hung out rounding the home turn and for a short distance at the entrance to the straight. On Sunday 28 November 2021, Trainer Mr. D. Jolly advised Stewards on return to his stable the mare had jarred up. HUNTLEY LADY will now be given a short let up.

TONY'S REWARD (J. Potter) - hung out rounding the home turn.

RACE 4: DOONY'S DASH HANDICAP - 1100 Metres

DEEP DIVE (B. Price) - laid out under pressure in the straight. Rider explained in relation to the gelding's performance that his instructions were to lead or settle in the first four. He added that the gelding found the lead and travelled well during the event and that DEEP DIVE laid out from rounding the home turn until the finish. He further explained that DEEP DIVE, being first up in today's event, would derive benefit from its run.

MUM'S MY HERO (G. Lo) – rider explained in relation to the gelding's performance that it felt uncomfortable in its action and never travelled throughout the event. A post-race veterinary examination revealed the mare to be lame in the off the fore leg. Trainer, Mr C. Curtis, was advised a Veterinary Certificate of Fitness is required prior to a future trial or race.

BOLT I AM (A. Chung) - slow to begin.

ATOMIC LOKADE (P. Gatt) - slow to begin. Hung out rounding the home turn. A post-race veterinary examination revealed the mare to have thumps.

ZOULAH (K. Crowther) - raced keenly during the event.

RACE 5: THE PHOENIX HANDICAP - 1600 Metres

HYPERCANE (A. Kelly) – when questioned in relation to the tactics on the gelding in today's event, co-trainer, Mr R. Jolly, explained that he advised the rider to encourage the gelding out of the barriers. He added that he was surprised to see HYPERCANE lead in today's event, however there appeared to be an average tempo on paper. Rider reported she obtained the lead without much effort after beginning well.

ECHO BOOMER (T. Pannell) - a post-race veterinary examination revealed a lower than expected heart rate.

SHOCK ALERT (K. Zechner) - Raced keenly during the event.

RENALOT (D. Caboche) - dipped on jumping away. Raced keenly during the event.

KALAMON (J. Toeroek) - contacted a perimeter fence on exiting the mounting yard and was examined on arrival at the barriers and passed fit to start. Jumped away awkwardly and contacted ARTFUL LIBBY.

RAPID RAISER (J. Holder) - held up for clear running from shortly after the entrance to the straight until passing the 200 metres.

GETOUTTHEWAY (R. Hurdle) – over-raced during the event. Had difficulty obtaining clear ground from near the 200 metres until the 100 metres when laying in and racing between SHOCK ALERT and MOSCOW MULE.

ARTFUL LIBBY (B. Vorster) - jumped away awkwardly, shifted out and contacted KALAMON. Raced wide without cover from the 1000 metres.

RACE 6: GRAND SYNDICATES - RACE WITH TEAM GRAND HANDICAP - 2500 Metres

EXALTED AMBITION (J. Holder) - laid in under pressure in the straight.

SASUN (B. Price) - rider reported that the gelding was not suited to today's firm track conditions.

OURKHANI (A. Kelly) - laid in under pressure in the straight.

AZZUREOUS (S. Metcalfe) - jumped away awkwardly, shifted in and brushed TURF MAN.

SKY HERO (K. Crowther) - hung out from rounding the home turn and in the straight. A post-race veterinary examination revealed no visible abnormalities.

TURF MAN (J. Maund) - on jumping away was brushed by AZZUREOUS.

KNEE SLAPPER (A. Chung) - raced wide without cover throughout the event.

RACE 7: THE GIRLS ARE TURNING 40 HANDICAP - 1800 Metres

SWISS HERO (W. Price) - laid out under pressure in the straight.

COMFORT GIRL (J. Holder) - hung out rounding the home turn.

VICTORY BANDIT (E. Boyd) - over-raced during the event and got its head up when being restrained.

APPLIED (J. Eaton) - rider reported that the gelding hung out during the event and failed to stretch out due to the firm track conditions. Slow to begin. Hung out under pressure in the straight and was difficult for the rider to ride out in her normal manner.

RISING THUNDER (C. Lions) - shortly after the start, attempted to buck and as a result rider became unbalanced for a number of strides. Trainer, Mr G. Young, was advised that a warning had been placed on the gelding in relation to its racing manners.

RACE 8: ROADSIDE SERVICES CITY OF MARION STAKES - 1200 Metres

FREE OF DEBT (G. Lo) – laid out under pressure in the straight. A post-race veterinary examination revealed bilateral hind quarter soreness. Trainer, Mr. C. Bieg, was advised that at Veterinary Certificate of Fitness was required prior to accepting for a future trial or race.

FAROOQ (A. Chung) – held up for clear running from approaching the 100 metres and was untested to the line. Approaching the finish when attempting a tight run between PARSIFAL (NZ) and DIAMONDS, which laid in slightly, appeared to clip the heel of DIAMONDS and dipped. Rider was reprimanded under AR131(a) and advised to ensure he attempts runs with sufficient room in future.

OPEN MINDED (NZ) (K. Zechner) - near the 100 metres was inconvenienced as OUTLAWS REVENGE shifted out.

SECOND SLIP (NZ) (T. Pannell) – over-raced during the event. Held up for clear running from the 400 metres until the 300 metres.

MAGNA BELLA (P. Gatt) - trainer, Mr A. Clarken, advised Stewards, prior to the event, that he would instruct the rider to attempt to settle further back due to the wide barrier draw. Settled back.

EXTRA TIME (T. Voorham) - held up for clear running from the 100 meters and was untested to the line.

TRIP (S. Logan) – rider explained in relation to the mare's performance that it did not appreciate being pressured in the lead in today's event, was under pressure from the 600 metres and failed to let down. A post-race veterinary examination revealed no visible abnormalities. On Sunday 28 November 2021, Trainer Mr. D. Jolly advised Stewards on return to his stable the mare had jarred up. TRIP will now be given a short let up.

OUTLAWS REVENGE (D. Tourneur) – shortly after the start, bucked for a number of strides, lost ground and as a result the rider became unbalanced. Trainer, Mr R. Balfour was advised a warning had been placed on the gelding in relation to its racing manners. Over raced in the middle stages. Hung out under pressure in the straight and inside the 100 meters shifted out into the running of OPEN MINDED (NZ) which was inconvenienced. Rider was reprimanded under AR131(a) and advised to make a greater effort when his mounts are shifting ground in future.

ANOTHER AWARD (J. Holder) - jumped away awkwardly and was a result was slow to begin. Held up for a number of strides near the 300 metres.

RACE 9: VALE POLLY HALL HANDICAP - 1050 Metres

HELLO LADIES (S. Cahill) – rider explained in relation to the gelding's performance that it travelled well during the event, however he was mindful of how the track conditions in relation to its firmness and appeared to be favouring horses on the rail. He added, he was unable to attempt to allow his mount to improve along the rail due to the positioning of a number of other runners and therefore he elected to shift out and allow HELLO LADIES to attempt to run on. A post-race veterinary examination revealed no visible abnormalities.

MYSTICANO (S. Logan) - on jumping away bumped with MOON AND BACK which was taken out and shortly after had its hind quarters turned out by MOON AND BACK.

BETTA EDDIE (G. Lo) - raced wide without cover throughout the event. Rider pleaded guilty to a charge under AR209(1) for failing to the carry correct weight being 0.5 kg under his declared weight and was fined \$200.

SIDEARM (T. Pannell) - had difficulty obtaining clear ground from near the 400 metres until approaching the 100 metres when racing between FALLOW and MOON AND BACK which was hanging out. When questioned in relation to his riding of the gelding in the straight, rider explained that his instructions were to allow the gelding to travel into the race as long as possible as in the stables opinion SIDEARM is better ridden conservatively with one sprint. He added that he complied with the instructions and when he asked the gelding to let down near the 200 metres he was disappointed with its response and that it was unable to finish the event off strongly considering how well it travelled during the race. Trainer Mr W Clarken confirmed the instructions.

RACE 9: VALE POLLY HALL HANDICAP - 1050 Metres (cont'd)

PARISIENNE MONDE (K. Crowther) - held up for a short distance shortly after the entrance to the straight.

STORM VOYAGER (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

MOON AND BACK (W. Price) - on jumping away was hampered and bumped with LOPE DE WOLF, was taken out and bumped with MYSTICANO on a number of occasions. Raced fiercely during the event. Hung out under pressure in the straight.

GOODGEE (A. Jordsjo) - rider reported that the mare did not feel comfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

LOPE DE WOLF (B. Vorster) - jumped away awkwardly, shifted out and bumped MOON AND BACK.
