RACE 1: A & G WILSON EARTHMOVERS THREE-YEARS-OLD & OVER MAIDEN PLATE - 1215 Metres

HILL ROAD RAIDER (E. Wong) - laid in from the 400 metres until approaching the finish.

GREY FOLLY (M. Collett) - laid in under pressure in the straight.

PADSTOW POLLY (A. Lindsay) - contacted and inconvenienced at the start when VEGAS DESTINY (NZ) jumped away awkwardly and shifted out.

SUGGESTIVE MISS (S. Callow) - fractious in the barrier. Underwent a pre-race veterinary examination behind the barrier and passed fit to race. Mr S. Theodore representing Trainer, Mr T. Doudle, was advised that a warning had been placed on the filly in relation to its barrier manners.

NISKIE LATANIE (K. Sardelic) - inconvenienced at the start and lost ground when PADSTOW POLLY was taken out.

VEGAS DESTINY (NZ) (J. Huxtable) - jumped away awkwardly and shifted out at the start.



RACE 2: AURORA OZONE HOTEL RATING 0-54 HANDICAP - 1215 Metres

BIGNOTA (D. Caboche) - slow to begin. Rider reported that he had concerns with the geldings action throughout the event and that it did not stretch out. A post-race veterinary examination revealed no visible abnormalities.

SAND CAT (C. Murray) - laid in under pressure over the concluding stages of the event, resulting in its rider being obliged to stop riding and straighten in an attempt to correct his mount approaching the 50 metres.

THE LADIES MAN (S. Callow) - laid in under pressure over the concluding stages of the event and could not be fully tested by its rider to the finish.

TROUBLED TIMES (M. Collett) - close to the winning post was bumped by GOLDEN RIPPLES, which shifted in under pressure.

MIGHTY MOSHE (K. Sardelic) - raced erratically over the final 200 metres and inside the 100 metres had to be steadied away from the heels of THE LADIES MAN, which laid in under pressure.

ROSE SAUVAGE (M. Vassallo) - tailed out. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Trainer, Mr T. Day, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

GOLDEN RIPPLES (E. Wong) – stood awkwardly in the gates and turned its head as the start was effected resulting in the mare losing ground. Stewards spoke to the rider in relation to the mare shifting in under pressure over the concluding stages of the event, which resulted in him being awkwardly placed on the heels of SAND CAT and making contact with TROUBLED TIMES approaching the winning post. Stewards advised the rider that in these circumstances he would be expected to stop riding and straighten his mount sooner than he did on this occasion.

RACE 3: TAB BENCHMARK 62 HANDICAP - 1215 Metres

I'M KENNY (A. Lindsay) - passing the 750 metres was taken wider by KYASHI.

KYASHI (C. Murray) - weakened it the straight. Rider reported that his mount jumped a patch of the track near the 750 metres and shifted out abruptly taking I'M KENNY wider. He added that the gelding was inclined to lay in under pressure in the straight placing him at some disadvantage riding his mount out to the finish. A post-race veterinary examination revealed no visible abnormalities.

DAVEEDO (M. Vassallo) - laid in under pressure in the straight.

RACE 4: ELDERS RURAL SERVICE BENCHMARK 58 HANDICAP - 1050 Metres

RODNEY (J. Huxtable) - jumped away awkwardly resulting in its rider becoming unbalanced. Rider reported that the gelding may have come to the end of his preparation and raced like a tired horse. A post-race veterinary examination revealed no visible abnormalities.

ROCK HARD (K. Sardelic) - approaching the 900 metres was inconvenienced when tightened for room between JUSTA JILLAROO, which shifted in and DAZZLING HARMONY, which was taken out by SMARTKAP. Passing the 850 metres became unbalanced when bumped on the hind quarters by DAZZLING HARMONY, which was taken out and had to be steadied away from the heels of FARSTAR. Approaching the 100 metres had to be steadied and was obliged to alter course to the outside of the heels of RODNEY, which commenced to weaken.

SMARTKAP (S. Callow) - passing the 900 metres had to be steadied away from the heels of FARSTAR, which commenced to hang out from that point.

JUSTA JILLAROO (C. Murray) - passing the 850 metres became unbalanced when bumped on the hind quarters by ROCK HARD.

DAZZLING HARMONY (E. Wong) - passing the 850 metres had to be steadied away from the heels of FARSTAR, which hung out from that point and in turn made contact with the hind quarters of ROCK HARD.

RACE 4: ELDERS RURAL SERVICE BENCHMARK 58 HANDICAP - 1050 Metres (cont'd)

ARACHNATTACK (M. Vassallo) - jumped a patch of the track near the 750 metres and became unbalanced.

FARSTAR (S. Metcalfe) – jumped away awkwardly. Commenced to hang out rounding the first turn near the 900 metres. Rider reported that the gelding continued to hang out from this point and that she had no control for the remainder of the race. Trainer, Mr K. Healy, was advised the gelding must perform to the Stewards' satisfaction in an Official Barrier Trial prior to a future race start.

RACE 5: KANGAROO ISLAND SPIRITS BENCHMARK 58 HANDICAP - 1360 Metres

RIKIBOBBY (A. Lindsay) - raced wide throughout the event.

TONY'S REWARD (S. Metcalfe) – passing the 400 metres had to steadied when racing in restricted room to the inside of MOSS THE BOSS.

OUR DEXTER (M. Collett) - raced wide throughout the event.

SMART STYLE (D. Caboche) - slow to begin.

RACE 6: DUDLEY WINES KANGAROO ISLAND CUP - 1880 Metres

SPLASH SOME CASH (J. Huxtable) – hampered on jumping away when EL DESPERADO was taken out. Rider pleaded guilty to a charge under AR131(c) in that he made a celebratory gesture on the gelding prior to the winning post and a short distance after the winning post rider was dislodged resulting in STEALTHY LUCAS, HE EKSCELS (NZ), REX GOLIATH, AUSSIE SOJOURN, EL DESPERADO and YESUGEI (NZ) all having to take evasive action to avoid the fallen rider and was suspended from riding in races for a period to commence at midnight Saturday, 19 February 2022 and to conclude midnight Saturday, 12 March 2022, a period of 3 weeks. In determining penalty, Stewards took into account J. Huxtable's good record in relation to this rule, his guilty plea and contrition during the inquiry. J. Huxtable was examined by First Care Medical staff post the event and was declared fit to fulfil his remaining engagement.

STEALTHY LUCAS (S. Callow) - raced wide throughout the event.

MONTEPULCIANO (C. Murray) - jumped away awkwardly and ran out at the start. Passing the 700 metres was hampered by REX GOLIATH.

HE EKSCELS (NZ) (J. Doyle) - raced without throughout the event.

REX GOLIATH (S. Metcalfe) - shifted out at the 450 metres and hampered MONTEPULCIANO. Laid in under pressure over the concluding stages of the event.

AUSSIE SOJOURN (D. Caboche) - shifted in under pressure over the concluding stages of the event.

EL DESPERADO (K. Sardelic) - hampered on jumping away when MONTEPULCIANO shifted out.

RACE 7: SEALINK BENCHMARK 58 HANDICAP - 1750 Metres

SHAME SHAME (J. Huxtable) - on jumping away was bumped the hind quarters of NOT ALONE.

NOT ALONE (E. Wong) - tightened on jumping away between SHAME SHAME and RUGER ROSE.



RACE 7: SEALINK BENCHMARK 58 HANDICAP - 1750 Metres (cont'd)

RUN ON (NZ) (S. Callow) – rider reported that she was not happy with her mounts action and that it was under pressure from the 600 metres and did not respond to her riding. A post-race veterinary examination revealed the gelding to have atrial fibrillation. Trainer, Ms. P. Trenwith, was advised the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

SPY COLONEL (D. Caboche) - bumped on jumping away. Bumped again and taken wider rounding the turn out of the straight near the 1500 metres by EARL OF SANDWICH, which made the turn out of the straight awkwardly and ran wide. At the 1400 metres was obliged to race wide for some distance when EARL OF SANDWICH shifted out throughout the middle stages. A post-race veterinary examination revealed no visible abnormalities.

EARL OF SANDWICH (J. Doyle) - made the turn out of the straight awkwardly and took SPY COLONEL wider on the track.

YULONG AWESOME (S. Metcalfe) – bumped on jumping away. On the turn out of the straight was taken wider when SPY COLONEL was taken out.

CYBER INTERVENTION (C. Murray) - rider reported that his mount choked down and for this reason was under pressure from the 700 metres and did not finish the race off. A post-race veterinary examination revealed a laceration to the near hind leg.

IT'S MAGIC (A. Lindsay) - jumped away awkwardly and lost ground. Passing the 600 metres had to be steadied when CYBER INTERVENTION commenced to weaken from that point.

RUGER ROSE (K. Sardelic) - jumped away awkwardly and shifted in. Laid in under pressure in the straight.

MISS ELEGANCE (M. Collett) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by M. Collett and noted that she used it on seven occasions over the final 100 metres of the event. Rider also pleaded guilty to a breach of AR132(a)(i) for using the whip in consecutive strides before the 100 metres and was reprimanded.
