RACE 1: FURPHY HANDICAP - 1600 Metres

ANGASTON (A. Chung) – near the 800 metres, when racing behind NOT USUAL GLORIOUS, was brushed by TRADEWIND, which shifted in, in an attempt to obtain cover behind NOT USUAL GLORIOUS and as a consequence, was taken in slightly inside the heels of NOT USUAL GLORIOUS. Shortly thereafter, inside the 800 metres TRADEWIND continued to shift in slightly in an attempt to restrain and settle with cover behind NOT USUAL GLORIOUS and in doing so, contacted the hindquarters of ANGASTON, which was turned, resulting in that horse becoming unbalanced. A post-race veterinary examination revealed no visible abnormalities.

TRADEWIND (W. Price) - near the 800 metres shifted in, in an attempt to obtain cover behind NOT USUAL GLORIOUS, and in doing so, initially brushed with ANGASTON, which was taken in and thereafter, made contact with the hindquarters of ANGASTON, resulting in that horse becoming unbalanced. Rider was severely reprimanded and advised to only shift ground when entitled to do so.

RACE 2: ADELAIDE RACING CARNIVAL - APRIL 30TH -MAY 21ST MAIDEN PLATE - 1100 Metres

CLASSY KENNY (J. Maund) – awkward to begin. Rider pleaded guilty to a charge under AR131(b) for failing to ride his mount out to the end of the race. In determining penalty, Stewards took into account his guilty plea, his record and other factors and in the circumstances J. Maund was fined \$200. Rider reported that the gelding was wayward in the run.

LORD LUKER (IRE) (T. Pannell) - slow to begin.

ALPINE BEAU (E. Finnegan) – awkward and slow to begin and thereafter was slow to muster early speed. Approaching the 200 metres, when attempting a run to the outside of SET TO ROCK was momentarily steadied owing to the position of A FEW GOOD MEN to its outside and thereafter had difficulty in obtaining a full clear run to the outside of SET TO ROCK and was only able to be fully tested from approaching the 100 metres. Raced a little greenly in the straight.



RACE 2: ADELAIDE RACING CARNIVAL - APRIL 30TH -MAY 21ST MAIDEN PLATE - 1100 Metres (Cont'd)

COURAGEOUS HEARTS (T. Voorham) - knuckled on jumping away.

GUN FOR HIRE (B. Price) - Trainer Mr B. Bogarts was advised a warning had been placed on the gelding in relation to its pre-race manners. A post-race veterinary examination revealed no visible abnormalities.

JAAZEB (L. Neindorf) – tightened at the start between YEAH YEAH NAH, which shifted out and SET TO ROCK, which shifted in.

WARRANDYTE ROAD (A. Chung) - rider reported the gelding hung out rounding the home turn.

SET TO ROCK (W. Price) - shifted in at the start and tightened JAAZEB.

YEAH YEAH NAH (R. Hurdle) - Difficult to load, Trainer Mr D. Carrison was advised a warning had been placed on the gelding in relation to it being difficult to load. Shifted out at the start and tightened JAAZEB.

EXTREMELY DISCREET (K. Crowther) – contacted at the start by SHEZ BETTY, which shifted in. Raced very ungenerously in the early stages. Inclined to lay out rounding the home turn. Raced greenly in the straight.

SHEZ BETTY (J. Opperman) – awkward to begin, shifted in and contacted EXTREMELY DISCREET. Laid in throughout in the straight.

RACE 3: ZILZIE WINES HANDICAP - 1200 Metres

MANHATTEN TIMES (T. Voorham) - laid in, in the straight.

ANGEL LIKE (B. Price) - a post-race veterinary examination revealed no visible abnormalities.


CHARM SLINGA (NZ) (B. Vorster) – approaching the 150 metres, when attempting to improve into a tight run between SHARWIN and SAMESYN, was disappointed and had to be steadied when taken in by SAMESYN, which was inclined to lay in and shifted in. Thereafter when inside the 100 metres, when again attempting to improve between SHARWIN and SAMESYN, was disappointed and had to be checked when awkward inside the heels of SAMESYN, which laid in and shifted in.

SAMESYN (A. Chung) - was inclined to lay in from inside the 200 metres and near the 150 metres shifted in and inconvenienced CHARM SLINGA (NZ). Rider took corrective action and straightened his mount and thereafter, near the 100 metres laid in and shifted in sharply onto CHARM SLINGA (NZ), which had to be checked - rider took corrective action to straighten his mount as a consequence.

RACE 4: WESLO SECURITY HANDICAP - 1600 Metres

ANTARCTIC OCEAN (NZ) (A. Chung) – near the 200 metres laid out under pressure and shifted out and inconvenienced NAKHEEL, which had to be momentarily steadied. Rider was reprimanded and advised to take greater care when his mounts commence to shift ground. Rider was also reminded to not use his whip in a manner that raises his arm above shoulder height.

LAKE'S FOLLY (M. Lloyd) - became held up near the 200 metres and was obliged to shift to the outside of LOPE DE WOLF and THE MAP to obtain clear running.



RACE 4: WESLO SECURITY HANDICAP - 1600 Metres (Cont'd)

APPLIED (T. Hope) – Over the concluding stages had to be steadied away from the heels of BRIABELLA, which laid in and shifted in.

NAKHEEL (K. Crowther) – near the 200 metres was inconvenienced by ANTARCTIC OCEAN (NZ), which shifted out and had to be momentarily steadied.

BRIABELLA (M. Collett) – raced erratically in the early stages and was inclined to lay in and thereafter laid in, in the straight and shifted in over the concluding stages and hampered APPLIED. Rider was reprimanded and advised to take greater care when her mounts commence to shift ground.

RACE 5: LORD REIMS STAKES - 2600 Metres

EPERDUMENT (J. Eaton) – awkward to begin, shifted out and contacted CANFORD. Shortly after passing the winning post on the first occasion, shifted out and made slight contact with CANFORD, which was taken out onto SO BENE, resulting in SO BENE being momentarily inconvenienced. Held up for clear running from near the 400 metres until near the 300 metres.

HASTA LA WAR (T. Voorham) – a late scratching by order of Stewards at 8.25 am acting on confirmed advice from Trainer S. Murphy that the gelding had injured its near fore tendon.

CANFORD (W. Price) – contacted at the start. Shortly after passing the winning post on the first occasion was contacted by EPERDUMENT, which shifted out, and shifted out onto SO BENE, which was inconvenienced.

HE EKSCELS (NZ) (E. Finnegan) - raced wide without cover throughout the event.

WERTHEIMER (NZ) (T. Pannell) – rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by T. Pannell and noted that he used it on one occasion over the concluding 100 metres of the event.

GEORGE HERCULES (K. Crowther) - raced keenly in the early stages of the event. Approaching the crossing near the 1800 metres became awkward inside the heels of SANTELMO FUEGO for a short distance. Thereafter raced keenly for some distance.

SO BENE (J. Benbow) - shortly after passing the winning post on the first occasion was momentarily inconvenienced by CANFORD, which shifted out after being contacted by EPERDUMENT.

RACE 6: GRAND SYNDICATES - 5% SHARES JUST \$1,100 HANDICAP - 1100 Metres

SHAMINO (K. Crowther) – near the 800 metres shifted out and inconvenienced PORT VALE, which had to be momentarily steadied. Rider was reminded of her obligations when shifting ground. Had difficulty obtaining clear running from near the entrance to the straight for a short distance and was obliged to shift to the outside of GINGER JONES to improve its position.

ECUMENICAL (J. Eaton) – near the 200 metres rolled out and away from SHAMINO, which improved to its inside and brushed with PORT VALE.

GREAT LEVELLER (A. Chung) - awkward to begin, shifted in and contacted EXTRA MILE.



EXTRA MILE (B. Vorster) - contacted at the start. From near the 150 metres became held up for clear running behind GREAT LEVELLER and GINGER JONES and as a consequence was untested to the finish.

RACE 6: GRAND SYNDICATES - 5% SHARES JUST \$1,100 HANDICAP - 1100 Metres (Cont'd)

WINNING WEATHER (T. Voorham) – held up for clear running from near the 400 metres until near the 150 metres where it was obliged to shift to the inside of GREAT LEVELLER to obtain clear running.

HIDDEN LEGEND (B. Price) – got its near hind leg up in its barrier stall after being loaded, was removed and examined by the Veterinary Surgeon who reported the gelding was lame in the near hind leg. HIDDEN LEGEND was a late scratching by order of Stewards at 3.28 pm acting on veterinary advice. Trainer, Mr W. Clarken, was advised that a Veterinary Certificate of Fitness was required prior to a future trial. Mr Clarken was advised in view of the gelding's barrier manners the gelding would be required to prove tractable in an Official Barrier Trial prior to accepting for a future race.

PORT VALE (O. Ridge) – near the 800 metres had to be momentarily steadied when awkward on the heels of SHAMINO, which shifted out. Near the 200 metres was brushed by ECUMENICAL, which shifted out and away from SHAMINO, which rolled out. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by O. Ridge and noted that he used it on six occasions over the concluding 100 metres of the event.

RACE 7: THOMAS FARMS SUPPORTING SAROA HANDICAP - 1200 Metres

TONGSAI BOSS (T. Hope) - underwent a pre-race veterinary examination as it had not raced since December 2019 and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

JAPERY (A. Chung) – awkward to begin. Inside the 300 metres rolled out and hampered COOL MAGNUM, which had to be momentarily steadied. Rider reprimanded and advised to take greater care when his mounts commence to shift ground. Rider reported the gelding felt sore in the near hind leg during the event. A post-race veterinary examination revealed no visible abnormalities.

SPIN THE REWARD (R. Hurdle) - rider reported his saddle slipped forward near the 1000 metres, placing him at a disadvantage for the remainder of the event.

MOTELL (B. Vorster) - awkward to begin.

COOL MAGNUM (J. Maund) - inside the 300 metres was tightened between SPIN THE REWARD and JAPERY, which rolled out, was hampered and had to be momentarily steadied.

CAFE RIZU (W. Price) - got its head up when being restrained shortly after the start.

RACE 8: TAB ADELAIDE CUP DAY - MONDAY MARCH 14 HANDICAP - 1800 Metres

HEIR OF TAVISTOCK (NZ) (J. Opperman) – Shifted in approaching the 1600 metres to obtain a forward position near the rail, and in doing so inconvenienced SANBLAS and FIZIQUE. Rider was reminded of his obligations when shifting ground.

SANBLAS (C. Rawiller) – inconvenienced approaching the 1600 metres by HEIR OF TAVISTOCK (NZ), which shifted in. Held up for clear running from inside the 500 metres until near the entrance to the straight. Near the 300 metres rolled out and inconvenienced STAN THE CADDY.

YURI ROYALE (A. Chung) - a post-race veterinary examination revealed no visible abnormalities.

STAN THE CADDY (K. Crowther) - near the 300 metres, when weakening, was momentarily inconvenienced by SANBLAS, which rolled out.



RACE 8: TAB ADELAIDE CUP DAY - MONDAY MARCH 14 HANDICAP - 1800 Metres (Cont'd)

HARLEYMOVEN (T. Pannell) - raced wide without cover throughout the event.

FIZIQUE (W. Price) – inconvenienced approaching the 1600 metres, when racing behind SANBLAS, which was inconvenienced by HEIR OF TAVISTOCK (NZ), which shifted in.

RACE 9: THE JUNCTION HANDICAP - 1050 Metres

HEYINGTON STATION (C. Rawiller) - laid out severely in the straight.

PEGASI (M. Lloyd) - had to be momentarily steadied near the 100 metres when inconvenienced by ZARACE, which shifted in and away from CALL ME CURTIS, as that horse was taken in by COLLIVER.

CALL ME CURTIS (T. Voorham) - inside the 300 metres, when improving between COLLIVER and ZARACE, was obliged to be steadied for several strides when COLLIVER laid in and shifted in. Thereafter near the 100 metres was again momentarily inconvenienced and take in by COLLIVER, which laid in and shifted in.

COLLIVER (D. Caboche) - inside the 300 metres laid in, shifted in and inconvenienced CALL ME CURTIS. Thereafter near the 100 metres laid in again and shifted in taking CALL ME CURTUS inwards.

RIZSKI (J. Eaton) - held up for clear running from inside the 500 metres until approaching the 100 metres.

ZARACE (A. Jordsjo) - near the 100 metres was taken in by CALL ME CURTIS onto PEGASI.

TURF TAPPER (L. Neindorf) – disappointed for clear running inside the 300 metres when attempting to improve between ZARACE and DASKULYA and shifted out shortly thereafter, attempted a run between ZARACE and COLLIVER but was disappointed for that run, as CALL ME CURTIS claimed the run and was unable to be tested until approaching near the 100 metres.

JUSTAKIDD (R. Hurdle) - stood flat-footed and was slow to begin and thereafter was slow to muster early speed.
