Racing SA Ltd Stipendiary Stewards' Report

TRACK: Good 4 (Track with some give in it)

RAIL: Out 3 metres 1200m to winning post, true remainder.

WEATHER: Overcast

RACE 1: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1200 Metres

MAC 'N' CHEESE (B. Vorster) – slow into stride. Held up for clear running from near the entrance to the straight until near the 200 metres, where it was obliged to shift to the inside of JUSTAKIDD to obtain clear running.

JAAZEB (W. Price) - raced keenly for a short distance near the 800 metres.

KNIGHTSTOWN (R. Hurdle) - raced keenly in the early stages of the event.

JUSTAKIDD (T. Pannell) - inclined to lay out in the straight.

SOMEWATT FABULOUS (J. Toeroek) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: THOMAS FARMS CINDERELLA STAKES - 1050 Metres

SEE YOU IN HEAVEN (J. Toeroek) - awkward to begin, shifted in and contacted RUNAWAY BELLE.

BISTRO (J. Kah) - following the declaration of acceptances, Trainer, Ms P. Trenwith, acting on behalf of Trainers, Messrs A. & S. Freedman, made a gear application to add a tongue tie to the filly's race gear. Stewards acceded to this request and acting under AR206(2) fined Messrs A. & S. Freedman \$200.

ARABIAN MELODY (J. Allen) - raced greenly in the straight and was inclined to lay in. A post-race veterinary examination revealed no visible abnormalities.

RUNAWAY BELLE (B. Allen) - contacted at the start.



RACE 3: G.H. MUMM HANDICAP - 1600 Metres

ANGASTON (A. Chung) – rider returned to scale 1.1 kg below the weight he was required to carry in the event. Stewards were able to establish that a lead bag which the rider had weighed out with had not been included during saddling and Stewards were able to locate it at the stall where the gelding had been saddled. Trainer, Mr J. O'Connor was charged under AR209(2)(b), the particulars of the charge being that when saddling ANGASTON for this event, he omitted to include the lead bag which A. Chung weighed out with, resulting in A. Chung weighing in 1.1 kg under the weight at which he weighed out at. Mr J. O'Connor pleaded guilty and was fined \$500. In arriving at penalty Stewards took into account his guilty plea and clean record. As a result, ANGASTON which was placed eighth was disqualified from the event under AR209(2)(a). A post-race veterinary examination revealed no visible abnormalities.

HEIR OF TAVISTOCK (NZ) (J. Opperman) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by J. Opperman and noted that he used it on eight occasions over the final 100 metres of the event.

RACE 4: WINNING EDGE PRESENTATIONS HANDICAP - 1050 Metres

GREAT LEVELLER (A. Chung) - knuckled at the start. Approaching the 100 metres shifted out under pressure and tightened WINNING WEATHER onto HEYINGTON STATION, resulting in WINNING WEATHER having to be steadied and making contact with HEYINGTON STATION, which became awkward inside the heels of HIDDEN LEGEND for several strides. Rider pleaded guilty to a charge of careless riding under AR131(a) for allowing his mount to shift out when insufficiently clear and was suspended from riding in races for a period to commence midnight Sunday, 20 March 2022 and to conclude midnight Saturday, 27 March 2022, a period of 3 meetings. In determining penalty, Stewards took into account A. Chung's guilty plea, previous record and forthrightness at the inquiry.

MR MARATHON MAN (GB) (J. Opperman) - raced keenly in the early stages of the event. Held up for clear running from near the entrance to the straight until near the 200 metres.

OKAY TO PAY (M. Lloyd) - jumped away awkwardly, shifted out and hampered ARKHAM KNIGHT.

ARKHAM KNIGHT (D. Oliver) - was tightened and hampered at the start by OKAY TO PAY, which shifted out.

HIDDEN LEGEND (B. Melham) - laid in, in the straight.

HEYINGTON STATION (C. Rawiller) – proved difficult to load. Trainer, Mr W. Clarken was advised that a warning had been placed on the gelding in relation to its pre-race behaviour. Raced very keenly in the early stages of the event and near the 700 metres when being restrained shifted to the outside of GREAT LEVELLER and in doing so, hampered GREAT DIVINER. A post-race veterinary examination revealed no visible abnormalities.

PARIANO (A. Kelly) - held up for clear running from near the entrance to the straight until inside the 300 metres.

WINNING WEATHER (P. Gatt) - approaching the 100 metres was tightened onto HEYINGTON STATION by GREAT LEVELLER which shifted out

GREAT DIVINER (T. Pannell) - lost its near fore plate during the event. Hampered near the 700 metres when HEYINGTON STATION shifted out, and as a consequence had to be steadied and contacted HEYINGTON STATION.

RACE 5: C S HAYES MEMORIAL CUP - 1600 Metres

FAROOQ (D. Lane) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$400. In determining penalty Stewards had regard for the totality of the use of the whip by D. Lane and noted that he used it on eleven occasions over the final 100 metres of the event; however, Stewards also considered his most recent record and overall record in respect of whip breaches.

ECUMENICAL (J Eaton) - raced wide without cover during the early and middle stages of the event.

SPLASH SOME CASH (S. Logan) - raced keenly in the early and middle stages of the event.

RACE 6: TERRY HOWE PRINTING MATRICE STAKES - 1200 Metres

SECOND SLIP (NZ) (T. Pannell) - laid out in the straight.

EXTRA MILE (J. Toeroek) - contacted at the start.

VIEIRA (S. Metcalfe) - raced keenly in the early and middle stages of the event.

HEARTY LASS (W. Price) - reared at the start, very awkward and slow to begin.

POINT BLAZE (K. Crowther) - awkward to begin, shifted out and contacted EXTRA MILE. Inclined to lay out rounding the home turn and shortly after straightening became disappointed for clear running between SANSOM (NZ) and SECOND SLIP (NZ) and was obliged to shift to the outside of SANSOM (NZ) to obtain clear running and thereafter continued to lay out for the remainder of the event.

MANHATTEN TIMES (J. Eaton) - awkward and slow to begin. Inclined to lay in, in the early part of the straight.

RACE 7: TAB ADELAIDE CUP - 3200 Metres

All runners in this event underwent a pre-race veterinary examination and were passed fit to start.

SKELM (M. Poy) - contacted at the start. Lost it's near fore plate during the event. Near the entrance to the straight was contacted by DAQIANSWEET JUNIOR (NZ), which shifted out to improve, had its hindquarters turned and was taken a little wider on the track.

AURORA'S SYMPHONY (D. Oliver) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by D. Oliver and noted that he used it on three occasions over the final 100 metres of the event.

FUTURE SCORE (IRE) (D. Bates) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by D. Bates and noted that he used it on four occasions over the final 100 metres of the event.

GOOD IDEA (B. Thompson) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by B. Thompson and noted that he used it on four occasions over the final 100 metres of the event.

DAQIANSWEET JUNIOR (NZ) (J. Kah) - near the entrance to the straight, shifted out to improve and contacted the hind quarters of SKELM, which was taken a little wider on the track.

EPERDUMENT (J. Eaton) - jumped away awkwardly, shifted out and contacted SKELM.

JEKYLL'N'HYDE (M. Dee) - reared at the start and was awkward to begin.

SANTELMO FUEGO (S. Logan) - a post-race veterinary examination revealed that the gelding had a poor post-race recovery and exhibited signs of heat stress.

BUSKER'S BALLAD (B. Vorster) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by B. Vorster and noted that he used it on three occasions over the final 100 metres of the event.



RACE 8: MORPHETTVILLE GUINEAS - 1600 Metres

MAX FIRE (P. Gatt) - raced keenly in the early stages of the event.

STRIKE EAGLE (J. Allen) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr T. McEvoy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

WATER INTO WINE (B. Vorster) - shortly after the entrance to the straight was obliged to shift to the inside of CHARM SLINGA (NZ) to improve its position. After the winning post had to be restrained to avoid jockey, B. Melham, who was dislodged from his mount, as a consequence the gelding shifted out abruptly, unbalancing B. Vorster who was dislodged. B. Vorster was examined by the First Care Medical personnel and was cleared of injury.

SET THE SAILS (B. Melham) – after passing the winning post, the colt stumbled and dislodged its rider. B. Melham was attended to by the First Care Medical personnel and transported to hospital for further assessment and observation. A post-race veterinary examination revealed no visible abnormalities.

HARLEYMOVEN (R. Hurdle) - shifted out at the start and contacted TUPOLEU. Laid out under pressure in the straight.

CHARM SLINGA (NZ) (W. Price) - inside the 350 metres was disappointed for clear running when attempting a run between STRIKE EAGLE and ALPINE BEAU and was unable to improve its position for several strides and was then obliged to shift to the outside of ALPINE BEAU to improve its position.

BENZ BARON (E. Finnegan) - shortly after the winning post had to be checked to avoid SET THE SAILS, which stumbled and dislodged its rider, B. Melham.

TUPOLEU (O. Ridge) - shifted in at the start and contacted HARLEYMOVEN.

RACE 9: GRAND SYNDICATES HANDICAP - 1200 Metres

KEEP ON BOPPING (T. Pannell) - inside the 200 metres shifted out abruptly of its own accord and became awkward inside the heels of HILLS, which was inclined to lay in and shifted in.

YOUNG JIMMY (B. Price) - a post-race veterinary examination revealed the gelding to be exhibiting signs of heat stress. First aid administered.

CALL ME CURTIS (T. Voorham) - slow to begin. Rider reported that it was her intention to settle further forward in today's event; however, the gelding missed the start and she was obliged to settle further back than intended.

LIBRATE (K. Crowther) - which had not raced since February 2021 underwent a pre-race veterinary examination and was declared fit to start. A post-race veterinary examination revealed the mare to be lame in the off hind leg.
