RACE 1: THOMAS FARMS HANDICAP - 1100 Metres

FIZZY BUBBLY (NZ) (T. Voorham) - inconvenienced when contacted on jumping away,

SEATTLE GRACE (J. Holder) - hung out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

BONNIE GANGSTER (J. Potter) - slow to begin.

MORE REWARD (S. Logan) - jumped away awkwardly, shifted out and contacted FIZZY BUBBLY (NZ). Raced keenly in the early and middle stages of the event. Shifted out at the entrance to the straight to improve and in doing so, took LOOKS LIKE A LADY slightly wider.

LOOKS LIKE A LADY (L. Neindorf) - raced keenly in the early and middle stages of the event. Taken slightly wider at the entrance to the straight by MORE REWARD.

Correct weight was delayed to allow L. Neindorf (LOOKS LIKE A LADY), placed fourth and Co-Trainer Mr G. Richards, to view the vision in the straight. After viewing the vision. L. Neindorf lodged an objection against S. Logan (MORE REWARD), placed third alleging interference rounding the home turn and entrance to the straight. After considering the evidence, viewing the official vision and acting on their own observations Stewards *dismissed* the objection.

RACE 2: G.H. MUMM MAIDEN PLATE - 1100 Metres

The event was delayed approximately two minutes.



RACE 2: G.H. MUMM MAIDEN PLATE - 1100 Metres (Cont'd)

COURAGEOUS HEARTS (J. Holder) - laid in under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Co-Trainer, Mr L. Macdonald, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

LUCKY BLUE (J. Potter) - inconvenienced on jumping away when contacted by KATINA JOY. Rider accidentally dropped his whip at the entrance to the straight.

SIR ARMINIUS (J. Opperman) - raced keenly in the early and middle stages of the event.

THROWAPARTY (E. Wong) - dipped shortly after the start, shifted out abruptly onto BONNIESIX, which was hampered.

BONNIESIX (S. Logan) - hampered on jumping away when THROWAPARTY shifted out. Raced greenly in the straight. A post-race veterinary examination revealed no visible abnormalities.

BORN TO RUN (NZ) (R. Hurdle) - raced keenly in the early and middle stages of the event.

EXALTED DAME (E. Boyd) – slow to begin. Rider explained that after being slow to begin she had encouraged the mare however, it was unable to maintain contact with the field. She added after straightening, EXALTED DAME responded to her riding and despite it being green, commenced to improve into the race. She stated that after improving onto the heels of THROWAPARTY near the 200m she had some difficulty in obtaining clear ground to the finish. Rider was of the opinion that the mare would benefit from the race experience and may be better suited in a race over a greater distance.

KATINA JOY (B. Price) - shifted out on jumping away onto LUCKY BLUE. Near the 500m shifted out and away from MADDISON MISS onto the hindquarters of COURAGEOUS HEARTS, became awkward in its action and lost ground.

MADDISON MISS (C. Jones) - near the 500m shifted out slightly to improve onto KATINA JOY, which shifted out slightly onto the hindquarters of COURAGEOUS HEARTS.

RICHANA (P. Gatt) - raced keenly in the early and middle stages of the event.

RACE 3: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1600 Metres

UNLACED (NZ) (J. Eaton) - lost its near hind plate during the event.

FRANCE'S BOY (L. McNeil) - lost its near hind plate during the event.

ROBE BAY (P. Gatt) - refused to load. Acting on this advice, Stewards declared the mare a late scratching at 1.01 pm Trainer Mr P. Hardacre was advised that ROBE BAY would be required to load without delay in two consecutive trails prior to accepting for a future race.

MAGICAL RIDE (D. Caboche) - a post-race veterinary examination revealed a slower than normal recovery.

DEELBRAKA (S. Fawke) - raced keenly in the early and middle stages of the event.

SAWTELL (NZ) (S. Logan) - underwent a pre-race veterinary examination and was deemed suitable to race. Near the 500m was racing in restricted room to the inside of MAGICAL RIDE, shifted in slightly, brushed the running rail, over-reacted and lost ground.

SCOUT'S HONOUR (J. Benbow) - jumped away awkwardly.

RACE 4: SPRING RACING CARNIVAL AT MORPHETTVILLE - OCT. 8TH - NOV 5TH HANDICAP - 1050 Metres

The race was delayed by approximately three minutes to avoid a clash with an interstate event.

GREAT DIVINER (L. Neindorf) - inconvenienced on jumping away. Near the 500 metres became unbalanced and was taken wider when contacted by HOWL



RACE 4: SPRING RACING CARNIVAL AT MORPHETTVILLE - OCT. 8TH - NOV 5TH HANDICAP - 1050 Metres (Cont'd)

HOWL (P. Gatt) - raced keenly in the early and middle stages of the event. Near the 500m shifted out to improve and in doing so, contacted GREAT DIVINER, which was unbalanced and taken wider. Rider was reminded of his obligations when shifting ground.

KONG (J. Holder) - held up from the entrance of the straight until inside the 200m.

MCCAIN (T. Pannell) - held up from the 500m until near the 100m.

SANBUCK (R. Hurdle) - shifted in on jumping away onto GREAT DIVINER. A post-race veterinary examination revealed no visible abnormalities.

ANGEL LIKE (K. Crowther) - a post-race veterinary examination revealed a slow recovery.

RACE 5: THE JUNCTION HANDICAP - 1200 Metres

The race was delayed by approximately two minutes to avoid a clash with an interstate event.

CLASSY BANNER (L. Neindorf) - shifted out on jumping away onto HANSOM MAN.

DEEVINE (P. Gatt) - lost its near fore plate during the event. Had difficulty obtaining clear ground from the entrance to the straight and was obliged to alter course near the 200m to obtain clear ground.

VIEIRA (J. Benbow) - laid in under pressure in the straight. A post-race veterinary examination revealed the gelding to be exhibiting sign of mild thumps.

CHICAGO STORM (T. Pannell) – rider explained that the gelding had never travelled and as a result, he was required to place it under pressure much earlier than he had hoped. He added that after being placed under pressure, CHICAGO STORM had not responded, had raced flat to the finish and was disappointing. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Trainer, Mr D. Aldridge, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

SHORT STORIES (E. Boyd) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

HANSOM MAN (J. Maund) - hampered on jumping away and lost its position when tightened onto DEEVINE by CLASSY BANNER. Raced keenly in the early and middle stages. Laid in under pressure in the straight.

RACE 6: MURRAY HUGHES/HERO WIND HANDICAP - 2000 Metres

JAGUARY (NZ) (L. McNeil) - a post-race veterinary examination revealed no visible abnormalities.

DUKE OF PLUMPTON (NZ) (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

PERFECT ILLUSION (GB) (J. Toeroek) – rider reported the gelding felt short in its action when pulling up. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Co-Trainer, Mr R. Jolly, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

ICHIBANSAN (J. Holder) - Raced keenly in the early and middle stages.

DIXIE WHISTLER (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

BEAR ARMS (E. Boyd) - stood flat-footed and was slow to begin. Laid in under pressure in the straight.

JOPHIEL (NZ) (S. Metcalfe) - was cautioned in relation to using her whip with an action that raises her arm above shoulder height in accordance with AR132(6)(b).

RACE 7: GRAND SYNDICATES SPRING STAKES - 1200 Metres

BEHEMOTH (P. Gatt) – jumped away awkwardly and shortly after got its head back striking the face of P. Gatt and as a result, was slow into stride. At the entrance to the straight shifted out onto VENUSIAN, which was forced to take hold. On pulling up P. Gatt was examined by the First Care Medical Personnel and ruled unfit to fulfil his remaining engagements. As a result, the inquiry into this incident was adjourned to a date to be fixed. A post-race veterinary examination revealed no visible abnormalities.

OUTLAWS REVENGE (J. Benbow) - a post-race veterinary examination revealed no visible abnormalities.

PINDARIC (J. Eaton) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

EXTREME THRILL (C. Rawiller) - had difficulty obtaining clear ground near the 200m until inside the 100m. Rider was cautioned in relation to using his whip with an action that raises his arm above shoulder height in accordance with AR132(6)(b).

SPARKUP (J. Toeroek) - at the entrance to the straight was inconvenienced when contacted by AGREEABLE.

VENUSIAN (S. Metcalfe) - at the entrance to the straight was forced to take hold to avoid the heels of BEHEMOTH, which shifted out.

AGREEABLE (T. Pannell) - at the entrance to the straight was hampered when tightened onto SPARKUP by VENUSIAN, which had been taken out.

KENYAN WONDER (C. Jones) - raced keenly in the early and middle stages of the event. Obliged to alter course near the 300m to obtain clear ground. Lost both fore plates during the event.

RACE 8: FURPHY HANDICAP - 1600 Metres

MOSCOW RED (NZ) (L. McNeil) - slow to begin. Had difficulty obtaining clear ground from near the 400m until inside the 200m.

YANACOCHA (J. Potter) - near the 1500m shifted in when insufficiently clear of STADIUM OF LIGHT (NZ), forcing its rider to take hold and lose her position. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 14 August 2022 and to conclude at midnight on Sunday, 21 August 2022: a period of three meetings.. A post-race veterinary examination revealed no visible abnormalities.

MONRAAJ (S. Fawke) – lost its near hind plate in the mounting yard. Re-plated by Farrier. Underwent a pre-race veterinary examination and was deemed suitable to race. Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

MUFFLA (J. Toeroek) - slow to begin.

STADIUM OF LIGHT (NZ) (J. Eaton) - raced keenly in the early and middle stages of the event.

ZIGGI ROCKS (R. Hurdle) - raced keenly in the early and middle stages of the event.

TURFITT (L. Neindorf) - laid out under pressure over the concluding 150m.

TEA RAV (NZ) (B. Price) - a post-race veterinary examination revealed the mare to be lame in both hind legs. Trainer, Mr S. Gower, was advised that a Veterinary Clearance was required prior to a future jump out, trial or race start.

CANIDAE (D. Caboche) -jumped away awkwardly.



RACE 9: THE FOTOBASE GROUP HANDICAP - 1100 Metres

TOORAK WARRIOR (T. Pannell) - laid out under pressure in the straight.

HELLO LADIES (J. Opperman) - a late scratching by order of Stewards at 1.26pm due to track downgrade.

GLACIUS (L. McNeil) - shifted out on jumping away and contacted KUNGKA MARU. A post-race veterinary examination revealed no visible abnormalities.

LOAD AND GO (C. Rawiller) - hampered shortly after the start when TEXAN WINDSTORM shifted in.

SO YOU CAN (T. Voorham) - hampered shortly after the start when tightened onto MISS MUCINNI by KUNGKA MARU.

POCKET ROX (S. Vella) - shifted in on jumping away and contacted ULTIMATE VICTORY. Near the 200m shifted out onto MISS MUCINNI.

ULTIMATE VICTORY (J. Toeroek) - inconvenienced on jumping away and contacted by POCKET ROX. A post-race veterinary examination revealed no visible abnormalities.

SAVILLE (R. Hurdle) - lost off fore plate in the mounting yard. Re-plated by Farrier. Underwent a pre-race veterinary examination and was deemed suitable to race.

BUBBLE OVER (L. Neindorf) - raced keenly in the early and middle stages of the event. Momentarily held up at the entrance to the straight and was obliged to alter course in the vicinity of the 300m to obtain clear ground.

MISS MUCINNI (K. Crowther) - raced keenly in the early and middle stages of the event. Near the 200m had to momentarily steady when POCKET ROX shifted out. A post-race veterinary examination revealed no visible abnormalities.

KUNGKA MARU (D. Caboche) - contacted on jumping away. Shortly after shifted out and away from GLACIUS onto SO YOU CAN.

RODNEY (S. Logan) - jumped away awkwardly.

TEXAN WINDSTORM (J. Benbow) - shifted in shortly after the start onto LOAD AND GO. Raced keenly in the early and middle stages of the event.

RACE 4: COOPERS BREWERY BENCHMARK 62 HANDICAP - 2200 Metres

PRINCE JOFRA (L. Neindorf) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 m and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip by L. Neindorf and noted that he used it twice over the concluding 100 m of the event.

AMMO LOCO (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 m and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by S. Fawke and noted that he used it on ten occasions over the concluding 100 m of the event.
