#### RACE 1: SCHWEPPES HANDICAP - 1050 metres

**POMP** (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

RED FIRE LADY (R. Hurdle) - jumped away awkwardly.

**BIG EFFORT** (P. Gatt) – hung out from the vicinity of the 600 metres until the entrance to the straight.

### RACE 2: HOLDFAST INSURANCE HANDICAP - 1600 metres

**METIER** (D. Dunn) – raced wide without cover throughout the event. In the vicinity of the 1100 metres had to momentarily steady off the heels of MAIL IT IN. A post-race veterinary examination revealed signs of mild colic post-race.

**BATTLE BREWING** (C. Lindop) - jumped away awkwardly and shifted in bumping METRO COWBOY. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**MAIL IT IN** (J. Holder) – shifted in onto METIER in the vicinity of the 1100 metres. Rider reminded of his obligations when shifting ground in, in future. Stepped a section of the track in the vicinity of the 600 metres for no apparent reason.

PACO EXPRESS (J. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

**METRO COWBOY** (J. Kah) – contacted on jumping away.

**DASHEBO** (R. Hurdle) – had to be steadied off the heels of SOARING HIGH in the vicinity of the 1100 metres as the pace slackened.

#### RACE 3: UBET ADELAIDE CUP 14 MARCH HANDICAP - 1200 metres

**BRIMARVI PRINCE** (J. Toeroek) – had difficulty obtaining clear running in the straight and in the vicinity of the 100 metres was obliged to alter course to the outside of CHARLES IN CHARGE to obtain clear ground.

**MISS ADELE** (J. Holder) – was under pressure and did not travel throughout the event. A post-race veterinary examination revealed a higher than expected heart rate and mild heat stress.

#### RACE 3: UBET ADELAIDE CUP 14 MARCH HANDICAP - 1200 metres (Cont'd)

CHARLES IN CHARGE (D. Moor) - jumped away awkwardly.

#### RACE 4: PROJECTION GRAPHICS HANDICAP - 1600 metres

RIVER'S LANE (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**FLYING CASINO** (J. Holder) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**SEE WHAT I BRING** (J. Bowditch) – raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**QUICKSILVER LASS** (C. Lindop) - raced keenly in the early and middle stages of the event.

ALERTNESS (T. Zanker) - slow to begin.

#### RACE 5: UBET CINDERELLA STAKES - 1050 metres

**SHE'S POSTIVE** (J. Noonan) – inconvenienced on a number of occasions in the early and middle stages by GOGO GRACE, which was inclined to lay out.

**LA RENARDE** (T. Sadler) – taken out near the 400 metres by TOKELAU. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300. A post-race veterinary examination revealed significant heat stress. First aid administered.

**BANGS** (J. Toeroek) – lost position on jumping away when tightened between TOKELAU and GETEMHEL (NZ). Taken out at the 400 metres onto GETEMHEL (NZ) by SHE'S POSITIVE.

**TOKELAU** (D. Moor) – jumped away awkwardly and shifted out onto BANGS. Shifted out at the 400 metres onto SHE'S POSITIVE. Rider reminded of obligations. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

**NEAPOLITAN (NZ)** (M. Neilson) – dislodged M. Neilson en route to the barriers and galloped riderless for a short distance prior to being recaptured. Underwent a pre-race veterinary examination and ruled unfit to race. Acting on veterinary advice Stewards withdrew the filly at 3.29 pm. Warning issued. M. Neilson was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagement.

**GETEMHEL (NZ)** (D. Tourneur) – shifted in on jumping away onto BANGS. Inconvenienced near the 400 metres and taken wider by BANGS. A post-race veterinary examination revealed no visible abnormalities.

**GOGO GRACE** (C. Lindop) – inclined to lay out in the early and middle stages of the event inconveniencing SHE'S POSITIVE on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

MASKA (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

## RACE 6: MITTY'S HANDICAP - 1800 metres

PROUD EAGLE (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**ACID FLO** (H. Coffey) – raced keenly in the early and middle stages of the event.

SWINGING SOLDIER (J. Toeroek) - raced keenly in the early and middle stages of the event.

## RACE 6: MITTY'S HANDICAP - 1800 metres (Cont'd)

**WATCH THE WOLF** (C, Lindop) – inconvenienced near the 800 metres when taken wider by ACID FLO and again near the 600 metres and 400 metres when taken wider by SWINGING SOLDIER. A post-race veterinary examination revealed no visible abnormalities.

**SHADOWS ABOVE** (P. Gatt) – lost its near fore plate during the event.

## RACE 7: JAMES BOAG'S PREMIUM LORD REIMS STAKES - 2600 metres

**SIGNOFF (IRE)** (H. Coffey) – shifted out and away from GO DREAMING near the 400 metres onto DISTILLATION, which had to be steadied momentarily when tightened onto TUNES.

**DISTILLATION** (T. Sadler) – had to momentarily steady near the 400 metres when tightened between SIGNOFF (IRE) and TUNES.

**GO DEAMING** (J. Potter) – hung out making the home turn. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**STIMULATTE** (J. Bowditch) – shifted out and away from DISTILLATION near the 600 metres onto ROBOCOP.

**TUNES** (D. Moor) – rolled in slightly near the 600 metres onto ROBOCOP.

**CELTIC PRINCE (NZ)** (J. Toeroek) – lost its off hind plate during the event.

**ROBOCOP** (R. Hurdle) – raced wide without cover throughout the event. Hampered and lost its position near the 600 metres when tightened between STIMULATTE, which shifted out and TUNES, which rolled in slightly.

## RACE 8: MAC DRINK DRIVING? GROW UP HANDICAP - 1200 metres

**EL PRADO GOLD** (D. Caboche) – raced keenly in the early and middle stages of the event.

**LEIA** - underwent a pre-race veterinary examination on arrival on course which revealed the mare to be lame in the near hind leg. Acting on veterinary advice Stewards withdrew LEIA at 3.06 pm.

**PETROV** (T. Sadler) – accidentally dropped his near side reign in the vicinity of the 200 metres.

**SEE ME ROLLIN'** (J. Potter) – forced to take hold in the vicinity of the 600 metres to avoid the heels of EXALTED JOURNEY. A post-race veterinary examination revealed significant heat stress. First aid administered.

**EXALTED JOURNEY** (E. Finnegan) – shifted in when insufficiently clear near the 600 metres onto SEE ME ROLLIN', which was forced to take hold. Rider pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Monday, 14 March and to conclude at midnight on Saturday, 19 March 2016; a period of three (3) meetings.

**CLAIR** (J. Holder) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.
