### RACE 1 : HOLDFAST INSURANCE / SABOIS MAIDEN PLATE - 1400 metres

**CENTURIUS** (D. Tourneur) - jumped away awkwardly and shifted in.

**ZOLOTOI** (S. Cahill) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. Lost its near hind plate during the event.

**BERRY BABY** (K. Brooks) – inconvenienced in the vicinity of the 400 metres when FIRSTEE shifted out slightly. Rider reported the mare made excess respiratory noise on pulling up. A post-race veterinary examination revealed excess upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness required prior to trial or race.

CHAMPAGNE FLOWERS (D. Caboche) - jumped away awkwardly.

**MINTINI** (T. Pannell) – lost its near hind plate during the event.

**ALSHIMA** (P. Gatt) – hampered on jumping away when taken out and tightened onto SEATTLE FLIGHT by NOIR CHEVAL. A post-race veterinary examination revealed no visible abnormalities.

**FIRSTEE** (D. Tourneur) - jumped away awkwardly and shifted out onto NOIR CHEVAL. Shifted out slightly in the vicinity of the 400 metres onto BERRY BABY. Rider reminded of obligations when shifting out in future. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

**NOIR CHEVAL** (W. Kerford) – inconvenienced on jumping away and taken out onto ALSHIMA.

**SEATTLE FLIGHT** (E. Finnegan) – hampered on jumping away. Raced wide without cover throughout the event.

# RACE 2 : SCHWEPPES BENCHMARK 64 HANDICAP - 1550 metres

**GENEROUS BEAU** (D. Caboche) – contacted on jumping away.

**JEST FOR THE ROAD** (C. Jones) - jumped away awkwardly and shifted out contacting GENEROUS BEAU. Raced keenly in the early and middle stages of the event.

# RACE 2 : SCHWEPPES BENCHMARK 64 HANDICAP - 1550 metres (Cont'd)

**RAIN ATTACK** (Z. Spain) – rider reported the gelding was inclined to hang out throughout the event and he had become concerned with its action over the concluding stages. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**MAGGIE'S CALL** (A. Doyle) - slow to begin. Lost its off hind plate during the event.

# RACE 3 : PROJECTION GRAPHICS CLASS TWO HANDICAP - 1550 metres

**MODEL DRAGON** (D. Tourneur) – stood flat-footed and was slow to begin. In the vicinity of the 1100 metres improved onto the heels of YEN and had to be restrained.

**YEN** (C. Lindop) – approaching the 600 metres improved onto the heels of OCTOMINT and had to be restrained. A post-race veterinary examination revealed no visible abnormalities.

# RACE 4 : JAMES BOAG'S PREMIUM / SABOIS FILLES & MARES BENCHMARK 70 HANDICAP - 1250 metres

**AMPLE ON OFFA** (E. Finnegan) - jumped away awkwardly and shifted in contacting HOT GOSSIP. Raced wide without cover throughout the event. Stewards questioned E. Finnegan in relation to her instructions for today's event. She explained she had been instructed to obtain cover as she had at the mares most recent start, however, on that occasion she had been unable to do so and elected to push forward. She added given the speed of today's event it was her intention to be able to sit in behind TYCOON QUEEN and INFINITY QUEEN on jumping and settled on pace with cover, however, due to how the mare began she was unable to do so as SCRUM had improved to her inside quickly to take up a position to her inside. She further added from that point she felt it would be detrimental to her mount to push forward given the speed and considered restraining her mount would also not be in the mare's best interest and for this reason elected to sit three wide without cover as her mount was travelling comfortably. Mr C. Bieg confirmed the instructions provided to E. Finnegan were to be on pace with cover.

**INFINITY QUEEN** (D. Caboche) – had difficulty in obtain clear ground from the entrance to the straight until in the vicinity of the 50 metres.

**ZIPNOTIZED** (J. Kah) – became held up in the vicinity of the 200 metres until inside the 100 metres. Lost near fore plate during the event.

**DEANNA JEAN** (J. Potter) – Shifted in inside the 1000 metres onto OUR PROSPECT. Inclined to lay out under pressure in the straight. Rider was found guilty of a charge of Careless Riding under AR137(a) in that he had shifted in when insufficiently clear of OUR PROSPECT and was suspended from riding in races for a period to commence at midnight on Wednesday, 25 May 2016 and to conclude at midnight on Sunday, 5 June 2016; a period of five (5) meetings. Lost its off hind plate during the event.

**HOT GOSSIP** (Z. Spain) – obliged to be checked inside the 1000 metres off the heels of OUR PROSPECT, which had been taken in by DEANNA JEAN. Held up from the vicinity of the 600 metres until near the 200 metres and had difficulty in obtaining clear ground over the concluding stages.

**OUR PROSPECT** (C. Lindop) - taken in onto HOT GOSSIP and then had to be steadied inside the 1000 metres when DEANNA JEAN shifted in.

### RACE 5 : ADELAIDE GALVANISING CLASS TWO HANDICAP - 1000 metres

**CONCENTRATE** (Z. Spain) - wide without cover throughout the event.

**CESTOS** (S. Cahill) - jumped away awkwardly and shifted out onto SILENT SNIPER. Held up from the entrance to the straight until the vicinity of the 100 metres.

**RAHEEBA** (J. Toeroek) - a post-race veterinary examination after returning to scale revealed blood in its mouth from a minor laceration to the tongue.

# RACE 5 : ADELAIDE GALVANISING CLASS TWO HANDICAP - 1000 metres (Cont'd)

**RITZY DANE** (K. Brooks) – improved onto the heels of DOWNS AFTER DARK in the vicinity of the 500 metres and had to be steadied for a number of strides.

RIGHT HERE (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

**KIM'S INTUITION** (E. Finnegan) – slow into stride. Held up form the entrance to the straight until approaching the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

SILENT SNIPER (J. Kah) – tightened onto BRIMARVI EQUIADA on jumping away.

### RACE 6 : QUAYCLEAN BENCHMARK 60 HANDICAP - 1400 metres

**COMPLETE CLASS** (C. Lindop) - jumped away awkwardly.

**DAZZLING LILLY** (J. Cartwright) – lost its off fore plate during the event. Rider reported he was concerned with the mare's action in the straight. A post-race veterinary examination revealed the mare to be lame in the off foreleg. In the opinion of the Veterinary Surgeon, the lameness was due to the lost shoe.

**GREEN HORNET (NZ)** (E. Finnegan) – held up form the vicinity of the 500 metres until approaching the 200 metres. Difficulty in obtaining clear ground for the remainder of the race. A post-race veterinary examination revealed no visible abnormalities.

WHERE'S THAT (A. Doyle) - raced wide without cover throughout the event.

### RACE 7 : MEDALLION HOMES BENCHMARK 60 HANDICAP - 1250 metres

**SOVEREIGN DUKE** (Z. Spain) - jumped away awkwardly and shifted in bumping ALREIDY LEICA. A post-race veterinary examination revealed a poor recovery.

**CARDINAL MISSION** (D. Caboche) – tightened onto SOCIAL MEDIA shortly after the start by CHONDRA and forced to race in restricted room between these two runners for a number of strides. A post-race veterinary examination revealed no visible abnormalities.

**ASTRO VITA** (C. Lindop) – obliged to be steadied shortly after the start when SOCIAL MEDIA was taken in at the same time as SOVEREIGN DUKE had rolled out slightly.

**PATCH HERO** (J. Kah) – bumped at the start.

**SERBIAN CROWN** (T. Pannell) - jumped away awkwardly.

**SOCIAL MEDIA** (D. Tourneur) - jumped away awkwardly, contacted by CARDINAL MISSION shortly after the start which had been taken in by CHONDRA. Raced keenly in the early and middle stages of the event.

**CHONDRA** (P. Gatt) – shifted in shortly after the start onto CARDINAL MISSION. Rider reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**ALREADY LEICA** (C. Jones) – taken in on jumping away and hampered when tightened onto PATCH HERO.
