### RACE 1 : ADELAIDE GALVANISING HANDICAP - 2400 metres

**RICH RIVER** (J. Cartwright) – rider explained the gelding had travelled well in the early and middle stages, however, when placed under pressure at the entrance to the straight it failed to respond to his riding and in his opinion may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

WHAT'S IN A NAME (R. Hurdle) – raced keenly in the early and middle stages of the event.

**RIVER'S LANE** (D. Caboche) – raced keenly in the early stages of the event.

**GALLATIN** (D. Tourneur) – had to momentarily steady in the vicinity of the 600 metres when racing in restricted room between SILENT MAN and RIVER'S LANE.

# RACE 2 : HOLDFAST INSURANCE HANDICAP - 1000 metres

**HEARTZ ABLAZE** (J. Toeroek) – shifted out on jumping away.

**SHACKED UP** (D. Tourneur) – rider explained the filly had only travelled fairly in the early stages and when placed under pressure at the entrance to the straight failed to respond to his riding and weakened from the event. A post-race veterinary examination revealed an elevated heart rate and abnormal upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race

**MYSTICANO** (J. Maund) - slow to begin and shortly after was hampered by HEARTZ ABLAZE. Raced keenly in the early and middle stages of the event.

**LAUVASSA** (J. Holder) – rider reported the filly's action did not feel comfortable in the straight. A post-race veterinary examination revealed no visible abnormalities.

# RACE 3 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1400 metres

HOYLAKE (NZ) (J. Toeroek) - jumped away awkwardly.

# RACE 3 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1400 metres (cont'd)

**LADY SILHOUETTE** (A. Doyle) - jumped away awkwardly. Lost its off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

WHERE'S TIM (C. Lindop) - a post-race veterinary examination revealed no visible abnormalities.

**NO DOUBTFIRE** (D. Tourneur) - slow to begin.

**MONOPOLE** (J. Holder) - inclined to lay in under pressure in the straight.

## RACE 4 : SCHWEPPES HANDICAP - 1300 metres

**ALMADRAM** (W. Kerford) - slow to begin. Raced keenly in the early and middle stages of the event. Raced greenly throughout and made the turn in the vicinity of the 900 metres awkwardly and shifted out abruptly.

**FAST** 'N' **ROLLING** (M. Neilson) – made the turn in the vicinity of the 900 metres awkwardly and shifted out onto TAHNEE TIARA.

**WAGING WAR** (C. Lindop) - jumped away awkwardly and was slow to begin. Raced keenly in the early and middle stages of the event.

**SOMETHING MORE** (J. Holder) – contacted on jumping away.

**TAHNEE TIARA** (J. Kah) - jumped away awkwardly and shifted out onto SOMETHING MORE. Inconvenienced in the vicinity of the 900 metres when taken wider by FAST 'N' ROLLING.

### RACE 5 : PROJECTION GRAPHICS HANDICAP - 1250 metres

**HOOK ME UP** (A. Doyle) - shifted in shortly after the start and clipped the heels of MUBAKKIR losing ground. Rider explained his instructions in this event were to lead and after clipping heels at the start and losing his position, he had elected to push forward in an attempt to comply with the instructions. Trainer, Mr J. Opperman confirmed the instructions were to lead. Stewards advised A. Doyle that he had been too single minded in complying with the instructions and after the interference on jumping away, he should have considered other available options throughout the event. Rider reported the gelding did not feel comfortable in its action in the straight and for that reason had elected to ease it from the event. A post-race veterinary examination revealed no visible abnormalities.

**MUBAKKIR** (D. Caboche) – held up from the vicinity of the 500 metres until the entrance to the straight where he attempted a tight run to the inside of DEBEERSONUS, which rolled out. Shortly after, raced in restricted room for a number of strides between BEST FORTUNE, which rolled out and DEBEERSONUS, which rolled in. In the vicinity of the 300 metres was taken in onto BEST FORTUNE when DEBEERSONUS rolled in slightly.

**DEBEERSONUS** (R. Hurdle) – rolled out rounding the home turn. Rolled back in its original position shortly after straightening onto MUBAKKIR, which was taken in onto BEST FORTUNE.

**BEST FORTUNE** (J. Kah) – laid out at the entrance to the straight and brushed MUBAKKIR. Had to take hold in the vicinity of the 300 metres when MUBAKKIR was taken in by DEBEERSONUS, which rolled in slightly.

# RACE 6 : UBET HANDICAP - 1550 metres

ALCOHOL (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

**CHESTNUT CHARLIE** (T. Pannell) – raced keenly in the early and middle stages of the event and was wide without cover throughout.

**ZEPRISE JOURNEY** (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

**STAR FORTUNE** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

## RACE 7 : CAMPOLINA STUD HANDICAP - 1000 metres

**CONSERVATORIUM** (D. Cabcoche) – inclined to lay out in the straight. Shifted in and away from TILDY LAD approaching the finish onto CLASSY JACK.

**SWINGING ARMS** (J. Cartwright) – unable to obtain clear ground from the vicinity of the 400 metres until near the 200 metres. Rider reported that after finding clear ground in the vicinity of the 200 metres became concerned with the gelding's action. A post-race veterinary examination revealed no visible abnormalities.

**HEART OF A LION** (M. Neilson) – shifted out on jumping away onto DOUBLE POCKETS. Contacted near the 200 metres by TILDY LAD and was inconvenienced. Laid in over the concluding stages onto TILDY LAD.

**DOUBLE POCKETS** (R. Hurdle) - slow to begin and shortly after was hampered and lost its position by HEART OF A LION, which shifted in.

**PLANET VOYAGE** (C. Lindop) – raced wide without cover throughout the event.

**LUCKY SYMBOL** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**TILDY LAD** (J. Maund) – shifted out approaching the 200 metres in an attempt to obtain clear ground and contacted the hindquarters of HEART OF A LION, turning that gelding in. Taken in approaching the finish by HEART OF A LION.

**CALIANCO** (J. Kah) - wide without cover throughout the event.

**CLASSY JACK** (J. Holder) – approaching the finish had to be steadied when CONSERVATORIUM shifted in and away from TILDY LAD.

Correct weight for this event was delayed to allow J. Maund (TILDY LAD) placed fourth to view the official footage. After doing so J. Maund lodged an objection against D. Caboche (CONSERVATORIUM) placed third, alleging interference in the straight. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.

# RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres

**GRAND ARMADA** (D. Tootell) – raced keenly in the early and middle stages of the event.

**MAGNUS KNIGHT** (D. Caboche) – raced wide without cover throughout the event. Contacted at the entrance to the straight and taken out by GOLDEN CENTURY.

**CON'S GOLD** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**SECRETMENSBUSINESS** (A. Doyle) – approaching the 400 metres improved onto the heels of OUR PROSPECT and had to be steadied.

**BURGUNDY BLAST** (J. Kah) – raced in restricted room for a short distance at the entrance to the straight when SULLIVAN BAY shifted out to improve.

**SOCIAL LANE** (T. Pannell) – raced in restricted room to the inside of CLAIR from the vicinity of the 800 metres and near the 600 metres contacted the running rail, was hampered and lost its positon when CLAIR was taken in slightly. Lost its action for a short distance in the vicinity of the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

**GOLDEN CENTURY** (J. Cartwright) – shifted out at the entrance to the straight contacting MAGNUS KNIGHT, which was taken out into the running line of OUR PROSPECT. Rider severely reprimanded.

**OUR PROSPECT** (C. Lindop) – raced wide without cover throughout the event. Had to steady at the entrance to the straight to avoid the heels of MAGNUS KNIGHT, which had been taken out.

# RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres (Cont'd)

**CLAIR** (J. Holder) – raced in restricted room between RORY'S UNION and SOCIAL LANE from the 800 metres to the 600 metres.

**RORY'S UNION** (J. Maund) – raced in restricted room between GOLDEN CENTURY and CLAIR from the 800 metres to the 600 metres. Had difficulty in obtaining clear ground between the 400 metres and the 200 metres.
