**RACE 1 : M & J WILLIS AUSTRALIAN OPAL MINES HANDICAP - 1000 metres**

**BULLION WOLF** (Z. Spain) – a post-race veterinary examination revealed no visible abnormalities.

**RAMPAGE** (M. Neilson) – became held up for clear running for a short distance at the entrance to the straight and was obliged to alter course approaching the 200 metres to obtain clear running.

**NODOUBTABOUTIT** (K. Chiong) - a post-race veterinary examination revealed no visible abnormalities.

**LIFE'S REWARD** (J. Holder) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race. Trainer advised LIFE'S REWARD would now be spelled.

**WITH A BIT OF DASH** (T. Pannell) – contacted at the start, inconvenienced and taken wider near the 600 metres.

**VIENNA WALTZ** (D. Tourneur) - jumped away awkwardly, shifted out and contacted WITH A BIT OF DASH. Over-raced in the early stages and became awkward inside the heels of RATHER SILKY for a short distance near the 600 metres, rolled out and when being restrained shifted out and inconvenienced WITH A BIT OF DASH, which was taken wider.

**RACE 2 : VALENTIA @ CORNERSTONE STUD HANDICAP - 2400 metres**

**TRY FOUR** (J. Allen) – shortly after the entrance to the straight shifted out to improve and contacted BARGE AND CHARGE, which was taken wider.

**ALLEZ TARA** (E. Finnegan) – rider explained her instructions provided today were similar as at the gelding's last start which was to allow the gelding to settle mid-race and then sprint home. She added she was unable to allow the gelding to settle mid-race owing to being challenged by BARGE AND CHARGE and as a consequence ALLEZ TARA commenced to over-race mid-race. She further added from inside the 600 metres the gelding travelled well but when asked for an effort in the straight did not finish the race off in the same manner it did in its previous start and on trotting back after pulling up, she was of the opinion the gelding felt sore in both front legs. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 2 : VALENTIA @ CORNERSTONE STUD HANDICAP - 2400 metres (Cont'd)**

**HOYLAKE (NZ)** (M. Neilson) – rider explained his instructions were to settle off the pace as per the gelding's previous start but when asked for an effort near the 600 metres, HOYLAKE (NZ) was under pressure, commenced to weaken and was disappointing in its performance. A post-race veterinary examination revealed a lower than expected heart rate.

**BARGE AND CHARGE** (K. Chiong) – taken wider shortly after the entrance to the straight.

**KIWI COLLEEN (NZ)** (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

**SEARAVEN** (K. Bishop) - underwent a pre-race veterinary examination after arrival on course when the gelding injured itself in the float en route to the course, was found to have a small abrasion to its near hind leg and passed fit to race.

## **RACE 3 : DAKEN AND DAKEN REAL ESTATE HANDICAP - 1550 metres**

**GHUMBASHY (FR)** (D. Thornton) a post-race veterinary examination revealed the gelding to be lame in off hind leg. Veterinary Certificate of Fitness required prior to trial or race.

**SANDHILL WARRIOR** (M. Poon) – laid out under pressure in the straight.

**ROTHMOORE** (T. Pannell) – rider reported the gelding slipped on jumping away, and as a consequence he was obliged to settle further back than intended.

**INVIDIA** (E. Boyd) – rider reported the mare over-raced in the early stages of the event and commenced to hang out inside the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

## **RACE 4 : AKEED MOFEED @ GOLDIN FARMS HCP - 1250 metres**

**NICCOCO** (D. Thornton) – rider reported in his opinion the gelding may not have been suited by the underfoot track conditions. A post-race veterinary examination revealed no visible abnormalities.

**MAYBE THIS TIME** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**CRYSTAL MOMENT** (O. Ridge) – over-raced in the early stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

## **RACE 5 : GUARDIAN INSURANCE BROKERS HANDICAP - 1000 metres**

**PLANET VOYAGE** (K Bishop) - a post-race veterinary examination revealed no visible abnormalities.

**RISEN FROM DOUBT** (D. Thornton) - a post-race veterinary examination revealed no visible abnormalities.

**KUNGSLEDEN** (E. Boyd) – hung out in the straight. A post-race veterinary examination revealed no visible abnormalities.

**ARDERE** (K. Chiong) – hung out in the straight. Lost its off hind plate during the event.

## **RACE 6 : JOHN O'NEIL OAM HAPPY RETIREMENT HANDICAP – 1300 metres**

**EDGEWOOD** (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

**MISS JOOLIA** (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

## **RACE 6 : JOHN O'NEIL OAM HAPPY RETIREMENT HANDICAP – 1300 metres (Cont'd)**

**SEGREGATION** (D. Tourneur) - jumped away awkwardly, shifted out and contacted PEPPER THE PIN. Made the turn near the 1000 metres awkwardly. In the vicinity of the 600 metres raced ungenerously, became awkwardly placed inside the heels of KARLOVASI for a short distance and raced in restricted room.

**MURTI** (E. Finnegan) – the tongue tie fitted to the gelding had to be replaced at the barriers. Rider reported in her opinion the gelding chocked down in running. A post-race veterinary examination revealed a slow post-race recovery.

**PEPPER THE PIN** (C. Lindop) – contacted at the start and became unbalanced.

**TYRANNIZE (NZ)** (S. King) – inclined to lay out in the straight. Rider explained the gelding appeared field-shy during the event and did not let down over the concluding stages and only finished the race off fairly.

## **RACE 7 : UBET PENNY EDITION STAKES - 1400 metres**

**ULMANN** (J. Allen) - a post-race veterinary examination revealed no visible abnormalities.

**EXCITES ZELADY** (P. Gatt) – Trainer Mr C. Bieg advised Stewards of a change of tactics prior to the event in that he would instruct his rider to attempt to settle mid-field or worse than mid-field with cover.

**GAMBLIN' GURU** (J. Holder) – began awkwardly and was slow to begin losing one to two lengths. A post-race veterinary examination revealed no visible abnormalities.

**GRACIOUS PROSPECT** (M. Neilson) – reared at the start.

**RUNWAY STAR** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**CAVALOCE** (S. Cahill) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

## **RACE 8 : BETTER LOOSEN UP MEMORIAL HANDICAP - 1400 metres**

**BIG BOY BLEV** (D. Tourneur) – over-raced in the early stages of the event and approaching the 1000 metres became awkward on the heels of runners, shifted out and inconvenienced EMMOOKI'S STAR.

**OWL ON THE PROWL** (J. Frew) - rider reported in his opinion the gelding did not handle the track conditions. A post-race veterinary examination revealed no visible abnormalities.

**KRYPTONIAN** (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

**EMMOOKI'S STAR** (J. Kah) – inconvenienced approaching the 1000 metres.

**MAGNUS MAGIC** (J. Holder) – over-raced in the early stages of the event and raced ungenerously in the vicinity of the 1000 metres for a short distance.

**AUGUSTA BELLE** (D. Caboche) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

#### **RACE 5 : JOCKEY CELEBRATION DAY HANDICAP - 1100 metres**

Stewards today concluded an inquiry into the incident near the 800 metres where THE CASTLE KAT (R. Hurdle) was obliged to check to avoid the heels of TYCOON SOFIE (J. Holder). After taking evidence from both R. Hurdle and J. Holder, Stewards determined that whilst J. Holder shifted in when not sufficiently clear, the manner in which THE CASTLE KAT raced had contributed in part to the incident and consequently J. Holder was severely reprimanded and advised to take greater care when shifting ground in future.
