## THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

## Report on Race Meeting held at Balaklava Racecourse by the Balaklava Racing Club on Wednesday, 9 November 2016

### RACE 1: BALAKLAVA TRANSPORT MAIDEN PLATE - 1055 metres

Start of this event was delayed approximately three minutes.

**MINT WAY** (A. Jordsjo) – dislodged rider en route to the start. A. Jordsjo was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements. Fractious in its barrier when being loaded. Co-trainer, Mr G. Kent, was advised the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race. Inclined to lay out under pressure in the straight.

**JET EXPRESS** (T. Pannell) – slow to begin.

**REAL XANEY** (P. Roff) – jumped away awkwardly, shifted out and bumped SKALARM.

**RONDAFERRO** (L. Stojakovic) – inclined to hang out under pressure in the straight.

**TRUTH ABOUT LOVE** (J. Potter) – a post-race veterinary examination revealed no visible abnormalities.

**SHOW BENDER** (J. Bowditch) – fractious in the mounting yard and dislodged its rider. J. Bowditch was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements. Underwent a pre-race veterinary examination and passed fit to race. Had difficulty obtaining clear ground from inside the 400 metres until in the vicinity of the 200 metres.

**SKALARM** (P. Gatt) – bumped at the start as REAL XANEY jumped away awkwardly and shifted out.

#### RACE 2: MC CRACKEN FORD / SABOIS FILLIES & MARES MAIDEN PLATE - 1410 metres

This event was delayed by approximately two minutes.

**FEZ BAHH** (L. Stojakovic) – slow to begin. Inclined to race keenly in the early and middle stages of the event.

**KASMARLAINE** (D. Tourneur) – in the vicinity of the 900 metres whilst racing keenly and being restrained, was tightened onto AHECKSTAR by BEAUTIFUL VOICE, which was racing keenly and when being restrained shifted in slightly. As a result, KASMARLAINE appeared to clip the heels of BEAUTIFUL VOICE and became unbalanced for several strides.

**SAVANETA** (A. Jordsjo) – raced keenly in the early and middle stages of the event.

# RACE 2 : MC CRACKEN FORD / SABOIS FILLIES & MARES MAIDEN PLATE - 1410 metres (Cont'd)

**BEAUTIFUL VOICE** (B. Claridge) – in the vicinity of the 900 metres when racing keenly and being restrained off of the heels of WREAKED shifted in onto KASMARLAINE, which clipped the heels of that filly when tightened onto AHECKSTAR.

**KELOWNA (NZ)** (D. Thornton) — underwent a pre-race veterinary examination after becoming fractious in its barrier stall after being loaded and ruled unfit to race. Acting on this advice Stewards withdrew KELOWNA (NZ) at 1.14 pm. Mr C. McEvoy, stable representative for Mr T. McEvoy, was advised a warning had been placed on the filly in relation to its barrier manners.

**LANSON LASS (**P. Gatt) – a post-race veterinary examination revealed excess upper respiratory noise. Trainer, Mr M. Huxtable, was advised that the results of a laryngoscopic examination and Veterinary Certificate of Fitness were required prior to accepting for a future trial or race. Mr M. Huxtable advised Stewards that he would recommend to the owners that the filly be retired.

### RACE 3 : CLASSIC HITS 5CS & MAGIC 1059 / SABOIS C,G& E MAIDEN PLATE - 1410 metres

The start of this event was delayed by approximately one minute.

**AWKWARD SILENCE** (J. Potter) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr B. Bogarts, was advised that a warning had been placed on the gelding in relation to its racing manners.

**BALLONI** (J. Huxtable) – fractious in the mounting yard, dislodged its rider and contacted a perimeter fence. Acting on a request from co-trainer, Mr G. Kent, that the gelding, in his opinion, had lost its composure. Stewards withdrew BALLONI at 1.48 pm. Mr G. Kent was advised that a warning had been placed on the gelding in relation to its pre-race behaviour. J. Huxtable was examined by the First Care Medical Personnel and was passed fit to fulfil his remaining engagements.

**DON'T RETREAT** (J. Bowditch) – jumped away awkwardly, shifted out and bumped MANCHESTER. Inclined to race greenly in the straight.

**MANCHESTER** (T. Pannell) – bumped at the start as DON'T RETREAT jumped away awkwardly and shifted out. As a result, was tightened onto WANTED BY ALL.

#### RACE 4: MID NORTH PARTY HIRE C,G & E BM 56 HANDICAP - 1210 metres

**COMMISSAR** (J. Huxtable) – underwent a pre-race veterinary examination on arrival on course as it had not raced for over 12 months and was passed fit to start. Jumped away awkwardly.

**MOSTLY** (M. Poon) – co-trainer, Mr B. Hayes, advised Stewards that he would instruct apprentice M. Poon to attempt to settle further forward in this event. A post-race veterinary examination revealed the gelding had suffered a bi-lateral bleeding attack. Mr B. Hayes was advised as this was the gelding's second bleeding attack it was now ineligible to start in any race in Australia in accordance with AR53A(5). Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SOCIAL LANE** (E. Boyd) – inclined to lay in throughout the event.

**FORGOT MY SOCK** (Z. Spain) – underwent a pre-race veterinary examination on arrival on course and passed fit to race. Bumped at the start as LITTLE JAY JAY jumped away awkwardly and shifted out.

**LITTLE JAY JAY** (K. Bishop) – jumped away awkwardly and shifted out bumping FORGOT MY SOCK.

#### RACE 5: THE RIPPER ROAST RACE / KBL SECURITY CLASS TWO HANDICAP - 2210 metres

The start of this event was delayed by approximately two minutes.

# RACE 5 : THE RIPPER ROAST RACE / KBL SECURITY CLASS TWO HANDICAP - 2210 metres (Cont'd)

**ANURADHA** (P. Gatt) – inclined to lay out under pressure in the straight.

**FORTY LOVE** (E. Boyd) – required to be re-saddled at the start. Became fractious in its barrier stall after being loaded. Underwent a pre-race veterinary examination and passed fit to start. Raced keenly in the early stages of the event. Rider reported that the gelding did not feel comfortable in its action throughout the event and for this reason she elected not to ride the gelding out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

**PLUSHENKO** (C. Lindop) – Trainer Mr G. Young was fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards.

**HONOURABLE FRED** (J. Huxtable) – a post-race veterinary examination revealed no visible abnormalities.

## RACE 6: HYLAND RACE COLOURS / BRERETON JEWELLERS / SABOIS F&M BM 60 HANDICAP – 1410 metres

**SATURDAY MAGIC** (S. Price) – was held up for clear running between ZAAZOE and MISS COMMUNICATION from shortly after the entrance to the straight until in the vicinity of the 300 metres, when it shifted out when insufficiently clear of MAGISUE, which was obliged to be checked and lost its position when tightened onto LEXGETREDDY. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 12 November, and to conclude at midnight on Friday, 18 November 2016: a period of three (3) meetings.

**MISS MORGANA** (J. Kah) - rider reported the mare was reluctant to stretch out when placed under pressure in the straight. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer Mr G. Young was advised a Veterinary Certificate of Fitness required prior to trial or race.

**MAGISUE** (Z. Spain) - in the vicinity of the 300 metres was obliged to be checked and lost its position when tightened onto LEXGETREDDY as SATURDAY MAGIC shifted out when insufficiently clear.

Correct weight for this event was delayed to allow S. Price (SATURDAY MAGIC) and Trainer Mr D. Shepherd, placed second to view the vision in the straight.

## RACE 7 : PLAINS PRODUCER NEWSPAPER / ATKINS PHOTOGRAPHY BM 60 HANDICAP - 1410 metres

**BALF'S CHOICE** (M. Poon) – inclined to lay in under pressure in the straight.

**THAT'S A SLAB** (A. Jordsjo) - jumped away awkwardly and shifted in making heavy contact with BITEY HORSEY.

**ANYPORTINASTORM** (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

SANIMA STAR (P. Roff) – inclined to race keenly in the early and middle stages of the event.

**BITEY HORSEY** (J. Potter) – heavily contacted at the start as THAT'S A SLAB jumped away awkwardly and shifted in.

## RACE 8 : TAD'S EMBROIDERY SERVICE / EVANS FAEHRMANN P/L CLASS TWO HANDICAP - 1610 metres

**JIMMY ROYALE** (A. Jordsjo) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**GUN GURU** (C. Lindop) - in the vicinity of the 200 metres was obliged to be eased for a number of strides when disappointed in attempting a tight run to the inside of CASINO CLUB, which rolled in marginally.

**WISH LIST** (J. Bowditch) – raced keenly in the early and middle stages of the event.

CASINO CLUB (B. Claridge) - in the vicinity of the 200 metres rolled in marginally.

**DEVARICH** (K. Bishop) - slow to begin.
