Report on Race Meeting held at Strathalbyn Racecourse by the Strathalbyn Racing Club on Sunday, 20 November 2016

RACE 1: STRATHALBYN CUP JANUARY 15 MAIDEN PLATE - 1353 metres

THE REMOVALIST (P. Roff) – in the vicinity of the 1000 metres shifted in when insufficiently clear of BLOND VOYAGE, which was taken in onto BONSTAR EXPRESS. Rider was reminded of his obligations to be sufficiently clear when shifting ground in future.

BLONDE VOYAGE (J. Huxtable) – in the vicinity of the 1000 metres was crowded in onto BONSTAR EXPRESS after THE REMOVALIST shifted in when insufficiently clear. Over-raced throughout the middle stages of the event.

BONSTAR EXPRESS (L. Stojakovic) – in the vicinity of the 1000 metres was crowded after THE REMOVALIST shifted in onto BLONDE VOYAGE. As a result, BONSTAR EXPRESS had to be checked to avoid the heels of BLONDE VOYAGE making contact with the inside running rail. Rider reported the mare hung in throughout. A post-race veterinary examination revealed no visible abnormalities.

NORTHERN ECLIPSE (K. Bishop) – rider reported the filly felt awkward in its action over the concluding stages and as a result elected not to place the filly under pressure over the concluding stages. A post-race veterinary examination revealed an abnormal upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

RACE 2: BLEASDALE VINEYARDS / SABOIS DISTANCE MAIDEN PLATE- 1250 metres

CANONIC (M. Neilson) – over-raced in the early and middle stages of the event. In the vicinity of the 200 metres laid in when placed under pressure making contact with SAVANETA.

GOING NOWHERE (Z. Spain) – laid in when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SURE GONE (J. Kah) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

SWING ALONG (K. Bishop) – raced wide without cover throughout the event.

SAVANETA (J. Bowditch) - in the vicinity of the 200 metres was momentarily hampered after GOING NOWHERE shifted in under pressure.

RACE 3: FABAL WINES / SABOIS F&M MAIDEN PLATE - 1203 metres

O'LONHROAD (D. Caboche) – rider was examined by the First Care Medical Personnel behind the barriers after suffering a bleeding nose and was passed fit to start.

PARTY SET (K. Bishop) – began awkwardly. Over-raced in the middle stages of the event. In the vicinity of the 900 metres was crowded by CONNERMARA ROSE, which was taken in by SUPER CRUNCH. In the incident PARTY SET made contact with the running rail, blundered and as a result took CONNERMARA ROSE back out across the heels of SUPER CRUNCH.

SATURDAY'S DATE (S. Price) – hampered on jumping away.

CONNERMARA ROSE (P. Gatt) - in the vicinity of the 900 metres was taken in onto PARTY SET by SUPER CRUNCH making contact with PARTY SET. As a result, was buffeted out across the heels of SUPER CRUNCH and was severely hampered.

SUPER CRUNCH (J. Potter) - in the vicinity of the 900 metres shifted in marginally taking in CONNERMARA ROSE in onto PARTY SET.

RACE 4: LAKE BREEZE WINES CLASS TWO HANDICAP - 1603 metres

IDAHO (L. Stojakovic) – over-raced in the early stages of the event. Held up for clear running in the vicinity of the 400 metres until inside the 300 metres.

BIANCONNED (J. Toeroek) - slow to begin.

SEPTEMBER STORM (Jemma Frew) – over-raced throughout the event.

SENATUS (J. Potter) – blundered when making the crossing awkwardly.

RACE 5: THE WINE HOUSE BENCHMARK 56 HANDICAP - 1353 metres

MIDNIGHT MOON (J. Huxtable) - in the vicinity of the 900 metres hung out when making the turn. Over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SPIRITED MATCH (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

PLAYBOY LANE (B. Griffiths) – over-raced in the early stages of the event.

BACKSTAGE PASS (Jemma Frew) - slow to begin.

NIGHT BREEZE (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

COBBY GIRL (J. Mamat) - underwent a pre-race veterinary examination after having to be re-plated and passed fit to race. Rider reported he had concerns with the mare's actions and as a result failed to place COBBY GIRL under pressure in the straight. A post-race veterinary examination revealed atrial fibrillation. Advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the filly performing satisfactorily in an Official Barrier Trial.

RACE 6: HOWLIN' GALE WINES COLTS, GELDINGS & ENTIRES BENCHMARK 56 HANDICAP - 1203 metres

SHARK MIRAGE (S. Cahill) – began awkwardly making contact with the inside partition of the gates.

BATTISTONI (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

DAMAGE CONTROL (E. Boyd) - in the vicinity of the 300 metres blundered for no apparent reason.

RACE 6: HOWLIN' GALE WINES COLTS, GELDINGS & ENTIRES BENCHMARK 56 HANDICAP - 1203 metres (Cont'd)

TIMES LIKE THESE (NZ) (J. Potter) - held up for clear running on entering the home straight and in the vicinity of the 300 metres shifted to the outside of RAMESSES to improve. Raced in restricted room over the concluding stages between BOLD JAZZ and DAMAGE CONTROL.

BIG WEEKEEND (J. Huxtable) – hung out severely rounding the home turn and in the vicinity of the 300 metres was awkwardly placed to the inside of AQUIA CREEK. A post-race veterinary examination revealed no visible abnormalities.

BITEY HORSEY (E. Finnegan) – laid in when placed under pressure over the concluding stages.

RACE 7: 2016 LANGHORNE CREEK VIGNERON'S CUP - 1353 metres

HERENOA (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

IMPORTANT (J. Kah) - a post-race veterinary examination revealed mild heat stress.

KARADOC KID (P. Denton) - a post-race veterinary examination revealed no visible abnormalities.

ALERTNESS (M. Poon) – jumped away awkwardly.

RACE 8 : BREMERTON WINES / SABOIS FILLIES & MARES BENCHMARK 64 HANDICAP - 1203 metres

ANNANDALE LASS (D. Caboche) - a post-race veterinary examination revealed minor lacerations to near hind cannon. First administered.

JOY FLIPPER (J. Potter) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RED FAIRARIE (S. Cahill) - in the vicinity of the 900 metres raced in restricted room between DULCIE JANE and ANNANDALE LASS, which rolled in marginally. Momentarily held up for clear running in the vicinity of the 500 metres.

GOOSE GREEN – a late scratching at 11.20 am by order of Stewards on Veterinary advice as the mare was lame in the off foreleg.

FRAAR MANDY (L. Stojakovic) - a post-race veterinary examination revealed no visible abnormalities.
