Report on Race Meeting held at Kingscote Racecourse by Kangaroo Island Racing Club on Thursday, 16 February 2017

RACE 1: CANADIAN CLUB / SABOIS MAIDEN PLATE -1360 metres

ABLE STRIKER (D. Tootell) – bucked shortly after the start on a number of occasions and dislodged its rider. Shortly after contacted the running rail. D. Tootell was examined by the First Care Medical personnel and passed fit to fulfil his remaining engagements. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr S. Whittle, was advised that the gelding was required to complete an Official Barrier Trial to the Stewards' satisfaction prior to accepting for a future race.

LUNAR POWER (V. Wong) – underwent a pre-race veterinary examination on arrival on course as it had not raced in over two years and found to be lame in the near foreleg. Acting on this advice Stewards withdrew LUNAR POWER at 12.50 pm. Trainer, Mr D. O'Leary, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

BONSTAR EXPRESS (L. Stojakovic) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 2: FESTIVAL HIRE BENCHMARK 80 HANDICAP - 1750 metres

MOORE ALPHA (K. Cross) – inclined to lay out under pressure in the straight.

ONE FOR MAX (B. Griffiths) – hung out rounding the home turn.

FINAL TABLE (J. Potter) – laid out rounding the home turn.

RACE 3: DUDLEY BUBBLY BENCHMARK 54 HANDICAP - 1880 metres

The start of this event was delayed approximately 1 minute.

COURT RANGER (V. Wong) – reluctant to proceed to the barriers. Late scratching by order of Stewards at 2.21 pm. Trainer, Mr D. O'Leary, was advised that the mare was required to proceed to the start without delay to the satisfaction of Stewards in an Official Barrier Trial prior to accepting for a future race.

RACE 4: K.I. BREWERY / SABOIS MAIDEN PLATE - 1008 metres

VANDALAY (J. Huxtable) – marginally slow to begin.

ONRUSH (W. Kerford) – raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: K.I. BREWERY / SABOIS MAIDEN PLATE - 1008 metres (cont'd)

QUICK BISCUIT (L. Stojakovic) – jumped away awkwardly, shifted out and bumped RAINBOW REFLECTION.

RAINBOW REFLECTION (J. Toeroek) – bumped at the start as QUICK BISCUIT jumped away awkwardly and shifted out.

RON'S DELIGHT (K. Cross) – inclined to race greenly in the straight.

SHOW 'EM SHARKIE (J. Potter) – inclined to lay in under pressure in the straight. Trainer, Mr K. Healy, was fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

Correct weight for this event was delayed to allow Stewards to view the vision of the start.

RACE 5: ATKINS FREIGHT SERVICE BENCHMARK 64 HANDICAP - 1008 metres

AUSSIE JACK (K. Crowther) – inclined to lay in under pressure in the straight. In the vicinity of the 200 metres rider accidentally dropped her off side rein before being regathered shortly after.

SWINGITLIKESAYERS (Z. Spain) – underwent a pre-race veterinary examination after becoming fractious in its barrier stall and passed fit to start. Hung in severely under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

MAKE MINE MAGNUS (D. Tootell) – jumped away awkwardly and shifted in.

ARWA (E. Boyd) – made the corner in the vicinity of the 800 metres awkwardly and shifted out.

RACE 6: AG WILLSON EARTHMOVERS BENCHMARK 54 HANDICAP - 1360 metres

CALYPSO CHOICE (J. Huxtable) – a post-race veterinary examination revealed no visible abnormalities.

EMMOOKI'S STAR (D. Tootell) – slow to begin.

FRAAR MANDY (L. Stojakovic) – a post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr H. Montgomerie, was advised that a Veterinary Certificate of Fitness was required prior to accepting for a future trial or race.

LATER BABY (E. Boyd) – slow to begin.

RACE 7: BUDGET RENT-A-CAR KANGAROO ISLAND BENCHMARK 60 HANDICAP - 1215 metres

ALITAKA (Z. Spain) – inclined to lay in under pressure in the straight.

DUST 'N' DIAMONDS (K. Cross) – a post-race veterinary examination revealed no visible abnormalities.

RAINBOW ROOM (B. Griffiths) – slow to begin.

BENGAL TIGER (E. Boyd) – underwent a pre-race veterinary examination on arrival at the barriers and found to be lame in both forelegs. Acting on this advice Stewards withdrew BENGAL TIGER at 4.45 pm. Ms L. Faust, representing Trainer Mr J. Dunn, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.
