Report on Race Meeting held at the Port Lincoln Racecourse by the Port Lincoln Racing Club on Sunday, 19 February 2017

RACE 1: WILLOW GROVE STUD / SABOIS TWO-YEAR-OLD HANDICAP - 1210 metres

MIRTHDALE (T. Pannell) - jumped away awkwardly.

PUZZLIST (B. Claridge) - raced wide without cover throughout the event.

HORIZON WATCH (S. Fawke) - jumped away awkwardly.

RACE 2: DK QUARRIES / SABOIS MAIDEN PLATE - 1000 metres

INSKY (NZ) (J. Toeroek) – inside the 400 metres rolled out onto AGNES ISLAND, which was momentarily inconvenienced when tightened onto OUR MISSION. In the vicinity of the 200 metres became inconvenienced when GET NO ANSWERS, which raced greenly shifted out abruptly and INSKY (NZ) was inconvenienced for a number of strides when tightened onto HALLS BAY.

PHANTOM DATE (J. Bowditch) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

DESERT MINTY (T. Pannell) - from shortly after the start failed to maintain contact with the field. Rider reported the gelding did not travel during the event and felt shin sore. A post-race veterinary examination revealed shin soreness in both forelegs. Trainer Mr B. J Cozamanis was advised a Veterinary Certificate of Fitness is required prior to trial or race.

GET NO ANSWERS (V. Wong) - jumped away awkwardly and shifted in onto HALLS BAY. In the vicinity of the 200 metres, when racing greenly, shifted out abruptly onto INSKY, which was inconvenienced for a number of strides when tightened onto HALLS BAY. A post-race veterinary examination revealed no visible abnormalities.

AGNES ISLAND (B. Griffiths) – contacted at the start as HALLS BAY was taken in. Inside the 400 metres momentarily inconvenienced when tightened onto OUR MISSION as INSKY rolled out.

HALLS BAY (M. Poon) – taken in by GET NO ANSWERS and contacted AGNES ISLAND.

RACE 3: FOURIER TECHNOLOGIES / SABOIS MAIDEN PLATE - 1390 metres

CASIRAGHI (B. Claridge) – inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

BEACH GOD (J. Bowditch) - jumped away awkwardly, shifted in and contacted ARTFUL IGGY.

AHECKSTAR (S. Fawke) - raced wide without cover in the early and middle stages of the event.

ARTFUL IGGY (B. Griffiths) – contacted at the start as BEACH GOD jumped away awkwardly and shifted out.

ELECTIVE (T. Zanker) – rider reported the mare travelled well during the event and felt comfortable in its action, however, when asked for an effort in the vicinity of the 800 metres failed to respond to her riding. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: RAMSEY BROS BENCHMARK 60 HANDICAP- 1210 metres

The start of this event was delayed approximately two minutes.

NIPPY LIPPY (J. Huxtable) – became fractious in its barrier stall after being loaded. Underwent a pre-race veterinary examination and found the mare to be lame in the near hind leg. Acting on this advice Stewards withdrew NIPPY LIPPY at 2.16 pm.

GOLD BUSKER (J. Bowditch) - in the vicinity of the 200 metres was taken out by MILOS, which rolled out onto KID ME.

MORE THAN MOST (R. Hurdle) - in the vicinity of the 200 metres was inconvenienced when attempting a run between KID ME and PERUVIAN POWER as KID ME was taken out by GOLD BUSKER, which was taken out by MILOS, which rolled out. Thereafter MORE THAN MOST raced in restricted room between KID ME and PERUVIAN POWER, which was inclined to hang in, for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

KID ME (V. Wong) - jumped away awkwardly, shifted in and bumped MILOS. Raced wide without cover in the early and middle stages of the event. In the vicinity of the 200 metres was taken out by GOLD BUSKER, which was taken out by MILOS, which rolled out.

PERUVIAN POWER (Z. Spain) – inconvenienced at the start as MILOS rolled in. Hung in under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr J. Dunn was advised a Veterinary Certificate of Fitness required prior to trial or race.

MILOS (D. Caboche) – bumped at the start as KID ME jumped away awkwardly, shortly after rolled in onto PERUVIAN POWER, which was inconvenienced. In the vicinity of the 200 metres rolled out onto GOLD BUSKER.

RACE 5: RAISE A GLASS TO WES IRVINE BENCHMARK 60 HANDICAP - 1210 metres

CYCLONE STRYKER (T. Pannell) - in the vicinity of the 1000 metres was obliged to be eased as ROCKY VALLEY was taken in by LIVERPOOL STRIKER. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Trainer Mr S. Drewitt was advised a Veterinary Certificate of Fitness required prior to trial or race.

ROCKY VALLEY (M. Poon) - in the vicinity of the 1100 metres was inclined to lay in and rolled in onto CONTEGO, which was obliged to be steadied when tightened onto CYCLONE STRYKER. In the vicinity of the 1000 metres was taken in onto CYCLONE STRYKER by LIVERPOOL STRIKER.

LIVERPOOL STRIKER (R. Hurdle) – in the vicinity of the 1000 metres shifted in onto ROCKY VALLEY, which was taken in onto CYCLONE STRYKER, which was obliged to be eased. Rider was reprimanded under AR137(a) and advised in future to ensure he is sufficiently clear when he intends to shift ground.

CONTEGO (T. Zanker) - in the vicinity of the 1100 metres was obliged to be steadied when tightened onto CYCLONE STRYKER as ROCKY VALLEY, which was inclined to lay in, rolled in. Thereafter was inclined to race keenly and got its head up on a number of occasions.

RACE 6: MAGIC MILLIONS BENCHMARK 64 HANDICAP - 1390 metres

MAGICAL TYCOON (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

ALL KRUPT (Z. Spain) – knuckled on jumping away. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr B. Cozamanis was advised a Veterinary Certificate of Fitness required prior to trial or race.

CASINO EXIT (S. Fawke) – raced wide without cover in the early and middle stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

RACE 7: CLASSICBET BENCHMARK 80 HANDICAP - 1000 metres

DESTONY HAWK (B. Claridge) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

GEORDIE'S SECOND (D. Tootell) - jumped away awkwardly. Hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

CHANDLERY (B. Griffiths) - slow to begin.

RACE 8 : THOMAS FOODS INTERNATIONAL PORT LINCOLN CUP PRELUDE - 1750 metres

SPALDING COVE (M. Poon) – passing the winning post on the first occasion was obliged to be steadied as ROOBOY shifted in. Held up for clear running when rounding the home turn for a number of strides when racing between ROOBOY and HARD AT IT. Difficulty in obtaining clear ground and raced in restricted room between ROOBOY and HARD AT IT from approaching the 100 metres for the remainder of the event.

ROOBOY (V. Wong) – passing the wining post on the first occasion shifted in onto SPALDING COVE, which was obliged to be steadied. Rider was severely reprimanded under AR137(a) and advised to ensure he is sufficiently clear when shifting ground in future.

RACE 9: MEMBER FOR FLINDERS PETER TRELOAR BENCHMARK 60 HANDICAP - 1750 metres

ASH ROAD (J. Bowditch) – rider reported the gelding did not feel comfortable in it action throughout the event. A post-race veterinary examination revealed no visible abnormalities.

VALUE AS (E. Boyd) – inside the 200 metres when attempting a run to the inside of LAMU LAD was inconvenienced as LAMU LAD, which laid in, in the straight shifted in. As a result, VALUE AS was obliged to alter course to the outside of LAMU LAD to obtain clear running.

LAMU LAD (S. Fawke) – laid in under pressure in the straight and inside the 200 metres shifted in. As a result, VALUE AS, which was improving to LAMU LAD'S inside was inconvenienced and obliged to alter course to its outside.
