RACE 1: JOCK'S / SABOIS DISTANCE MAIDEN PLATE - 2200 metres

EXALTED KANGA (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

HAND TO HAND (NZ) (R. Hurdle) - raced wide without cover throughout the event.

PADDINGTON WAY (D. Thornton) – Trainer Mr T. McEvoy advised Stewards of an intended change of tactics, to race the mare more positive in the early stages. Rider stated that he raced further back than intended after being hampered on jumping away.

KIRONA (J. Bowditch) – shifted out on jumping away tightening PADDINGTON WAY.

RACE 2: MCCRACKEN FORD / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1050 metres

INDIAN MO (J. Toeroek) - in the vicinity of the 400 metres had to be restrained to avoid the heels of LOVE CLUB, which shifted out abruptly. Over-raced when placed under pressure over the concluding stages.

LOVE CLUB (J. Holder) – raced fiercely throughout the event. In the vicinity of the 400 metres shifted out abruptly when over-racing hampering INDIAN MO. When questioned regarding the performance of the gelding, Trainer Mr J. O'Connor stated that the gelding had pleased in its work leading up to today's race and in his opinion LOVE CLUB may have chocked down. He advised that in future he would apply a tongue tie. Stewards advised Mr J. O'Connor that a warning would be placed on the gelding in regards to it being intractable A post-race veterinary examination revealed no visible abnormalities.

SEAFORE (D. Tootell) – slow into stride. A post-race veterinary examination revealed no visible abnormalities.

ZAVILLA (Z. Spain) – laid out when entering the home straight.

Correct weight for this event was delayed to allow D. Tourneur (ECLAIR SUNSHINE) and the connections placed second to view the official judges photo.

RACE 3: ROYAL HOTEL BALAKLAVA / SABOIS MAIDEN PLATE - 1050 metres

RED SCIMITAR (S. Cahill) – attempted to buck shortly after jumping away. Laid in when placed under pressure in the straight. Trainer advised a warning would be placed on the gelding.

RACE 3: ROYAL HOTEL BALAKLAVA / SABOIS MAIDEN PLATE - 1050 metres (Cont'd)

GRACEFUL WOLF (J. Maund) – slow into stride. Trainer Mr T. Montgomerie was advised that the gelding would be required to trial competitively to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race after being beaten 30 lengths. A post-race veterinary examination revealed no visible abnormalities.

DORAWIN (V. Wong) – laid out when placed out under pressure over the concluding stages.

RACE 4: HENSON LLOYD ACCOUNTANTS CLASS TWO HANDICAP - 1050 metres

MULDER (M. Neilson) – laid in when placed under pressure over the concluding stages.

STAGHORN (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

THE GEE TRAIN (T. Pannell) - underwent a pre-race veterinary examination as the gelding had not raced since 12 March 2016 and passed fit to race. Laid in when placed under pressure in the straight.

TEMPTING FAITH (E. Finnegan) - a post-race veterinary examination revealed the mare to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

RACE 5: PLAINS PRODUCER NEWSPAPER / SABOIS FILLIES & MARES BENCHMARK 64 HANDICAP - 1300 metres

INFINITY QUEEN (D. Caboche) – rider pleaded guilty to a charge under AR137(4)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$200.

MISS COMMUNICATION (Z. Spain) - in the vicinity of the 400 metres was hampered after MOLLY THE SNIP shifted out. A post-race veterinary examination revealed no visible abnormalities.

MOLLY THE SNIP (D. Tourneur) - in the vicinity of the 400 metres shifted out making contact with MISS COMMUNICATION.

RACE 6: THE NEW COOPERS PREMIUM LAGER CLASS TWO HANDICAP - 1400 metres

DAISY'S JOY (D. Thornton) – began awkwardly, shifted in making contact with COBBMORE. In the vicinity of the 400 metres was taken out onto WICKED PROMISE. A post-race veterinary examination revealed abnormal upper respiratory noise. Trainer Mr T. McEvoy advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

COBBMORE (S. Fawke) – hampered on jumping away. In the vicinity of the 400 metres was hampered and taken wider by DARK IMAGE.

ENZO THE BARBER (J. Bowditch) – over-raced in the early and middle stages of the event. Held up for clear running on entering the home straight.

DARK IMAGE (M. Neilson) - jumped away awkwardly. in the vicinity of the 400 metres shifted out taking COBBMORE out onto DAISY'S JOY, which was taken out onto WICKED PROMISE, which became momentarily unbalanced.

WICKED PROMISE (K. Crowther) – raced wide in the early and middle stages of the event. in the vicinity of the 400 metres became momentarily unbalanced after being taken wider on the track by DAISY'S JOY.

GOT THAT SWING (J. Holder) - began awkwardly and shifted in.

GERONIMO'S SON (D. Tootell) - hampered on jumping away.

SET TO SURPRISE (D. Caboche) – laid in when place under pressure in the straight.

RACE 7: BALAKLAVA STITCH JOINT BENCHMARK 56 HANDICAP - 1600 metres

MISTER BURGESS (V. Wong) - in the vicinity of the 1000 metres was momentarily hampered after I'M A PRINCESS shifted out in an attempt to improve.

MEADOWS CADDY (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

NIGHT BREEZE (M. Neilson) - in the vicinity of the 1000 metres was momentarily hampered after MISTER BURGESS was taken wider by I'M A PRINCESS which shifted out to improve.

I'M A PRINCESS (D. Thornton) - in the vicinity of the 1000 metres shifted out to improve taking MISTER BURGESS out onto NIGHT BREEZE.

PHOENIX EAGLE (NZ) (C. Lindop) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: TAYLORS WINES ADELAIDE PLAINS CUP CLASS ONE HANDICAP - 1200 metres

ANYPORTINASTORM (M. Neilson) – over-raced in the early and middle stages of the event. Ran off making the home turn.

SUNSTRYKE (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

ARAZITOFF (D. Tourneur) – over-raced in the early and middle stages of the event.

FLYING FEATHERS (K. Crowther) – laid out when placed under pressure in the home straight.
