## RACE 1: WEST END / SABOIS FILLIES AND MARES MAIDEN PLATE - 1200 metres

**AZTEC PRIESTESS** (S. Price) - a post-race veterinary examination revealed the mare to be lame in the near foreleg, injected mucous membrane and elevated heart rate. Veterinary Certificate of Fitness required prior to trial or race.

**RAINBOW REFLECTION** (S. Cahill) - slow to begin. A post-race veterinary examination revealed evidence of colic. First aid administered.

**SAARLAY** (M. Neilson) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SHOW 'EM SHARKIE** (J. Potter) – laid in under pressure in the straight.

**WARRASIDE FAIRY** (D. Tootell) – slow to begin.

#### RACE 2: EFFIE WILLIAMS 90<sup>TH</sup> / SABOIS MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately two minutes.

**BOURDAIN** (S. Cahill) - jumped away awkwardly and was slow into stride. Raced ungenerously in the early and middle stages of the event.

**CENTURIUS** (Z. Spain) – raced keenly in the early and middle stages of the event.

**JAGARNA** (P. Gatt) – Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Lost its near fore plate during the event.

#### RACE 3: MAGIC FM/5CS / SABOIS DISTANCE MAIDEN PLATE – 1800 metres

**IMA SPECIAL KID** (S. Price) – approaching the 1700 metres shifted out marginally. Raced ungenerously in the early and middle stages of the event.

**PAT THE WEAPON** (S. Cahill) – approaching the 1700 metres was momentarily inconvenienced when IMA SPECIAL KID shifted out marginally.

**TATLER** (NZ) (M. Neilson) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

## RACE 3: MAGIC FM/5CS / SABOIS DISTANCE MAIDEN PLATE – 1800 metres (Cont'd)

**SIXTEEN AGAIN** (J. Maund) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

AHECKSTAR (S. Fawke) - jumped away awkwardly.

### RACE 4: JIM BARRY WINES BENCHMARK 60 HANDICAP - 1800 metres

**OCCIDENT (NZ)** (M. Neilson) – inconvenienced on jumping away when CALYPSO CHOICE jumped away awkwardly and shifted out. A post-race veterinary examination revealed no visible abnormalities.

**BLONDE VOYAGE** (S. Price) – inconvenienced on jumping away when OCCIDENT (NZ) shifted out and away from CALYPSO CHOICE, which jumped away awkwardly and shifted out.

FLYTIR (J. Potter) – raced ungenerously in the early and middle stages of the event.

CALYPSO CHOICE (J. Maund) – jumped away awkwardly and shifted out bumping OCCIDENT (NZ).

**TEE BONE** (S. Fawke) - Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Performed below expectations. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**PHOENIX EAGLE (NZ)** (Z. Spain) – rider reported that from the vicinity of the 800 metres he became concerned with the gelding's action and eased PHOENIX EAGLE (NZ) out of the event. A post-race veterinary examination revealed the gelding to be lame in the near hind leg and an elevated heart rate. Veterinary Certificate of Fitness required prior to trial or race. Trainer Mr D. Halliday was advised that the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

### RACE 5 : TAYLORS WINES / SABOIS FILLIES AND MARES BENCHMARK 60 HANDICAP - 1200 metres

CALL ME PENNY (J. Maund) - jumped away awkwardly and shifted out inconveniencing PERASINO.

**PERASINO** (V. Wong) – inconvenienced on jumping away when CALL ME PENNY jumped away awkwardly and shifted out.

**ZAZIPZOOM** (J. Potter) - jumped away awkwardly and shifted in inconveniencing ALMA GIRL.

**ALMA GIRL** (B. Claridge) – inconvenienced on jumping away when ZAZIPZOOM jumped away awkwardly and shifted in.

#### RACE 6: AIRMASTER BENCHMARK 64 HANDICAP - 1200 metres

**BELGIETTO** (D. Thornton) - slow to begin.

**DAZZLING LILLY** (Z. Spain) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**EXALTED GEM** (B. Griffiths) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**ARTFUL CHARMER** (R. Hurdle) – raced ungenerously in the early and middle stages of the event.

## RACE 7: UBET BENCHMARK 56 HANDICAP - 1100 metres

**GO'EN HOFF** (S. Price) - slow to begin.

**MAKE MINE MAGNUS** (R. Hurdle) - in the vicinity of the 50 metres shifted out under pressure. Rider reminded of his obligations when shifting ground.

# RACE 7: UBET BENCHMARK 56 HANDICAP - 1100 metres (Cont'd)

**BALZAC** (T. Pannell) – in the vicinity of the 50 metres shifted in under pressure. Rider reminded of his obligations when shifting ground.

**QUICK BISCUIT** (P. Gatt) – in the vicinity of the 50 metres had to be momentarily steadied when BALZAC shifted in under pressure and MAKE MINE MAGNUS shifted out under pressure.

**SACRED SEAL** (J. Bowditch) – racing from the 400 metres to the 300 metres was held up for clear running.

**MORADO** (B. Claridge) – struck the mounting yard enclosure en route the gates. Underwent a pre-race veterinary examination at the barriers and passed fit to race.
