THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Monday, 13 March 2017

RACE 1: 7NEWS HANDICAP - 1050 metres

BAY ROAD (V. Wong) – shifted in, in the vicinity of the 800 metres and crossed the running of I AM GYPSY, which was obliged to alter course to avoid that horse's heels. Rider reprimanded and advised to take greater care when shifting ground.

I AM GYPSY (J. Kah) – shifted in inside the 900 metres and crossed the running of STAR STEALER, which was inconvenienced. Rider reprimanded for shifting ground when insufficiently clear. Inconvenienced near the 800 metres and had to alter course as BAY ROAD crossed.

READY SUNSHINE (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the off forleg. Veterinary Certificate of Fitness required prior to trial or race.

STAR STEALER (B. Allen) – over-raced in the early stages and was inconvenienced inside the 900 metres. Brushed at the entrance to the straight by FEDERAL COURT, which shifted out to improve. Raced in restricted room over the concluding stages between CALL ME CURTIS, which shifted in and STREETCAR ILLUSION, which shifted out to improve, was inconvenienced and had its hindquarters turned.

FEDERAL COURT (J. Bowditch) – shifted out at the entrance to the straight to improve and brushed STAR STEALER.

STREETCAR ILLUSION (J. Holder) – held up for clear running from in the vicinity of the 400 metres and thereafter from inside the 200 metres had difficulty obtaining clear running and inside the 100 metres shifted to the outside of I AM GYPSY to improve into a tight run between I AM GYPSY and STAR STEALER and contacted STAR STEALER, which was tightened onto CALL ME CURTIS, which shifted in under pressure. Rider reprimanded and advised to only attempt runs for which there was sufficient room.

CALL ME CURTIS (Z. Spain) – shifted in under pressure over the concluding stages. Rider reminded of his obligations for failing to straighten his mount when it commenced to shift ground.

Correct weight for this event was delayed to allow Stewards to view the vision in the straight.

RACE 2: SCHWEPPES OAKS 6TH MAY 2017 HANDICAP – 1200 metres

BEAUTIFUL FLYER (E. Boyd) – rider accidentally dropped her whip inside the 100 metres and was fined \$50 under AR137(a) for carelessness in dropping her whip. Rider reported the mare felt sore in front.

RACE 2: SCHWEPPES OAKS 6TH MAY 2017 HANDICAP – 1200 metres (Cont'd)

ALASKAN JADE (E. Finnegan) – rider reported the mare began better than expected and as it was her intention to obtain cover in the early stages, she considered it would be detrimental to the mare's chances in the race to attempt to restrain to obtain a positon back with cover and allowed it to stride forward in the circumstances.

MISS ADELE (J. Holder) – rider reported the mare felt sore in the near foreleg. A post-race veterinary examination revealed the mare to be lame in both forelegs. Veterinary Certificate of Fitness required prior to trial or race.

RACE 3: MAGIC MILLIONS ADELAIDE TWO-YEAR-OLD CLASSIC - 1200 metres

ECLAIR SUNSHINE (D. Tourneur) – approaching the 800 metres shifted in and away from KHITAAMY, which shifted in. Held up for a short distance at the entrance to the straight and thereafter commenced to lay in and laid in throughout in the straight. A post-race veterinary examination revealed no visible abnormalities.

AZZURO BIANCO (P. Gatt) – lost its off hind plate during the event.

KHITAAMY (R. Bayliss) – shifted in approaching the 800 metres.

BACKSTREET ALLEY (S. Vella) - slow to begin and raced very greenly throughout the event. A postrace veterinary examination revealed no visible abnormalities.

BAD WOLF (J. Bowditch) – rider reported the colt may be shin sore. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: UBET SA DERBY 13TH MAY 2017 HANDICAP - 1200 metres

POSH JOURNEY (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

REVOLVING DOOR (M. Zhara) - a post-race veterinary examination revealed no visible abnormalities.

YULONG YONGXING (B. Allen) – raced ungenerously in the early stages and approaching the 100 metres shifted out to attempt to improve to the outside of SO YOU TOO but shortly thereafter straightened and did not persist with that run. A post-race veterinary examination revealed no visible abnormalities.

BERNIE (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

FULLY STOKED (E. Finnegan) - underwent a pre-race veterinary examination on arrival on course and passed fit to race.

JUST A BIGGER DASH (M. Poon) – began awkwardly. Rider reported it was his intention to lead but owing to the manner in which the gelding began he was unable to do so.

GAME OF WAR (J. Bowditch) – held up from in the vicinity of the 400 metres for a short distance. Approaching the 100 metres shifted in under riding and crossed the running of ARKHAM KNIGHT, which was obliged to be checked to avoid the heels of GAME OF WAR losing its position. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on 22 March, and to conclude at midnight on 29 March 2017: a period of three (3) meetings.

ARKHAM KNIGHT (N. Beriman) – had difficulty obtaining clear running in the early part of the straight. Thereafter approaching the 100 metres raced in restricted room between YULONG YONGXING to its inside and GAME OF WAR, which shifted in across the running of ARKHAM KNIGHT. As a consequence, N. Beriman had to check her mount and lost her position.

RACE 5: DARLEY GOODWOOD 20TH MAY 2017 HANDICAP - 1200 metres

COUNTER PULSE (C. Lindop) – rider accidentally dropped her whip in the vicinity of the 200 metres and was reprimanded for carelessness.

RACE 5: DARLEY GOODWOOD 20TH MAY 2017 HANDICAP - 1200 metres (Cont'd)

ASK ME HOW I KNOW (E. Finnegan) – slow to begin. Lost its off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

ITS NO JOKE (P. Gatt) - a post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

COCOA DOLL (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

NICCOCO (D. Thornton) – began awkwardly.

RACE 6: MY KITCHEN RULES MATRICE STAKES – 1200 metres

CASINO WIZARD (J. Holder) – inconvenienced near the 900 metres. Approaching the 100 metres raced in restricted room to the outside of KARLOVASI, which commenced to lay out and shifted out under pressure.

RIZIZ (T. Pannell) – rolled out near the 900 metres and inconvenienced CASINO WIZARD.

ROYAL RUMBLE (D. Lane) – slow to begin. Raced in restricted room approaching the 100 metres between CASINO WIZARD, which was taken out by KARLOVASI and HEZA RIPPER (NZ), which laid in.

KARLOVASI (P. Gatt) – laid out near the 100 metres.

HEZA RIPPER (NZ) (R. Bayliss) – raced greenly, was inclined to lay out in the early part of the straight and thereafter approaching the 100 metres commenced to lay in. A post-race veterinary examination revealed no visible abnormalities.

C'EST BEAU LA VIE (C. Lindop) - slow to begin. Raced in restricted room for a number of strides near the 100 metres to the outside of CASINO WIZARD. A post-race veterinary examination revealed no visible abnormalities.

LYUBA (B. Allen) – over-raced in the early and middle stages of the event.

RACE 7: UBET ADELAIDE CUP - 3200 metres

The start of this event was delayed approximately five and a half (5½) minutes due to a Club event scheduled in the mounting yard running over time, making it unsafe for the horses to enter the mounting yard.

MAIL IT IN (C. Lindop) – raced wide without cover in the early and middle stages of the event.

TUNES (J. Kah) – raced wide without cover in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

LIKE A CAROUSEL (C. Newitt) – stood flat-footed as the gates were released and lost many lengths at the start. Mr Keys advised a warning had been placed on the gelding in this regard.

CHESTNUT CHARLIE (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

DARABAD (FR) (N. Callow) – Stewards granted permission for the horse to race with a nose roll. Stewards questioned Trainer Mr R. Laing in regard to his failure to lodge a gear notification. As Stewards were able to confirm that DARABAD (FR) raced equipped with a nose roll at its last start in France, they permitted the horse to race accordingly. In the circumstances Mr Laing pleaded guilty to a charge under AR140B(2) for failing to seek permission to race the horse with a nose roll prior to acceptance time and was fined \$500. In the vicinity of the 450 metres raced in restricted room when weakening and was inclined to lay out and became awkward on the heels of HONEY STEEL'S GOLD which shifted in slightly. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: UBET ADELAIDE CUP - 3200 metres (Cont'd)

DOUBLE BLUFF (IRE) (J. Bowditch) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards took into account the context of the race. Lots it near hind plate during the event.

HONEY STEEL'S GOLD (B. Allen) – shifted in slightly near the 450 metres.

ANURADHA (D. Thornton) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race. First aid administered.

MIGHTY MAHER (T. Pannell) - a post-race veterinary examination revealed a slow post recovery.

RACE 8: SCHWEPPES C S HAYES MEMORIAL CUP - 1600 metres

PURPLE SMILE (R. Bayliss) - underwent a pre-race veterinary examination on arrival on course as it had not raced since March 2016 and passed fit to race.

IT AND A BIT (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

EXCITES ZELADY (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

MISS MURRA (P. Gatt) - a post-race veterinary examination revealed mild tying up in its hindquarters. First aid administered.

RACE 9: MAC DRINK DRIVING? GROW UP HANDICAP - 1600 metres

THAT'S A SLAB (E. Finnegan) - underwent a pre-race veterinary examination on arrival on course after it was established that the gelding hit its nose against the structure of the tie-up stall and had a minor laceration to its left nostril. Passed fit to race. Rider reported the gelding felt sore during the event. A post-race veterinary examination revealed no visible abnormalities.

CABLE BAY (NZ) (J. Potter) – commenced to race keenly in the vicinity of the 1000 metres and made the turn awkwardly.

SPIRITOF ENDEAVOUR (USA) (T. Pannell) – underwent a pre-race veterinary examination at the barriers after contacting the fence in the mounting yard and passed fit to race.

MISS SYDNEY (B. Allen) – rider reported the mare was galloped on shortly after the start and thereafter did not travel during the event. Lost its near hind plate during the event. A post-race veterinary examination revealed lacerations to both hind legs which was consistent with being galloped on.

OUR HENRIETTA (N. Beriman) - a post-race veterinary examination revealed no visible abnormalities.

PROUD EAGLE (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

JEALOUS RUMOUR (D. Thornton) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards took into account the context of the race.
