RACE 1: LINCOLN ESTATE WINES & ROLL THE DICE RACING / SABOIS MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately five minutes.

OUR MISSION (C. Davies) – reared on jumping away and as a result was slow to begin.

NATH'S WISH (D. McWhinney) – on jumping away brushed with APPROACHING BLISS.

APPROACHING BLISS (J. Huxtable) – on jumping away brushed with NATH'S WISH. Inclined to overrace during the event.

REDDYDOO (B. Griffiths) – rider reported in his opinion the filly never travelled during the event.

SYNERGY (T. Zanker) – on arrival at the barriers became unruly and dislodged its rider. T. Zanker was examined by the First Care Medical Personnel and was passed fit to fulfil her remaining engagements. SYNERGY underwent a pre-race veterinary examination and was passed fit to race.

RACE 2: THE STREAKY BAY RACING CLUBS IN KIND & APPRECIATED SUPPORTERS BM72 HANDICAP – 1000 metres

SOUND OF VICTORY (T. Zanker) – knuckled on jumping away. In the vicinity of the 200 metres, when weakening, was obliged to be steadied as CHANDLERY, which was inclined to lay in, shifted in. A post-race veterinary examination revealed blood in the near side nostril. As Stewards could not be satisfied that the bleeding was caused from an external trauma and acting under AR53A(7), Stewards advised Trainer Mr R. Wilkins that the gelding was required to gallop 1000 metres in presence of a Steward prior to accepting for a future race.

ELECTRIC SKY (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

CHANDLERY (K. Crowther) – inclined to lay in under pressure in the straight and in the vicinity of the 200 metres shifted in onto SOUND OF VICTORY, which was weakening and was obliged to be steadied. Rider severely reprimanded under AR137(a) and advised to make a greater effort when her mounts commence to shift in, in future. Approaching the 100 metres continued to lay in and shifted in onto SCENIC MINT, which was obliged to ease momentarily. Rider reminded of her obligations when shifting ground in future. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr C. Cox was advised a Veterinary Certificate of Fitness required prior to future trial or race.

RACE 3: STREAKY BAY MARINE PRODUCTS/STREAKY BAY MEAT SERVICE/PERKS/CEDUNA MACHINERY BM54 HANDICAP – 1200 metres

PERUVIAN POWER (J. Huxtable) – inclined to lay in under pressure in the straight.

GOLD BUSKER (C. Davies) - jumped away awkwardly and contacted KEEP DIGGING.

KEEP DIGGING (D. McWhinney) – on jumping away was contacted by GOLD BUSKER.

CARDINAL MISSION (L. Blackledge) –Stewards granted permission for L. Blackledge to not claim her full allowance in this event.

RACE 4 : R I & L A MONTGOMERIE & FESTIVAL HIRE BENCHMARK 60 HANDICAP - 1400 metres

SPINE SCHILLER (B. Griffiths) - a post-race veterinary examination revealed no visible abnormalities.

TICKET TO PARIS (J. Huxtable) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In assessing penalty Stewards took into account J. Huxtable's circumstances in the race.

READY AGAIN (C. Davies) - slow to begin.

EXALTED FEATURES (T. Zanker) – jumped away awkwardly and as a result T. Zanker became unbalanced for a number of strides.

SWEET SATURDAY (L. Blackledge) – as there was no rider available on course, Stewards granted permission for L. Blackledge to ride this gelding 1kg overweight.

RACE 5: XXXX GOLD & STREAKY BAY COMMUNITY HOTEL CUP - 1800 metres

EYE THE WORLD (B. Griffiths) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In assessing penalty Stewards took into account B. Griffith's circumstances in the race.

CATCH HIM (C. Davies) - slow to begin.

NEW WAVE (T. Zanker) - a post-race veterinary examination revealed no visible abnormalities.

DAL ROMMEL (NZ) (K. Crowther) – made the turn out of the home straight on the first occasion awkwardly and as a result ran wider on the track. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr F. Smith was advised a Veterinary Certificate of Fitness required prior to future trial or race.

RACE 6: FOODLAND STREAKY BAY BENCHMARK 54 HANDICAP - 1800 metres

JOKEN JIM (J. Huxtable) – a post-race veterinary examination revealed no visible abnormalities.

JUST PAST MIDNIGHT (L. Blackledge) - as there was no rider available on course, Stewards granted permission for L. Blackledge to not claim her full allowance in this event.

VELOCE ROCK (J. Maund) - a post-race veterinary examination revealed the gelding to be lame in off foreleg. Trainer Mr R. King was advised a Veterinary Certificate of Fitness required prior to trial or race.
