#### RACE 1: PRINCE OF WALES HOTEL / SABOIS MAIDEN PLATE - 1100 metres

**WILKIN** (R. Hurdle) – Stood flatfooted and missed the start badly. Rider reported that his mount felt awkward in its action shortly after jumping and refused to stride out at any stage of the event. A post-race veterinary examination revealed no visible abnormalities. Trainer Ms K Edwards was advised that the gelding would be required to perform in an Official Barrier Trial to the satisfaction of stewards prior to a future race.

AHIGA (C. Hall) - a post-race veterinary examination revealed no visible abnormalities.

**MENTAL AS ANYTHING** (B. Griffiths) - rider reported that his mount raced green throughout the event.

**JAYZOWN** (V. Wong) - a post-race veterinary examination revealed the gelding had fractured its near fore shoulder joint after pulling up past the winning post and was humanely euthanased.

# RACE 2: OMNIZAR / SABOIS MAIDEN PLATE - 1400 metres

**SUDDEN IMPULSE** (B. Griffiths) – rider reported his mount raced green throughout the event. In the vicinity of the 100m became awkwardly placed on the heels of MOWTOWN CHARM.

**NERINGAH** (E. Finnegan) – began awkwardly and as a result was slow into stride.

**DARKEN UP (NZ)** (V. Wong) – held up for clear running from the vicinity of the 200m to inside the 100m.

MOTOWN CHARM (S. Fawke) - over-raced in the early and middle stages of the event.

**SHE'S GOT RHYTHM** (R. Hurdle) - underwent a pre-race veterinary examination after being kicked during the loading process and was passed fit to start. Rider accidently dropped his offside reign for a stride in the vicinity of the 200m before regathering.

#### RACE 3: FESTIVAL HIRE / SABOIS MAIDEN PLATE - 1700 metres

**ATOMIC FLEA** (C. Collins) - stood flatfooted as the start was affected and was slow to begin. Trainer Mr S McIntyre was advised that a warning would be placed on the record of the gelding.

**CEALLACH** (A. Jordsjo) - held up for clear running on entering the home straight.

**HADFIELD** (B. Griffiths) - rider report that his mount felt awkward in its action throughout the event and failed to stride out at any stage. A post-race veterinary examination revealed the gelding to be lame in the off fore leg. Trainer Mr R Daniel was advised that he would be required to furnish a Veterinary Certificate of Fitness prior to the gelding competing satisfactorily in an Official Barrier Trial after failing to finish.

**BRINGME THE BUTLER** (K. Bishop) - rider reported her mount slipped in the vicinity of the 1100m. Lost its near fore plate in running.

CALL ME TOFF (C. Wong) - laid in when placed under pressure over the concluding stages.

CHASE THE STORM (E. Finnegan) - raced wide without cover throughout.

**MISS INTELLIGENT** - a late scratching on veterinary advice at 2.01pm after being fractious in the barriers. Trainer Mr L Creek was advised that the filly would be required to load and perform to the satisfaction of the stewards in an official barrier trial prior to resuming

#### RACE 4: COOPERS BREWERY BENCHMARK 60 HANDICAP - 1100 metres

**MANNION** (E. Finnegan) - when questioned regarding the performance of the gelding, rider reported she placed her mount under pressure in the vicinity of the 600m but her mount failed to respond to her vigorous urgings, began to weaken in the vicinity of the 400m and was disappointed in the geldings finishing effort. A post-race veterinary examination no visible abnormalities.

NORTH BEACH (B. Griffiths) - over-raced throughout the middle stages of the event.

#### RACE 5: WATTLE RANGE COUNCIL BENCHMARK 80 HANDICAP - 1100 metres

**RHYTHMATIC** (R. Hurdle) - in the vicinity of the 500m shifted out when insufficiently clear of REDEEKA which had to be steadied. Rider pleaded guilty to a charge of careless riding under AR137(a) and was suspended for riding in races for a period to commence at midnight Wednesday, 22 April 2017 and to conclude at midnight Monday, 26 April 2017, a period of three (3) race meetings.

MISS JOOLIA (C. Hall) - slow to begin.

**REDEEKA** (S. Fawke) - in the vicinity of the 500m had to be restrained to avoid the heels of RHYTHMATIC which shifted out when insufficiently clear.

# RACE 6: ADRIAN THOMAS INDUSTRIAL BENCHMARK 64 HANDICAP - 1400 metres

**ROMANEE VINCE (NZ)** – a late scratching on veterinary advice at 8.35am.

COSTA LANTE (D. Thornton) - slow to begin.

**WE'RE SO LUCKY** (C. Hall) - in the vicinity of the 300m became awkwardly placed inside of TZAREVNA while racing in restricted room.

**SPECTRUMS BITE** (K. Bishop) - raced wide without cover throughout.

KAEWSRAKOO (V. Wong) - jumped away awkwardly.

# RACE 7: KATNOOK ESTATE WINES PENOLA CUP - 1700 metres

**CELESTIAL STORY** (K. Bishop) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**MAJESTIC RIDGE** (E. Boyd) – a post-race veterinary examination revealed no visible abnormalities. Trainer Mr S McIntyre was advised the Mare would be required to trial competitively in an Official Barrier Trial after being beaten 38 Lengths.

# RACE 8: THOMAS, DEGARIS & CLARKSON BENCHMARK 56 HANDICAP - 1700 metres

**LINCECUM** - a late scratching on veterinary advice at 4.46pm after the gelding was found to be lame in the near fore leg.

**LOLOTEA** (S. Fawke) - over-raced in the early stages of the event.

**BACK TO REALITY** - a late scratching at 2.55pm after there was no available rider.

UNIVERSAL SOUND - a late scratching at 2.55pm after there was no available rider.
