Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 15 July 2017

RACE 1: JAMES BOAG'S PREMIUM HANDICAP - 1000 metres

WHITE KAPS (A. Jordsjo) – knuckled at the start, was very awkward to begin and thereafter commenced to race keenly inside the 800 metres for a short distance and brushed with FLYING KRUPT for some distance approaching the 600 metres. Rider reminded of her obligations. Lost its near fore plate during the event.

FLYING KRUPT (B. Claridge) – brushed with WHITE KAPS for some distance approaching the 600 metres. Rider reminded of his obligations.

ROYALARGO (R. Hurdle) – reared on jumping away, was very awkward and slow to begin losing two to three lengths. Improved onto the heels of runners approaching the 600 metres and was obliged to shift out to obtain clear ground. A post-race veterinary examination revealed the filly to be lame in near hind leg. Veterinary Certificate of Fitness required prior to trial or race.

DREAM OF GLORY (R. Clark) – Co-Trainer's Mr L. Macdonald & Mr A. Gluyas fined \$100 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards.

RACE 2: UBET HANDICAP - 1000 metres

BRINGAROO (T. Pannell) – began awkwardly and shifted out shortly after the start. Lost its off hind plate during the event.

NODOUBTABOUTIT (E. Finnegan) – raced keenly in the early stages and thereafter raced in restricted room for a short distance inside the 600 metres, got its head up and was ungenerous.

TWO DUCKS ARTIE (P. Gatt) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

CASQUE (D. Thornton) – slow into stride and was then tightened by BRINGAROO, which began awkwardly, shifted out and as a consequence lost its position.

RACE 3: HUGHES LIMOUSINES HANDICAP - 1250 metres

COUNTER PULSE (R. Clark) – rider reported the gelding pulled up distressed. A post-race veterinary examination revealed no visible abnormalities.

STRATEGIC DEMAND (J. Holder) – raced keenly in the middle stages of the event.

SANDHILL STAR (A. Jordsjo) – which had not raced since February 2016 underwent a pre-race veterinary examination after arrival on course and was passed fit to race.

LAST BULLET (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

OPTIMIZE (P. Gatt) – held up for a short distance at the entrance to the straight.

RACE 4: SCHWEPPES HANDICAP - 1250 metres

LOTS OF SMACKS (B. Thornton) – inconvenienced at the start. Held up for clear running for a number of strides at the entrance to the straight when racing behind CORRECT CALL.

CORRECT CALL (R. Clark) – began awkwardly, shifted out at the start and tightened LOTS OF SMACKS onto SANDHILL HERO resulting in both these runners being inconvenienced. Held up for clear running in the vicinity of the 400 metres when racing behind FLIP DE GLOIRE and to the inside of MINT COLLECTOR and was obliged to shift in, inside the 200 metres to obtain clear running. A post-race veterinary examination revealed no visible abnormalities.

SANDHILL HERO (A. Jordsjo) – which had not raced since April 2016 underwent a pre-race veterinary examination after arrival on course and was passed fit to race. Inconvenienced at the start.

INFINITY QUEEN (M. Neilson) – lost its off hind plate during the event.

MINT COLLECTOR (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

NIPPERKIN (P. Gatt) – raced wide without cover throughout the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RAIN FAST (C. Hall) – presented late in the mounting yard. Trainer Mr Lenehan pleaded guilty to a charge under AR124 for presenting the mare in the mounting yard no later than 15 minutes before the advertised start time for this race and was fined \$200.

RACE 5: WOMENS AND CHILDRENS HOSPITAL HANDICAP - 2250 metres

FLYING CASINO (J. Holder) rider reported the gelding was off the bridle from in the vicinity of the 600 metres, failed to finish the event off and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

SPUR ON GOLD (D. Thornton) - slow to begin.

RACE 6: STEVE HOLLOWAY WINNER WINNER CHICKEN DINNER HANDICAP - 1400 metres

REDEEM BOUNTY (J. Toeroek) –rider reported it was his intention to settle more forward but owing to the manner in which the gelding raced in the early part of the event, he was unable to take up a forward position and was obliged to settle back in the field. He added the gelding was very disappointing and failed to respond to his riding from inside the half mile. A post-race veterinary examination revealed no visible abnormalities.

ALLEZ TARA (E. Finnegan) – a post-race veterinary examination revealed no visible abnormalities.

COUNTER SPIN (R. Clark) – from in the vicinity of the 300 metres had difficulty obtaining clear running until near the 200 metres.

RACE 6: STEVE HOLLOWAY WINNER WINNER CHICKEN DINNER HANDICAP - 1400 metres (Cont'd)

AFFRAY (T. Pannell) – held up for clear running from inside the 400 metres until approaching the 300 metres.

RACE 7: HOLDFAST INSURANCE HANDICAP - 1000 metres

ITZ INVINCIBLE (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

ONE MORE DAISY (T. Pannell) – shifted out shortly after the start and contacted IDATWO.

CLASSY JACK (R. Clark) – accidentally dropped her whip over the concluding stages of the event and was reprimanded under AR137(a) for carelessness. A post-race veterinary examination revealed no visible abnormalities.

I AM THE GENERAL (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: MAC DRINK DRIVING? GROW UP HANDICAP - 1400 metres

ECLAIR ATTACK (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

LOKITIN (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

GROOVE WITH ME (S. Cahill) – tightened at the start and inconvenienced. Rider reported that as a consequence of suffering interference shortly after the start, he was unable to take up a more forward position as intended.

TYCOON SOFIE (B. Griffiths) – shifted in shortly after the start and tightened NIGHT QUEEN onto GROOVE WITH ME, which rolled out. As a consequence, NIGHT QUEEN was severely hampered and was unable to maintain his position. Rider severely reprimanded. A post-race veterinary examination revealed lacerations to the near fore fetlock.

GRUMPY GURU (J. Potter) – re-saddled in the mounting yard.

NIGHT QUEEN (S. Price) – tightened at the start, severely hampered and lost its position. A post-race veterinary examination revealed no visible abnormalities.

BURNRO (E. Finnegan) – contacted at the start and was inconvenienced.

JUST PEGGY (J. Kah) – over-raced in the early stages of the event.

EMMOOKI'S STAR – late scratching by order of Stewards at 8.19 am when it was established that Trainer Mr S. Whittle had not received the message that his runner had gained a start until after the closing time for scratchings.
