RACE 1: COOPERS / SABOIS TWO-YEAR-OLD MAIDEN PLATE - 1119 metres

BALWARRA GOLD (A. Doyle) - jumped away awkwardly and shifted out.

BOMBER BOB (K. Crowther) – inclined to hang out throughout the event. In the vicinity of the 500 metres was taken wider on the track by MRS HARVEY BROWN, which was taken out. A post-race veterinary examination revealed no visible abnormalities.

BUJOLASS (K. Bishop) - slow into stride.

MRS HARVEY BROWN (J. Kah) - slow to begin. In the vicinity of the 500 metres was taken out by RUSTYDUSTYSUNSHINE onto BOMBER BOB, which was taken wider. A post-race veterinary examination revealed no visible abnormalities.

RUSTYDUSTYSUNSHINE (E. Finnegan) – in the vicinity of the 500 metres shifted out to improve taking MRS HARVEY BROWN out onto BOMBER BOB, which was taken wider. Inclined to lay in under pressure in the straight.

RACE 2: GOLDIN FARMS BENCHMARK 64 HANDICAP - 2124 metres

BARGE AND CHARGE (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

KEEPAKIWI (NZ) (J. Holder) – difficulty in obtaining clear ground from rounding the home turn and thereafter for a short distance after entering the straight. Inclined to lay in under pressure in the straight.

EXALTED DEE (B. Griffiths) – raced wide without cover throughout the event.

RACE 3: TERRACE FUNCTION CENTRES / SABOIS FILLIES & MARES MAIDEN PLATE - 1119 metres

COMMANDING JOY (B. Griffiths) – bumped at the start by WE ARE BOMBER FANS, which jumped away awkwardly and shifted out.

MISS CUOCO (J. Kah) - rider could offer no explanation into the mare's performance in today's event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: TERRACE FUNCTION CENTRES / SABOIS FILLIES & MARES MAIDEN PLATE - 1119 metres (Cont'd)

WE ARE BOMBER FANS (J. Toeroek) - jumped away awkwardly, shifted out and bumped COMMANDING JOY.

HILUMIERE (P. Gatt) - jumped away awkwardly.

WARRASIDE FAIRY (A. Doyle) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: TREASURY WINES ESTATE / SABOIS MAIDEN PLATE - 1520 metres

EXALTED EDWARD (P. Gatt) – eased out of the event from in the vicinity of the 600 metres and failed to finish. Rider reported in his opinion the gelding may have choked down during the event. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr R. Wilkinson was advised that the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

HE'S A VALLEYBOY (C. Lindop) - slow to begin.

LANNISTER GOLD (A. Jordsjo) - in the vicinity of the 500 metres was taken in by PENNY FACE, which shifted in marginally onto ALPHA STRYKE, which was obliged to be steadied and lost its position as WHISPERING WILLOW rolled out when racing greenly.

PENNY FACE (D. Tootell) - in the vicinity of the 500 metres shifted in marginally onto LANNISTER GOLD, which was taken in onto ALPHA STRYKE, which was obliged to be steadied and lost it positon when tightened onto WHISPERING WILLOW, which rolled out when racing greenly. Rider reprimanded under AR137(a) and advised to take greater care in future.

WHISPERING WILLOW (B. Griffiths) - in the vicinity of the 500 metres rolled out when racing greenly onto ALPHA STRYKE, which was obliged to be steadied and lost its positon when tightened onto LANNISTER GOLD, which was taken in by PENNY FACE, which shifted in marginally. Rider reprimanded under AR137(a) and advised to take greater care in future.

ALPHA STRYKE (J. Toeroek) – in the vicinity of the 500 metres was obliged to be steadied and lost its position as WHISPERING WILLOW, which was racing greenly, rolled out as LANNISTER GOLD, was taken in by PENNY FACE, which shifted in marginally. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: CANADIAN CLUB MAIDEN PLATE - 1219 metres

FAMILJA (K. Crowther) – inclined to race keenly in the early and middle stages of the event.

EVASIVE WITNESS (J. Holder) – approaching the 1000 metres rolled out marginally onto TRYST AGAIN, which was obliged to be eased momentarily.

EWAN MINE (S. Cahill) – contacted a perimeter fence in the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race.

TIME ROGUE (V. Wong) – inclined to lay out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

TYPHON'S TOMMY (A. Doyle) - jumped away awkwardly and as a result was slow to begin.

TRYST AGAIN (C. Lindop) – approaching the 1000 metres was obliged to be eased momentarily off the heels of EVASIVE WITNESS, which rolled out marginally.

RACE 6: BACK TO THE EXCHANGE HOTEL GAWLER BENCHMARK 60 HANDICAP - 1520 metres

RAISE A DREAM (A. Jordsjo) – hung out throughout the event and inside the 200 metres shifted out inconveniencing L'AMARYBELLE.

L'AMARYBELLE (D. Tourneur) – inside the 200 metres was inconvenienced by RAISE A DREAM, which was inclined to hang out and shifted out. A post-race veterinary examination revealed no visible abnormalities.

PRESUMPTION (P. Gatt) – weakened from the 500 metres. A post-race veterinary examination revealed no visible abnormalities.

GRAND ARMADA (D. Caboche) – raced wide without cover throughout the event.

RACE 7: COCA COLA BENCHMARK 60 HANDICAP - 1722 metres

UNRELATED (P. Gatt) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

KAZOOM (NZ) (E. Finnegan) - slow to begin losing four to five lengths. Trainer Mr R. Campbell was advised a warning had been placed on the gelding.

SHADE OF GREEN (D. Caboche) – a post-race veterinary examination revealed no visible abnormalities. Trainer Mr D. Huxtable advised Stewards that the mare will be retired.

JARRVIS (A. Jordsjo) – approaching the 100 metres rider accidentally dropped her whip. Rider pleaded guilty to a charge under AR137(a) for carelessness in dropping her whip and was fined \$50.

RUN RUSTY RUN (B. Griffiths) – as no suitable Apprentice was available B. Griffiths was permitted to not claim his allowance in this event. B. Griffiths pleaded guilty to a charge under AR120(b) and was fined \$300. In assessing penalty Stewards took into account that B. Griffiths maintained the ride. A post-race veterinary examination revealed no visible abnormalities.

SELDOM HOME (K. Crowther) – contacted a perimeter fence on exiting the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to race.

RACE 8: GAWLER SOUTH BAKERY BENCHMARK 56 HANDICAP - 1219 metres

BEEJAYDEE (A. Jordsjo) – marginally slow to begin.

PARTING SHOT (B. Griffiths) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SPIRITED MATCH (A. Doyle) – as no suitable apprentice was available permission was granted for A. Doyle to claim 1.5kg of his 2kg allowance in this event. A. Doyle pleaded guilty to a charge under AR120(b) and was fined \$200. In assessing penalty Stewards took into account A. Doyle maintained the ride. Raced keenly throughout the event.

RACE 8: WEBB CONTRACTORS BENCHMARK 56 HANDICAP - 1400 metres

Stewards inquired into the reason why Damien Thornton failed to fulfil his engagement on LUCKY NOW, D. Thornton pleaded guilty to a charge under AR85B in that he failed to fulfil a riding engagement and was reprimanded and advised in future that communication between his manager and himself needs to be clearer.
