### THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

### Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 7 October 2017

# RACE 1: JAMES BOAG'S PLATE - 1000 metres

**MORE THAN EXCEED (NZ)** (D. Tourneur) – began very awkwardly, shifted in abruptly shortly after the start and became unbalanced for several strides.

**OUR GREAT NORTHERN** (J. Todd) – in the vicinity of the 300 metres raced greenly, shifted out and inconvenienced TEQUILA TIME, which was taken wider. Thereafter raced greenly for the remainder of the event.

**SIR GARFIELD** (J. Toeroek) – laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**TEQUILA TIME** (C. Lindop) – in the vicinity of the 300 metres was inconvenienced when taken wider by OUR GREAT NORTHERN. Raced greenly in the straight.

**COTILLION** (J. Turner) - a post-race veterinary examination revealed no visible abnormalities.

# RACE 2: SCHWEPPES HANDICAP – 1300 metres

**PASEETO** (J. Kah) – over-raced in the early stages of the event.

**ATTICUS (NZ)** (R. Hurdle) – Trainer Mr J. O'Connor pleaded guilty to a charge under LR18.1.7 for declaring a rider without a firm engagement. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**CANFORD** (J. Huxtable) – began awkwardly, shifted out and contacted ALLAYEZ. Momentarily held up for clear running in the e/vicinity of the 400 metres. Lost its off hind plate during the event.

**MISS BELISA** (J. Bowditch) – began awkwardly, shifted in and contacted ALLAYEZ. A post-race veterinary examination revealed no visible abnormalities.

THOR'S THUNDER (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

ALLAYEZ (K. Stra) – contacted at the start.

# RACE 3: BAZZ'S BUCKS SHOW HANDICAP - 1250 metres

**PALE ALE** (S. Cahill) – near the 1000 metres was taken in by FORCE OF THREE as that horse was tightened by STREET EMBRACE, which shifted in. As a consequence, PALE ALE was hampered, raced in restricted room and shifted in onto WALA PULKA. A post-race veterinary examination revealed no visible abnormalities.

**IGITUR** (J. Toeroek) – reared at the start and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**FULLY STOKED** (D. Tourneur) – approaching the 200 metres shifted out under riding, tightening FORCE OF THREE onto SET TO SPARKLE resulting in FORCE OF THREE'S running being taken and the gelding having to be checked to avoid the heels of FULLY STOKED. Rider was found guilty of a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 14 October and to conclude at midnight on Saturday 21 October 2017: a period of four meetings.

**STREET EMBRACE** (J. Huxtable) – shifted in near the 1000 metres and crossed the running of FORCE OF THREE when insufficiently clear tightening that horse onto PALE ALE. Rider pleaded guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 15 October and to conclude at midnight on Sunday 22 October 2017: a period of four meetings.

**FORCE OF THREE** (R. Hurdle) – the saddle slipped forward in the vicinity of the 1100 metres. Tightened near the 1000 metres by STREET EMBRACE, which shifted in, had to be checked and lost its position. Thereafter near the 300 metres raced in restricted room between SET TO SPARKLE and FULLY STOKED and approaching the 200 metres was obliged to be checked to avoid the heels of FULLY STOKED, which shifted out when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

**WALA PULKA** (J. Bowditch) – in the vicinity of the 1000 metres raced in restricted room to the inside of PALE ALE and was taken in when that horse was taken in by FORCE OF THREE and became severely hampered and unbalanced for several strides.

**SET TO SPARKLE** (J. Kah) – awkward to begin.

EQUIDAME (J. Holder) – disappointed for clear running for a short distance inside the 200 metres.

# RACE 4: KITTY CAT PASTORAL HANDICAP - 1950 metres

**LORD LUMBERJACK (GER)** (J. Kah) – laid out in the straight.

**COUNT OF LIMONADE (IRE)** (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

#### RACE 5: SPRING CARNIVAL 21 OCT - 7 NOV HANDICAP - 1250 metres

**ASHDAM** (D. Caboche) – contacted at the start.

**BOGGOMS** (J. Huxtable) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**AMPLE ON OFFA** (C. Lindop) – awkward to begin.

**JUSTIFY THAT** (V. Wong) – awkward to begin. Shifted in, contacted ASHDAM and over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**TYCOON QUEEN** (R. Clark) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**SWORD OF JUSTICE** (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

# RACE 6: HUGHES LIMOUSINES HANDICAP - 1000 metres

**USAIN DANE** (J. Huxtable) - slow to begin. Raced keenly in the early stages and laid in, in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

Correct weight was delayed to allow J. Huxtable (USAIN DANE) to view the vision of the start.

# RACE 7: UBET HANDICAP - 1400 metres

**DAYTONA GREY** (R. Clark) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to race. Inside the 1200 metres sifted in taking IT AND A BIT in onto SPY DECODER (NZ), which was taken in onto EXCITES ZELADY. Rider reminded of her obligations when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

**MOSS 'N' DALE (NZ)** (B. Stockdale) – held up rounding the home turn and thereafter laid out in the straight.

**IT AND A BIT** (J. Kah) – taken in inside the 1200 metres. A post-race veterinary examination revealed no visible abnormalities.

**EXCITES ZELADY** (J. Toeroek) – inside the 1200 metres was inconvenienced when awkwardly placed inside the heels of SPY DECODER (NZ), which was taken in.

**DR DAPPER** (C. Lindop) – momentarily inconvenienced when awkwardly placed outside the heels of FLOW METER near the 200 metres.

**SHARDS** (D. Tourneur) – slow to begin.

**SPY DECODER (NZ)** (V. Wong) – taken in inside the 1200 metres. A post-race veterinary examination revealed a slow post-race recovery. First aid administered.

**PENNY FOR A POUND** (J. Turner) – awkward to begin and was held up for a short distance at the entrance to the straight.

#### RACE 8: THE JUNCTION HANDICAP – 1400 metres

**SCRATCHY LASS** (J. Turner) – had difficulty obtaining clear running throughout in the straight. A postrace veterinary examination revealed no visible abnormalities.

**SO SKILLED** (J. Bowditch) – over-raced in the early stages of the event.

**BEAU RIVAGE** (J. Holder) – unable to obtain clear running over the concluding stages.

**WASABI BOB** (C. Lindop) – over-raced in the early stages of the event and brushed with MAZUREK on a number of occasions.

**SAVANERO (NZ)** (A. Doyle) – in the vicinity of eh 1200 metres shifted in to take up a forward position while checking the speed of his horse and crossed the running of MAZUREK when insufficiently clear and as a consequence MAZUREK, which had improved its position slightly, clipped the heels of SAVANERO (NZ) and stumbled. Rider pleaded guilty to a charge under AR137(d) for excessively checking the speed of his horse while shifting ground and was suspended from riding in races for a period to commence at midnight on Sunday, 15 October and to conclude at midnight on Saturday, 21 October 2017; a period of three meetings.

**MAZUREK** (J. Kah) – brushed with WASABI BOB on a number of occasions in the early stages of the event. In the vicinity of the 1200 metres clipped the heels of SAVANERO (NZ) and stumbled.

**WANTED BY ALL** (S. Fawke) shifted out inside the 100 metres and inconvenienced SAVANERO (NZ). Rider severely reprimanded and advised to take greater care when his mounts commence to shift ground in future.

## RACE 8: THE JUNCTION HANDICAP - 1400 metres (cont'd)

**AVOID THE MISSUS** (R. Clark) – unable to obtain clear running in the vicinity of the 150 metres for a short distance.
