# Report on Race Meeting held at Bordertown Racecourse by the Bordertown Racing Club on Sunday, 22 October 2017

#### RACE 1: RAY WHITE REAL ESTATE / SABOIS MAIDEN PLATE - 1100 metres

**ARTISTIC ESCAPE** (T. Pannell) – as the start was effected was restrained by a barrier attendant and failed to leave the starting barrier stall.

MISS MOSH (J. Potter) - shortly after the start was eased out of the event.

Correct weight was delayed to allow Stewards to interview the official starter, all the jockeys in this event and to view the vision in relation to the start. It was ascertained that shortly after the last horse was loaded into its barrier stall, the red warning light mechanism was activated which prematurely released the gates causing a false start. Stewards were advised that the starter made an attempt to verbally notify the jockeys of a false start but was unable to activate the false start siren and light as the system had not been set up. Acting under AR139 the race was declared (void) a non-race.

#### RACE 2: WISE FARM EQUIPMENT / SABOIS MAIDEN PLATE - 1300 metres

The start of this event was delayed approximately three minutes.

**ONEWOOD** (J. Maund) - slow to begin. In the vicinity of the 300 metres had to momentarily steady when PINT'S PUNCH shifted in under pressure.

**PINT'S PUNCH** (D. Tourneur) – bumped on jumping away when IT'S OUR LIFE jumped away awkwardly and shifted out. In the vicinity of the 300 metres shifted in under pressure.

**BOOMER BEACH** (J. Kah) - slow to begin. Shortly after entering the straight, shifted wider on the track inconveniencing WHEN IN VEGAS, which was taken wider.

IT'S OUR LIFE (V. Wong) - jumped away awkwardly and shifted out bumping PINT'S PUNCH.

**WHEN IN VEGAS** (A. Jordsjo) - shortly after entering the home straight was inconvenienced when taken wider by BOOMER BEACH, which shifted wider on the track.

### RACE 3: WILLOW GROVE STUD / SABOIS MAIDEN PLATE - 1550 metres

The start of this event was delayed approximately four minutes.

**NIGHT OF DREAMS** (C. Puls) – Trainer Mr K. Knowles advised Stewards of a tactics change in that he would instruct his rider to attempt to ride the gelding in a more forward position in today's event due to its barrier draw.

#### RACE 3: WILLOW GROVE STUD / SABOIS MAIDEN PLATE - 1550 metres (Cont'd)

**STORMY SKYE** (T. Pannell) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**TRAMPS LIKE US** (J. Maund) – dislodged its rider on arrival at the barriers and galloped for a short distance before been recaptured. Underwent a pre-race veterinary examination and passed fit to race. Rider was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements.

ASHADY HUSSY (V. Wong) – raced greenly in the home straight.

#### RACE 4: BORDERTOWN STONE SUPPLIES BENCHMARK 56 HANDICAP - 1550 metres

**WATCH THE WOLF** (P. Gatt) - slow to begin. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**SAGANO** (S. Fawke) – laid out under pressure in the home straight.

**CENTENARY SHOT** (E. Finnegan) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**UNDOUBTABLE** (R. Clark) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

Following the running of this event R. Clark was examined by the First Care Medical Personnel and ruled unfit to fulfil her remaining engagements.

#### RACE 5: WILLALOOKA TAVERN BENCHMARK 60 HANDICAP - 2000 metres

**SANZIO** (K. Bishop) – after passing the winning post ZANZIO appeared to break down and was quickly pulled up. A post-race veterinary examination revealed a fracture to the near fore fetlock and as a result SANZIO was humanely euthanased.

CHENERS (J. Kah) – reared as the start was effected and was very slow into stride.

Correct weight was delayed to allow Stewards to view the official vision of the start. After doing so, it was established that CHENERS reared and was slow into stride and was deemed to be a runner.

#### RACE 6: DOAN PHARMACIES BENCHMARK 60 HANDICAP - 1100 metres

**SUPER RULES** (V. Wong) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

WRITTEN ABOVE ALL (A. Doyle) - performed below expectations.

FIRST REWARDS (K. Crowther) - slow to begin.

**DULCIE JANE** – a late scratching at 3.14 pm as there were no apprentice rider available.

#### RACE 7: STIRLING VINEYARDS BENCHMARK 64 HANDICAP - 1300 metres

CELESTIAL STORY (V. Wong) - slow to begin.

**JUST WALLY** (A. Doyle) – from the vicinity of the 1100 metres was placed at a disadvantage for the remainder of the event when the saddle slipped forward on the gelding.

**IAMTHEKEY** (J. Kah) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.
