#### RACE 1: GIPSIE JACK / SABOIS DISTANCE MAIDEN PLATE - 2050 metres

**HAND TO HAND (NZ)** (B. Paterson) – began awkwardly and was slow to begin. In the vicinity of the 1600 metres had to be restrained after improving onto heels. Approaching the 1400 metres had to be restrained after the pace of the race had slackened and became extremely awkward in its stride.

**MIDRADA** (K. Bishop) – in the vicinity of the 400 metres had to be restrained to avoid the heels of DR DEPENDABLE, which improved to its outside.

**ONEMORE ELMO** (A Doyle) – approaching the 800 metres had to be restrained after improving onto heels.

**PURADEANIE** (S. Price) – approaching the 1600 metres had to be restrained to avoid the heels of DR DEPENDABLE, which was over-racing.

**DR DEPENDABLE** (C. Lindop) – over-raced in the early and middle stages of the event. In the vicinity of the 1600 metres had to be restrained after improving onto heels. A post-race veterinary examination revealed small laceration to off hind pastern.

## RACE 2: HOWLIN GALE WINES / SABOIS MAIDEN PLATE - 1200 metres

**DAKTARI** (J. Kah) - underwent a pre-race veterinary examination after not racing for the past 12 months and passed fit to race. A post-race veterinary examination revealed an elevated heart rate.

**LE DEZALEY** (S. Fawke) – over-raced in the early and middle stages of the event. Momentarily inconvenienced after entering the straight as GO STRAIGHTANDHARD rolled in momentarily.

**FABULOUS FLIPPER** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

**GO STRAIGHTANDHARD** (K. Crowther) – on entering the straight rolled in momentarily tightening LE DEZALEY.

#### RACE 3: VINEYARD ROAD / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres

**ARTISTIC ESCAPE** (J. Kah) – laid in under pressure over the concluding stages. Trainer was advised a warning had been placed on the mare regarding its pre-race manners.

#### RACE 3: VINEYARD ROAD / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres (Cont'd)

**LAST SOCIAL** (K. Stra) – took hold of its rider en route to the barriers. Underwent a pre-race veterinary examination and passed fit to race.

**ANNIFRID** (J. Holder) – laid out on entering the straight.

**OLIVIA JADE** (A. Doyle) - underwent a pre-race veterinary examination after being fractious in the barriers and passed fit to race. Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

## RACE 4: LAKE BREEZE WINES MAIDEN PLATE - 1600 metres

**ALLAYEZ** (J. Kah) – began awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**BOOMER BEACH** (S. Cahill) – began awkwardly.

**ANGEL'S WISH** (P. Gatt) – bumped on jumping away.

#### RACE 5: BREMERTON WINES BENCHMARK 56 HANDICAP - 1350 metres

PICTURE ME ROLLING (A. Jordsjo) – raced wide without cover throughout the event.

**HUSSARAMA** (T. Pannell) – bumped on jumping away.

**ASPALIS** (J. Kah) – laid out under pressure in the straight. Rider reported that in her opinion the mare raced flat throughout the event. A post-race veterinary examination revealed no visible abnormalities.

FREE THE WIND (J. Holder) – laid in when placed under pressure in the straight.

NIGHT BREEZE (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

SPIRITED MATCH (C. Lindop) – began awkwardly and shifted in making contact with HUSSARAMA.

**RORY'S UNION** (D. McQuinney) – in the vicinity of the 150 metres became momentarily inconvenienced when racing tight between FREE THE WIND, which shifted in and ASPALIS, which shifted out. Lost its near fore plate during the event.

## RACE 6: BLEASDALE VINEYARDS CLASS ONE HANDICAP - 1200 metres

**TRAFFIC MAESTRO** (J. Kah) – rider reported her mount felt awkward in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

**SPARKLING CURRENCY** (E. Boyd) - rider reported her mount felt awkward in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

**OAMARU LAD** (J. Holder) – over-raced in the early and middle stages of the event.

**ARCHWAY TO HEAVEN** (P. Gatt) – fractious en route to the track. Underwent a pre-race veterinary examination and passed fit to race. Over-raced in the early and middle stages of the event.

Following Race 6, A. Jordsjo was examined by the First Care Medical Personnel after being dislodged on pulling up following the race and was passed fit to fulfil her remaining engagements.

#### RACE 7: 2017 LANGHORNE CREEK CUP - 1350 metres

**CYCLONE THOMAS** (K. Crowther) – rider reported her mount felt flat throughout the event. A post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

## RACE 8: STRATHALBYN CUP FEBRUARY 4TH CLASS TWO HANDICAP - 1600 metres

**IMPULSE DIAVOLO** (S. Cahill) - underwent a pre-race veterinary examination behind the barriers after being re-plated and passed fit to race.

**NULLARBOR PETE** (A Doyle) – rider reported his mount became awkward in its stride after he felt his mount dipped in the straight. A post-race veterinary examination revealed a small laceration to the off hind fetlock.

**VONRASANA** (J. Bowditch) – rider reported his mount did not stride out at any point in the event. A post-race veterinary examination revealed no visible abnormalities.

**ZERO PATIENCE** (S. Fawke) – stood flat-footed as the start was effected and was slow to begin.
