## RACE 1: SCHWEPPES / SABOIS THREE-YEAR-OLD FILLIES MAIDEN PLATE - 1050 metres

**BOOM TUNE** (S. Fawke) – contacted on jumping away. Raced greenly in the straight.

**BURST OF FAITH** (B. Paterson) – Stewards acceded to a request from trainer, Mr J. Hickmott, to have the filly load with a barrier blanket, which had not been added to BURST OF FAITH's advertised gear due to a stable oversight. Mr Hickmott was fined \$200 under AR140B(2) for failing to lodged the gear request by the required time. Jumped away awkwardly and shifted out contacting BOOM TUNE.

# RACE 2: ADELAIDE GALVANISING BOXING DAY FAMILY RACES / SABOIS MAIDEN PLATE - 1050 metres

**CLASSY JOE** (B. Paterson) – hampered on jumping away when contacted by TOORAK ROAD. Held up from approaching the 400 metres until approaching the 200 metres. Lost its off hind plate during the event.

**EXTREME THRILL** (K. Bishop) – hung out rounding the home turn and then laid in under pressure in the straight.

**JOHN THE RODENT** (R. Hurdle) – jumped away awkwardly and shifted in making heavy contact with MAAZLE. Raced greenly throughout the event.

**MAAZLE** (D. Tourneur) – severely hampered on jumping away when contacted by JOHN THE RODENT. Rider reported that the gelding dipped for no apparent reason in the vicinity of the 75 metres.

**MODULATE** (P. Gatt) – inconvenienced in the vicinity of the 800 metres when it shifted in and away from WEDGEBROOK.

**THOMPSON'S REWARD** (J. Kah) – had to be steadied momentarily in the vicinity of the 800 metres when it improved onto the heels of MODULATE, which had been taken in. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**TOORAK ROAD** (S. Fawke) – jumped away awkwardly and shifted in abruptly making heaving contact with CLASSY JOE.

**WEDGEBROOK** (T. Pannell) – hung in severely throughout the event and in the vicinity of the 800 metres shifted in onto MODULATE. A post-race veterinary examination revealed no visible abnormalities.

# RACE 2: ADELAIDE GALVANISING BOXING DAY FAMILY RACES / SABOIS MAIDEN PLATE - 1050 metres (cont'd)

**YOELQUI** (J. Bowditch) – held up from the vicinity of the 400 metres until near the 200 metres. Shifted out abruptly over the concluding stages.

### RACE 3: HOLDFAST INSURANCE / SABOIS MAIDEN PLATE – 1200 metres

**LAST ONE NAMED** (J. Toeroek) – laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

**SANDISON** (K. Bishop) – jumped away awkwardly and was slow into stride. A post-race veterinary examination revealed no visible abnormalities.

**BAJAN** (P. Gatt) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**TRIPLE DEEZ** (S. Fawke) – laid out under pressure over the concluding 300 metres and inside the 200 metres shifted out inconveniencing THAT'S TWO SLABS, which was taken wider on the track.

Correct weight for this event was delayed to allow J. Holder (THAT'S TWO SLABS), and trainer, Mr D. Shepherd, to view the Official Vision in the straight.

## RACE 4: HUGHES LIMOUSINES MAIDEN PLATE - 1600 metres

**EXALTED KANGA** (C. Lindop) – jumped away awkwardly. Raced keenly in the early and middle stages of the event.

**ELECTRUM** (T. Pannell) – jumped away awkwardly and shifted out contacting SIXTEEN AGAIN. A post-race veterinary examination revealed no visible abnormalities.

**SIXTEEN AGAIN** (J. Maund) – contacted on jumping away.

# RACE 5: MEDALLION HOMES BENCHMARK 60 HANDICAP - 1050 metres

**SWISS DESIGN** (J. Huxtable) – held up from the entrance to the straight until the vicinity of the 200 metres.

**WICKED AFFAIR** (V. Wong) – had difficulty obtaining clear ground in the straight. A post-race veterinary examination revealed no visible abnormalities.

**YURILLA** (J. Kah) – rider reported the rig was inclined to lay in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**FLIP DE GLOIRE** (J. Toeroek) – held up from approaching the 500 metres until near the 200 metres.

**BRIMARVI GOLD** (P. Gatt) – rider reported that the mare felt short in its action. A post-race veterinary examination revealed no visible abnormalities.

**STAR PLAYER** (J. Holder) – a post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

# RACE 6: UBET CLASS TWO HANDICAP - 1200 metres

**ART MUSIC** (S. Fawke) – laid out throughout the event.

**DAKTARI** (J. Toeroek) – jumped away awkwardly. Laid in under pressure in the straight.

**SILENT ICE** (C. Lindop) – reared on jumping away.

## RACE 6: UBET CLASS TWO HANDICAP - 1200 metres (cont'd)

**EWAN MINE** (S. Cahill) – jumped away awkwardly. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**LUCKY WICK** (K. Bishop) – inconvenienced in the vicinity of the 800 metres when taken wider on the track by SHEANNA.

**TRAFFIC MAESTRO** (T. Pannell) – jumped away awkwardly.

**GET IN THE BOWL** (R. Hurdle) – stood flat-footed as the gates opened and was left at the post. Trainer, Mr S. Oxlade, was advised that the gelding would be required to jump away with the field in an Approval to Race Jump Out or a Barrier Trial prior to accepting for a future race.

**CAPABLE PRINCE** (D. Tourneur) – hung out rounding the home turn.

**SHEANNA** (A. Jordsjo) – raced keenly in the early and middle stages of the event and in the vicinity of 800 metres shifted out onto LUCKY WICK.

## RACE 7: GREG VENN'S SIGNIFICANT BIRTHDAY BENCHMARK 64 HANDICAP - 1600 metres

**ROWDY RICHARD** (T. Pannell) – lost its off fore plate during the event.

**YOU ES MARSHAL** (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

**UNDOUBTABLE** (S. Fawke) – stood flat-footed and was slow to begin. Trainer, Mr P. Moody, was advised that the gelding would be required to jump with the field in an Approval to Race Jump Out or a Barrier Trial prior to accepting for a future race.

### RACE 8: THE JUNCTION MARES BENCHMARK 64 HANDICAP - 1100 metres

**ARTISTIC ESCAPE** (J. Kah) – lost its off side winker approximately 100 metres after the start.

**STRYKE A RANSOM** (K. Stra) – a post-race veterinary examination revealed no visible abnormalities.

**SAINT STEF** (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

**LICORICE BULLET** (J. Toeroek) – laid in under pressure in the straight.
