RACE 1: BARRY MANEY FORD / SABOIS MAIDEN PLATE - 1700 metres

MIEL DE LAGO (D. Bates) - jumped away awkwardly.

RACE 2: UBET / SABOIS MAIDEN PLATE - 1100 metres

EQUILITE (L. Doodt) – racing to the 100 metres bumped MENTAL AS ANTHING on a number of occasions. Racing inside the 100 metres had to be steadied and lose its position when WONGA MISS shifted out when insufficiently clear.

MENTAL AS ANYTHING (E. Finnegan) – racing to the 100 metres bumped with EQUILITE on a number of occasions.

ANGELICUS (J. Potter) – slow to begin.

WONGA MISS (D. Tourneur) – from the vicinity of the 200 metre to the vicinity of the 100 metres was held up for clear running. Racing inside the 100 metres shifted out when insufficiently clear. Rider pleaded guilty to a charge under AR137(a) for careless riding and was suspended from riding in races for a period to commence midnight Wednesday, 28 February 2018 to midnight Wednesday, 7 March 2018, a period of four race meetings.

RACE 3: KATNOOK ESTATE WINERY / SABOIS MAIDEN PLATE - 1300 metres

DENOMINATOR (NZ) (C. Puls) – jumped away awkwardly and shifted out bumping DYADAMO. A post-race veterinary examination revealed no visible abnormalities.

DYADAMO (S. Fawke) – bumped on jumping away when DENOMINATOR (NZ) jumped away awkwardly and shifted out.

PRESS ON (D. Tourneur) – raced ungenerously in the early and middle stages of the event. Hung in under pressure in the straight. Performed below expectations. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Co-trainers, Messrs B & K Post, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

RACE 4: COOPERS BEWERY BENCHMARK 60 HANDICAP - 1100 metres

BONNE SENSATION (D. Bates) – Stewards acceded to a request from Trainer, Mr P. Preusker, that the mare race without a tongue as declared. Mr Preusker was fined \$200 under AR140B(3). Raced keenly in the early and middle stages of the event.

RACE 4: COOPERS BEWERY BENCHMARK 60 HANDICAP - 1100 metres (cont'd)

VISUAL IMAGE (E. Finnegan) – jumped away awkwardly. Raced keenly in the early and middle stages of the event.

RACE 5: PINKERTON, PALM, HAMLYN & STEEN BENCHMARK 72 HANDICAP - 1300 metres

RHYTHMATIC (D. Tourneur) – raced keenly in the early and middle stages of the event.

KNIGHTOFTHEREALM (J. Huxtable) – slow to begin.

PEPPER THE PIN (S. Fawke) – rider explained the gelding felt awkward in its action over the concluding stages of the event and for this reason he elected not to ride his mount out. A post-race veterinary examination revealed no visible abnormalities.

SOJU WARRIOR (D. Bates) – in the vicinity of the 600 metres was taken wider on the track when ELZETTE shifted out.

YET ANOTHER TIME (K. Bishop) – in the vicinity of the 1200 metres had to be momentarily steadied when RHYTHMATIC shifted in and away from SOJU WARRIOR.

RACE 6: LAWRENCE IRRIGATION BENCHMARK 56 HANDICAP - 1400 metres

The start of this event was delayed approximately four minutes.

LADY DEE DEE (J. Huxtable) – slow to begin.

OUR WANDO (C. Puls) – bumped on jumping away when HUSTLER LA LOPE jumped away awkwardly and shifted in.

GOLDEN RULE (A. Chan) – at the entrance to the straight shifted out to improve bumping HUSTLER LA LOPE onto the heels of LEAD THE WITNESS. Rider reprimanded under AR137(a) for careless riding.

HUSTLER LA LOPE (V. Wong) – jumped away awkwardly and shifted in bumping OUR WANDO. At the entrance to the straight was taken wider and had to be steadied off of the heels of LEAD THE WITNESS when GOLDEN RULE shifted wider on the track.

RACE 7: CAMERON LOCK SURVEYING BENCHMARK 60 HANDICAP - 1700 metres

The start of this race was delayed approximately three minutes.

QUEEN'S PALACE (K. Bishop) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

STRATEGIC SPICE (D. Tourneur) - raced keenly in the early and middle stages of the event.

GRECIAN SPY (E. Finnegan) - raced keenly in the early and middle stages of the event.

SUPER DELUXE (C. Collins) – apprentice C. Collins was granted permission to ride SUPER DELUXE despite not being able to claim her full allowance. Rider fined \$200 under AR120(b).

GENERAL:

RACE 6: LAWRENCE IRRIGATION BENCHMARK 56 HANDICAP - 1400 metres

Stewards questioned Trainer, Ms S. Murphy, in relation to her presenting HASTA LA SPEC into the parade ring for this race when HASTA LA LOPE had accepted for the event. After considering her explanation she pleaded guilty to charge under AR175(k) in that her negligence may have led to a breach of the Rules and was fined \$500. At arriving at this penalty Stewards took into account that there was no intent on the part of S. Murphy and that she had been involved in the racing industry for approximately thirty-six years and had not committed an offence of this nature previously.
