Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 5 May 2018

RACE 1: 13CABS QUEEN ADELAIDE STAKES - 1050 metres

DANCER'S KIN (D. Tourneur) – held up from near the entrance to the straight until approaching the 200 metres and thereafter shifted out approaching the 100 metres taking SOLAR STAR wider on the track.

SANGLIER (D. Lane) – brushed at the start and held up from near the entrance to the straight until approaching the 300 metres. Thereafter, when improving to the inside of HEAVEN'S DEAL, raced very greenly for the remainder of the event and shifted ground outwards on several occasions and became awkward inside the heels of HEAVEN'S DEAL for a short distance. A post-race veterinary examination revealed no visible abnormalities.

SOLAR STAR (K. McEvoy) – taken wider on the track approaching the 100 metres by DANCER'S KIN, which shifted out.

GERMANOTTA (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

MISS FLATLEY (E. Finnegan) – awkward to begin, shifted out and brushed SANGLIER.

SHE WILL RISE (R. Bayliss) – unable to obtain clear running from near the entrance to the straight until approaching the 100 metres and was inclined to lay in, in the straight.

Correct weight was delayed to allow D. Lane (SANGLIER) to view the vision in the straight.

RACE 2: BERESFORD WINES HANDICAP - 2000 metres

OBSERVATIONAL (GB) (L. Currie) – inclined to lay in, in the straight.

WAGING WAR (E. Boyd) – raced keenly in the early and middle stages of the event. Rider reported the gelding laid out from near the 500 metres was disappointing and did not finish the event off as expected. A post-race veterinary examination revealed no visible abnormalities. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 2: BERESFORD WINES HANDICAP - 2000 metres (Cont'd)

VELOX (GB) (K. McEvoy) – rider explained when placed under pressure inside the 500 metres, the gelding became one-paced and did not finish the event off. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: CARBINE CLUB HANDICAP - 1600 metres

BALF'S CHOICE (J. Bowditch) – slow to begin. Trainer Mr R. Balfour reported it was their intention to settle more forward in today's event but having regard for the manner in which the gelding began; J. Bowditch was unable to take up a more forward position. A post-race veterinary examination revealed no visible abnormalities.

FOUNDATION (IRE) (S. Cahill) - a post-race veterinary examination revealed no visible abnormalities.

RAW IMPULSE (GB) (D. Lane) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: UBET EUCLASE STAKES - 1200 metres

VIRIDINE (K. McEvoy) – Trainer Mr J. Cummings advised Stewards prior to the event that he would instruct his rider to attempt to settle more forward in today's event.

NATURE STRIP (C. Williams) - rider explained he had no specific instructions, however was happy to settle where he did in running and added the gelding did not finish the race off as he expected. A post-race veterinary examination revealed a poor post-race recovery associated with an elevated heart rate.

DESPATCH (J. Kah) – lost its near fore plate in running.

HOLY BLADE (D. Lane) – inclined to lay in under pressure in the straight.

FANCY RUMBLE (K. Crowther) - a post-race veterinary examination revealed the filly was treated post-race for thumps.

MINTHA (L. Currie) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: AAMI D C MCKAY STAKES - 1100 metres

SANTA ANA LANE (M. Zahra) – held up for clear running from near the entrance to the straight until approaching the 100 metres.

KEEN ARRAY (R. Bayliss) - a post-race veterinary examination revealed no visible abnormalities.

CASINO WIZARD (J. Holder) contacted gate at the start. A post-race veterinary examination revealed a broken middle incisor.

FIRST AMONG EQUALS (D. Lane) – shifted out over the concluding stages inconveniencing LOPE DE CAPIO.

I'M WESLEY (R. Clark) – inconvenienced over the concluding stages by SPRIGHTLY LASS as that horse shifted in. A post-race veterinary examination revealed the gelding was exhibiting signs of post-race stress and colic.

SPRIGHTLY LASS (D. Dunn) – over-raced in the early and middle stages of the event. Shifted in over the concluding stages and inconvenienced I'M WESLEY. Rider reprimanded for shifting ground when insufficiently clear.

LOPE DE CAPIO (E. Finnegan) – inconvenienced over the concluding stages.

DESERT LASHES (J. Kah) – slipped on jumping away. Rider explained as a consequence of the mare slipping on jumping away, she was obliged to settle further back than anticipated. She added that the mare travelled well during the event, however when placed under pressure failed to respond to her riding and was disappointing in its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: SCHWEPPES OAKS - 2000 metres

BRING ME ROSES (L. Currie) – weakened from in the vicinity of the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

MISS ADMIRATION (B. Melham) – which was loaded in the stall adjacent to JUNGLE FISH, which proved very fractious after being loaded into its gate, underwent a pre-race veterinary examination and was passed fit to race. Shifted out at the start when taken out by VELOCITA. A post-race veterinary examination revealed no visible abnormalities.

PLEASURING (D. Lane) – had difficulty obtaining clear ground for a short distance rounding the home turn.

SAVACOOL (NZ) (D. Oliver) – over-raced in the early and middle stages of the event. As a result raced wide without cover from inside the 1400 metres.

TEMPLE OF BEL (C. Williams) – slow into stride.

VELOCITA (S. Baster) – shifted out at the start taking MISS ADMIRATION out. Laid out near the 600 metres for a short distance. Had difficulty obtaining clear running from near the entrance to the straight until approaching the 100 metres.

SEMARI (NZ) (D. Dunn) – raced in restricted room between the 300 metres and the 200 metres and was unable to be fully tested when racing to the inside of PLEASURING.

EARTH ANGEL (J. Bowditch) – was buffeted shortly after the start between MISS ADMIRATION, which was taken out and SHEEZDASHING. Raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

JUNGLE FISH (K. McEvoy) – proved very fractious after being loaded into its barrier stall and reared over falling through the back of the stall gate. Underwent a pre-race veterinary examination and declared unfit to start. JUNGLE FISH was declared a late scratching at 3.28 pm by order of Stewards acting on veterinary advice. Trainer Mr M. Kent was advised that in view of the filly's behaviour it would now be required to prove tractable at an Official Trail prior to a future race.

RACE 7: UBET CLASSIC - 1200 metres

SUPER CASH (C. Williams) – contacted at the start by CATCHY. Had no clear running from near the entrance to the straight until inside the 100 metres and thereafter, over the concluding stages was again inconvenienced and unable to be fully tested as WHISPERING BROOK shifted in.

MISSROCK (B. Melham) – shifted out near the 100 metres after being corrected and encroached into the running line of IT'S BEEN A BATTLE, which was inconvenienced.

DAINTY TESS (J. Kah) – lost an off side plate during the event. Rider reported the mare travelled well during the event but when asked for an effort failed to respond to her riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

QUILISTA (D. Lane) – held up for clear running from near the entrance to the straight until inside the 200 metres.

WHISPERING BROOK (D. Yendall) – shifted in over the concluding stages.

MISS GUNPOWDER (J. Holder) – unable to obtain clear running from near the entrance to the straight until approaching the 50 metres.

LEGLESS VEUVE (NZ) (C. Parnham) – got its head up and raced ungenerously in the early stages of the event.

IT'S BEEN A BATTLE (J. Potter) – approaching the 100 metres became awkwardly placed on the heels of MISSROCK, which shifted out after being corrected.

RACE 7: UBET CLASSIC - 1200 metres (Cont'd)

MICA LIL (S. Cahill) – near the 500 metres became awkward for several strides inside the heels of SUPER CASH as that horse rolled out and MICA LIL improved into the inside of that horse of its own accord.

CATCHY (D. Dunn) - contacted SUPER CASH at the start.

FORMALITY (K. McEvoy) - underwent a pre-race veterinary examination and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: HUGHES LIMOUSINES QUEEN OF THE SOUTH STAKES - 1600 metres

SAVAPINSKI (NZ) (T. Clark) - underwent a pre-race veterinary examination and was passed fit to race. Bumped at the start as SHENANDOAH (NZ) jumped away awkwardly and shifted out.

SWORD OF LIGHT (D. Lane) - a post-race veterinary examination revealed no visible abnormalities.

TAHANEE (ARG) (D. Yendall) – raced keenly near the 1400 metres and rolled out inconveniencing LADY SILHOUETTE and thereafter laid in, in the straight.

JESTER HALO (C. Williams) – rider explained he was obliged to race three wide without cover and in his opinion, the mare did not finish the race off as expected. Trainer Mr D. Kolpin advised Stewards the mare would now be spelled. A post-race veterinary examination revealed no visible abnormalities.

HUSSTERICAL (S. Baster) rider reported the mare did not handle the track conditions. A post-race veterinary examination revealed no visible abnormalities.

LADY SILHOUETTE (D. Caboche) – inside the 1400 metres was inconvenienced when awkwardly placed on the heels of TAHANEE (ARG), which rolled out.

HAVE ANOTHER GLASS (E. Finnegan) – held up from near the entrance to the straight until near the 300 metres.

SHENANDOAH (NZ) (R. Bayliss) - jumped away awkwardly, shifted out and bumped SAVAPINSKI (NZ).
