THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 15 September 2018

RACE 1: UBET HANDICAP - 1950 metres

CRAFTY DEVIL (H. Coffey) – raced wide without cover in the middle stages of the event. Near the 700 metres was taken a little wider by NANGAWOOKA, which shifted out to improve. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr D. Weir, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

NANGAWOOKA (J. Holder) – shifted out near the 700 metres to improve taking CRAFTY DEVIL a little wider on the track.

QUEDOUTES (K. Crowther) – rider reported that the gelding felt sore on pulling up. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. First aid administered. Trainer, Mr B. Holtham, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

RACE 2: HOLDFAST INSURANCE HANDICAP - 1300 metres

FIGHTING HARADA (D. Tourneur) – fractious in the barriers after being loaded. Underwent a pre-race veterinary examination which revealed an abrasion to the nearside hock and was ruled unfit to start. Acting on this advice Stewards withdrew FIGHTING HARADA at 1.22 pm. Trainer, Mr M. Price, was advised that a warning had been placed on the horse in relation to its barrier manners.

BRONSKI BEAT (C. Symons) – got its head up and raced ungenerously for some distance in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

DIVER (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

STRATEGIC AGENDA (J. Potter) – trainer, Mr C. Bieg, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle back with cover to allow the filly to finish the race off. Raced fiercely in the early and middle stages of the event when being restrained.

RACE 3: TERRY HOWE PRINTING HANDICAP - 2400 metres

AL HARAM (FR) (J. Kah) – held up for clear running from inside the 500 metres until approaching the 200 metres.

RACE 3: TERRY HOWE PRINTING HANDICAP - 2400 metres (cont'd)

HARIPOUR (IRE) (C. Symons) – held up for clear running from inside the 500 metres until approaching the 200 metres.

EXALTED CRAFTSMAN (T. Pannell) – a post-race veterinary examination revealed no visible abnormalities.

SUPER SWOOP (R. Clark) – laid out in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: HAPPY 60TH BIRTHDAY CATHY HANDICAP - 1400 metres

ARTIE DEE TWO (H. Coffey) – shifted an off fore plate and required farrier attention on arrival on course. Examined by the Club's Veterinary Surgeon who declared ARTIE DEE TWO to be lame in the off foreleg. Acting on this advice Stewards withdrew ARTIE DEE TWO at 1.12 pm. Trainer, Mr D. Weir, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

SETINUM (L. Riordan) – laid both ways in the straight. A post-race veterinary examination revealed no visible abnormalities.

ZALMONA (T. Pannell) – over-raced in the early and middle stages of the event.

HOLY COMMAND (D. Tourneur) – saddle slipped backwards in running.

RACE 5: ADELAIDE GALVANISING HANDICAP - 1250 metres

STAR FORTUNE (D. Tourneur) – slow to begin. A post-race veterinary examination revealed no visible abnormalities

VIEIRA (G. Cartwright) – contacted at the start.

TAMASA (H. Coffey) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

TREMBLING (J. Holder) – awkward to begin, shifted out and contacted VIEIRA. Laid in, in the straight.

ZAMPERINI (L. Riordan) – began very awkwardly, shifted in abruptly shortly after the start. Thereafter in laid throughout the event. Raced wide without cover throughout the event. Weakened from shortly after the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities

RACE 6: DARLEY HANDICAP - 1400 metres

OPTIMIZE (J. Huxtable) – laid in throughout the event. Inconvenienced inside the 100 metres by FLOP, which shifted in. A post-race veterinary examination revealed no visible abnormalities.

SENSATION ALLY (C. Douglas) – a post-race veterinary examination revealed no visible abnormalities.

ASTROLOGICAL (C. Symons) – a post-race veterinary examination revealed no visible abnormalities.

FLEETING FEELING (J. Kah) – raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

WITH A BIT OF DASH (D. Tourneur) – inconvenienced inside the 100 metres by OPTIMIZE, which was taken in by FLOP.

GALCRUM (J. Maund) – became fractious in its barrier stall just prior to the gates being released. Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: DARLEY HANDICAP - 1400 metres (cont'd)

FLOP (J. Holder) – shifted in inside the 100 metres inconveniencing OPTIMIZE, which was taken in onto WITH A BIT OF DASH.

RACE 7: AAMI HANDICAP - 1400 metres

ACE ATTACK (E. Boyd) – a post-race veterinary examination revealed no visible abnormalities.

GALAXY GAZER (R. Clark) – approaching the finish shifted out and away from ADATTO (NZ), which laid out and shifted out, and as a consequence contacted the hindquarters of BOOMER BEACH.

TAN TAT TRUSTING (NZ) (J. Holder) – had difficulty obtaining clear running from the near the entrance to the straight until approaching the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

LAST WITNESS (D. Caboche) – buffeted at the start between BOOMER BEACH and THE CARD PLAYERS, which both shifted ground slightly. Laid out over the concluding stages.

THE CARD PLAYERS (L. Riordan) – rider reported that his saddle slipped sideways in running.

ADATTO (NZ) (J. Kah) – laid out in the straight. Shifted out over the concluding stages taking GALAXY GAZER wider.

BOOMER BEACH (A. Jordsjo) – approaching the finish was contacted by GALAXY GAZER.

RACE 8: TEYS AUSTRALIA HANDICAP - 1000 metres

LOCKDOWN JACK (K. Crowther) – inside the 100 metres shifted out abruptly away from IRISH MINT onto MOON SPINNER making contact with that horse and resulting in MOON SPINNER being taken out onto the heels of ARROW LANE, which shifted in.

ARROW LANE (R. Clark) – underwent a pre-race veterinary examination as it had not raced since December 2017 and was passed fit to start. Held up for clear running from near the 400 metres until inside the 100 metres.

MOON SPINNER (J. Kah) – contacted inside the 100 metres by LOCKDOWN JACK and taken out onto the heels of ARROW LANE, which shifted in. Weakened over the concluding stages. A post-race veterinary examination revealed the gelding to be lame in both hind legs. Trainer, Mr T. McEvoy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

ICELANDIC STAR (A. Jordsjo) – near the 300 metres was disappointed for clear running when attempting a run between GOLDEN MINESHAFT, to its outside, and FLAMING ACES, and was obliged to alter course to the outside of GOLDEN MINESHAFT to obtain clear running.

WE HAVE LIFT OFF (H. Coffey) – a post-race veterinary examination revealed no visible abnormalities.

GENERAL:

G. Cartwright pleaded guilty to a charge under AR160B(3) for having in her possession in the jockeys' room her mobile phone without the permission of the Stewards and was fined \$300. In determining penalty Stewards took into account that G. Cartwright had not used her phone from the time she had presented for racing duties and until it was found in her possession.

R. Clark pleaded guilty to a charge under AR160B(2) for using a mobile phone (to communicate with Mr Corstens) of a party connected to the stable of Trainer, Mr K. Corstens, the trainer of LADY CROMAC, the horse she rode in Race 6, in the mounting yard following the running of the race, and was fined \$300. In determining penalty Stewards had regard for R. Clark's guilty plea, her clean record and the fact there was no impropriety involved in the matter. Stewards confirmed the discussion that R. Clark had with Mr K. Corstens.
