

# THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

### Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 26 January 2019

#### RACE 1: FLEURIEU MILK COMPANY HANDICAP - 2250 metres

SCHERZOSO (D. Tourneur) - near the 1900 metres became awkward inside LADY BARRON and was hampered as that horse shifted in.

**LITTLE WHITE CLOUD (IRE)** (J. Holder) - rider reported that the gelding may have jarred up in running. A post-race veterinary examination revealed no visible abnormalities.

**MARMAN** (D. Caboche) – rider explained that his instructions were not to get too far back, but added when improving in the early stages he was caught wide without cover and was obliged to further improve his position to take up a more forward position near the lead in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**LADY BARRON** (C. Caserta) - near the 1900 metres shifted in and hampered SCHERZOSO. Rider was reminded of his obligations when shifting ground.

### RACE 2: HUGHES LIMOUSINES HANDICAP - 1250 metres

GO THE JOURNEY (K. Crowther) - laid out in the straight.

KARLOVASI (J. Toeroek) - near the 1000 metres was contacted by MAZUREK and hampered for several strides as that horse shifted in. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 2: HUGHES LIMOUSINES HANDICAP - 1250 metres (cont'd)

**MAZUREK** (A. Jordsjo) - had to be resaddled on arrival at the barriers. Near the 1000 metres shifted in and contacted KARLOVASI hampering that horse for several strides. Rider reprimanded under AR137(a) for shifting ground when not entitled to.

**ZALMONA** (J. Holder) - laid in, in the straight. Rider reported that the gelding may have been galloped on, on the off hind leg during the event. A post-race veterinary examination revealed a minor laceration to the hear hind leg. First aid applied.

### RACE 3: BAROSSA FINE FOODS HANDICAP - 1250 metres

STREET LIFE (T. Pannell) - laid out under pressure in the straight.

DANGER DEAL (R. Clark) - raced keenly in the early and middle stages of the event.

BALWARRA GOLD (E. Finnegan) - shifted out at the start and contacted TRIPLE DEEZ.

ILLUMICON (J. Holder) - laid out in the straight.

TRIPLE DEEZ (C. Parish) - contacted at the start.

#### RACE 4: TAB HANDICAP - 1400 metres

**SILENT WARRIOR** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

**DAKTARI** (R. Clark) - fractious in its barrier after being loaded. Mr S. Cahill, acting on behalf of trainer, Mr D. O'Leary, was advised that a warning had been placed on the gelding in relation to its barrier manners. A post-race veterinary examination revealed no visible abnormalities. Following this race R. Clark was examined by the First Care Medical personnel who passed her fit to fulfil her remaining engagements.

**OVER AND ABOVE** (C. Caserta) - inclined to lay in for a short distance near the entrance to the straight.

**STONE WARRIOR (NZ)** (D. Tourneur) - underwent a pre-race veterinary examination as it had not raced since October 2017 and was passed fit to start.

## RACE 5: KILLER QUEEN EXPERIENCE - FEB 9 AT MORPHETTVILLE MAIDEN PLATE - 1400 metres

**CHEEKYS BRO** (E. Boyd) - contacted shortly after the start. Over-raced in the early stages of the event.

**INDIAN MO** (K. Crowther) - awkward to begin, shifted out and contacted NOTARBARTOLO taking that horse wider.

MALOUFF (C. Caserta) - awkward to begin. Laid in, in the straight.

**NOTARBARTOLO** (E. Finnegan) – inconvenienced shortly after the start, shifted out and contacted CHEEKYS BRO. Near the 1300 metres raced in restricted room between CHEEKYS BRO and INDIAN MO, was obliged to be steadied and lost its position in running. Had difficulty obtaining clear running in the early part of the straight and was obliged to shift out to obtain clear running.

# RACE 5: KILLER QUEEN EXPERIENCE - FEB 9 AT MORPHETTVILLE MAIDEN PLATE - 1400 metres (cont'd)

**BAR GEM** (O. Ridge) - rider pleaded guilty to a charge under AR137A(5)(a) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for O. Ridge's clean record and the limited manner in which he used his whip over the final 100 metres of the event.

**VACANT BLOCK** (D. Tourneur) - near the entrance to the straight was contacted by GOOD NIC and had its hindquarters turned and was inconvenienced.

**GOOD NIC** (J. Toeroek) - awkward to begin. Near the entrance to the straight rolled out and contacted the hindquarters of VACANT BLOCK, which was inconvenienced.

### RACE 6: SCHWEPPES HANDICAP - 1250 metres

**POET'S LANDING (NZ)** (T. Pannell) – rider explained that the gelding travelled well in the early stages of the event, but failed to let down as expected in the straight and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

**STARVIRGO** (J. Holder) - awkward and slow to begin. Raced very keenly in the early stages of the event.

EXALTED TRAIL (R. Clark) - raced very keenly in the early stages of the event.

**STRYKE IN STYLE** (J. Toeroek) - very difficult to load. Trainer, Mr J. Macmillan, was advised that a warning had been placed on the gelding in relation to its loading manners; however, Mr Macmillan was also advised that if the horse behaved in a similar manner in future it would be sent back to a minimum of one trial, possibly two.

### RACE 7: TAB ADELAIDE CUP - MARCH 11 AT MORPHETTVILLE HANDICAP - 1400 metres

PRETIOSA (R. Clark) - eased out in the straight. A post-race veterinary examination revealed the gelding had bled from both nostrils. Trainer, Mr K. Sweeney, was advised that as this was the geldings first bi-lateral bleed PRETIOSA would now be suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

**VALLIANO** (C. Caserta) - held up for clear running from near the 500 metres to the entrance of the straight. A post-race veterinary examination revealed no visible abnormalities.

BIG CALL (J. Holder) - awkward and slow to begin.

GOUGERS (J. Toeroek) - over-raced in the early stages of the event. Laid out in the straight.

# RACE 8: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 1000 metres

**KILOWATT** (C. Caserta) - near the 600 metres raced in restricted room between EVERYDAY LADY, which rolled out, and SAVVY SHIELDS, which rolled in and had to be steadied.

MISS LABELLE (E. Finnegan) - rider reported that the mare felt sore in its near foreleg. A post-race veterinary examination revealed no visible abnormalities.

**SAVVY SHIELDS** (D. Tourneur) - near the 600 metres rolled in onto KILOWATT inconveniencing that horse.

# RACE 8: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 1000 metres (cont'd)

**NIGHT QUEEN** (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

**EVERYDAY LADY** (T. Pannell) – near the 600 metres rolled out onto KILOWATT inconveniencing that horse. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.
