Report on Race Meeting held at Naracoorte Racecourse by the Naracoorte Racing Club on Wednesday, 13 March 2019

RACE 1: HAPPY BIRTHDAY ANNE GAFFNEY BENCHMARK 60 HANDICAP - 1000 metres

BATTISTONI (c. Puls) – when questioned regarding the performance of the gelding rider stated that BATTISTONI pulled hard in the early stages and as a result failed to finish of today's event. A post-race veterinary examination revealed no visible abnormalities.

JIMASSI (K. Bishop) – knuckled on jumping away dislodging its rider and shifted out contacting PANAGIOTA. A post-race veterinary examination revealed no visible abnormalities.

PANAGIOTA (K. Lau) - had its hindquarters contacted on jumping away by JIMASSI, which shifted out abruptly after knuckling. Laid in under pressure in the straight.

PINK PIG (J. Holder) – Trainer, Mr D. Bowman, failed to produce the Thoroughbred Identification Card. The mare was permitted to start as it was able to be identified from records held by the Stewards. Trainer, Mr Bowman, was advised that the Thoroughbred Identification Card was required to be presented prior to a future race start. Dislodged its rider en route to the barriers. Underwent a pre-race veterinary examination and ruled unfit to start. Acting on this advice stewards withdrew PINK PIG at 12.55 pm. Trainer, Mr D. Bowman, was advised that a PINK PIG would be required to complete an Official Barrier Trial to the satisfaction of Stewards prior to a future race start. Mr Bowman was further advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

MOODY MISS (J. Potter) – in the vicinity of the 600 metres was obliged to be steadied and shift wider on the track to avoid the riderless horse, which shifted in.

RACE 2: ORMEROD PICS AND PIECES / SABOIS MAIDEN PLATE - 1000 metres

LADIES GLASS (J. Huxtable) – contacted on jumping away by LIVELY LASS, which shifted out abruptly. Laid in under pressure in the straight.

RACE 2: ORMEROD PICS AND PIECES / SABOIS MAIDEN PLATE - 1000 metres (Cont'd)

GOOD GIRL BELLA (E. Finnegan) - began awkwardly and as a result was slow into stride.

LEDAYL KISS (S. Fawke) - Trainer, Mr M. Hickmott, failed to produce the Thoroughbred Identification Card. The filly was permitted to start as it was able to be identified from records held by the Stewards. Mr Hickmott, was advised not to nominate LEDAYL KISS for a future race without being in possession of the Thoroughbred Identification Card which was required to be presented prior to a future race start. Momentarily inconvenienced on entering the straight.

LIVELY LASS (R. Clark) - began awkwardly shifting out and contacting LADIES GLASS.

RACE 3: HAPPY BIRTHDAY BINDI NEAL / SABOIS PLUS MAIDEN/CLASS 1 PLATE - 1800 metres

ARTISTIC DESIGN (K. Bishop) – in the vicinity of the 100 metres was contacted by ILLOWA, which shifted in despite the efforts of its rider, and was taken in onto SAN GREGORIO, which was taken in onto GO WALLY.

GO WALLY (W. Cave) – over-raced in the early and middle stages of the event. In the vicinity of the 1400 metres was obliged to shift wider on the track after improving onto the heels of ILLOWA and as a result raced wide without cover for the remainder of the event. In the vicinity of the 100 metres had to be checked to avoid the heels of SAN GREGORIO, which was taken in by ARTISTIC DESIGN, which was taken in by ILLOWA, which shifted in despite the efforts of its rider.

SAN GREGORIO (A. Lindsay) – in the vicinity of the 200 metres laid out becoming awkwardly placed to the inside of ARTISITC DESIGN. In the vicinity of the 100 metres was hampered and taken in onto GO WALLY by ARTISTIC DESIGN, which was taken in by ILLOWA, which shifted in despite the efforts of its rider.

ANOTHER KERRIE (P. Marks) - over-raced in the early and middle stages of the event.

ILLOWA (R. Clark) – laid in from the vicinity of the 600 metres. In the vicinity of the 100 metres laid in despite the efforts of its rider taking ARTISTIC DESIGN in onto SAN GREGORIO, which was taken in onto GO WALLY, which had to be checked. A post-race veterinary examination revealed no visible abnormalities. Trainer, Ms K. Edwards, was advised that a warning that a warning had been placed on the gelding in relation to hanging in.

RACE 4: ROBYN & PETER WALTERS / SABOIS MAIDEN PLATE - 1430 metres

FRITZ 'N' SAUCE (J. Potter) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MINNAMOSA (NZ) (C. Puls) – raced fiercely in the early and middle stages of the event. Rider reported that her mount slipped in the vicinity of the 400 metres.

AUSTRALIEN (K. Bishop) - slow to begin.

RACE 5: KALV & CO BENCHMARK 64 HANDICAP - 2000 metres

HASTA LA THOMAS (C. Jones) - over-raced in the early and middle stages.

CENTENARY SHOT (E. Finnegan) – a post-race veterinary examination revealed no visible abnormalities.

HAKERAK (J. Holder) – underwent a pre-race veterinary examination and passed fit to race. A post-race veterinary examination revealed the gelding to be lame in the near foreleg.



RACE 6: STORE 21 BENCHMARK 80 HANDICAP - 1430 metres

CRYSTAL GLASS (C. Puls) – slow to begin. In the vicinity of the 1200 metres had to be restrained when it improved onto the heels of IAMTHEKEY. Over-raced in the early and middle stages of the event.

RACE 7: HAGE TRACTORS AND IMPLEMENTS BENCHMARK 64 HANDICAP - 1200 metres

MISS MOSH (J. Potter) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

TEMEYEZ (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: HEARD'S MENSWEAR CLASS TWO HANDICAP - 1430 metres

TAN CHECK (NZ) (J. Huxtable) - laid out under pressure in the straight.

BRYBECK (R. Clark) - laid out throughout the event.

BOHEMIAN FOREST (J. Holder) - laid in when placed under pressure in the straight. In the vicinity of the 100 metres shifted in when insufficiently clear of COTILLION. Rider reprimanded under AR131(a) for careless riding.

COTILLION (S. Fawke) - in the vicinity of the 100 metres had to be restrained to avoid the heels of BOHEMIAN FOREST, which shifted in when insufficiently clear.
